NOTIFICATION REGARDING AN APPLICATION FOR A PROSPECTING RIGHT AND ENVIRONMENTAL AUTHORISATION ON VARIOUS FARMS WITHIN THE KROONSTAD, VENTERSBURG AND HENNINGMAN MAGISTERIAL DISTRICTS, IN THE FREE STATE PROVINCE (VENTERSBURG CONSOLIDATED PROSPECTING RIGHT).

On behalf of our client **Western Allen Ridge Gold Mines (Pty) Ltd**:

Shango Solutions has been appointed by Western Allen Ridge Gold Mines (Pty) Ltd (subsidiary of White Rivers Exploration) to assist in preparing and submitting a Basic Assessment Report (BAR) Environmental Management Programme (EMPR) and to undertake a Public Participation Process, in support of an application for a Prospecting Right and Environmental Authorisation. You have been identified as a potential Interested and Affected Party (I&AP). The Prospecting Right and Environmental Authorisation application will be undertaken in accordance with the requirements of the Minerals and Petroleum Resources Development Act, 2002 (Act 28 of 2002, as amended) (MPRDA) and the associated regulations and the National Environmental Management Act (Act 107 of 1998, as amended) (NEMA) and the associated regulations.

Western Allen Ridge Gold Mines (Pty) Ltd has submitted a Prospecting Right and Environmental Authorisation application to the Free State Department of Mineral Resources. The Department of Mineral Resources accepted the application on the 24th November 2017. If the application is granted, it will enable Western Allen Ridge Gold Mines (Pty) Ltd to ascertain if economically viable mineral deposits are present within the application area. The minerals of interest for prospecting include silver, gold, copper, iron, manganese, molybdenum, nickel, tungsten, zinc, diamond (alluvial), cobalt, coal, lead, platinum group metals, rare earths, sulphur and uranium. The proposed prospecting programme will be completed within five (5) years. It is anticipated that the following non-invasive and invasive techniques will be utilised during prospecting:

The application area is approximately 7 943.07 hectares in extent and is situated 14 kilometres north-northeast of Ventersburg in the Free State Province of South Africa. The prospecting area is located in the Kroonstad, Ventersburg and Henningman Magisterial Districts and fifty-three (53) farm portions extend over it.

The application for a Prospecting Right and Environmental Authorisation process will be carried out as stipulated in Section 16 of the MPRDA and Chapter 4 of the Environmental Impact Assessment Regulations, 2014 (GN R. 326 of 2017) promulgated under the NEMA. A public notification and involvement is being carried out as part of the Basic Assessment process.

This notice is in accordance with clause 16 of the MPRDA and Chapter 6 of GN R. 326 (of 2017), which requests that Western Allen Ridge Gold Mines (Pty) Ltd notify in writing and consult with the land owner or lawful occupier and any other affected party. The results of the consultation will be included in the BAR submission in order for the Department of Mineral Resources to adjudicate on the application.

1. INTRODUCTION

Western Allen Ridge Gold Mines (Pty) Ltd (Western Allen Ridge) submitted an application for a Prospecting Right and an Environmental Authorisation in order to prospect for the following commodities:

- Silver
- Gold
- Coal
- Cobalt
- Copper
- Diamond (Alluvial)
- Iron
- Manganese
- Molybdenum
- Nickel
- Lead
- Platinum Group Metals
- Rare Earths
- Sulphur
- Uranium
- Tungsten
- Zinc

The application for the Prospecting Right was accepted by the Department of Mineral Resources – Free State Province on the 24th November 2017. The proposed project will be known as Ventersburg Consolidated and it will aim to explore and quantify the potential mineral resources. In order to undertake prospecting activities, Western Allen Ridge requires a granted Prospecting Right (PR) in terms of the Mineral and Petroleum Resources Development Act (MPRDA, Act No.28 of 2002). Western Allen Ridge is also required to obtain an Environmental Authorisation (EA) in terms of the National Environmental Management Act (NEMA, Act No. 107 of 1998) which involves the submission of a Basic Assessment Report (BAR) and Environmental Management Programme (EMPR). Shango Solutions have been appointed by Western Allen Ridge as the Environmental Assessment Practitioner (EAP) to assist in complying with these requirements.

2. AIM OF THE BID

Public Participation forms an integral part of the Basic Assessment process. The BID offers the reader the opportunity to obtain information, comment, raise issues of concern and collaborate in the development of the process. The distribution of this document is a crucial step in advising the reader on how to become involved in the process.

This document aims to provide the reader with basic information regarding the proposed project which includes:

- An introduction of the project, including location details.
- An indication of the proposed activities and the legal framework in which the project is executed.
- An overview of the environmental baseline information and environmental impacts that may potentially occur.

3. LOCALITY

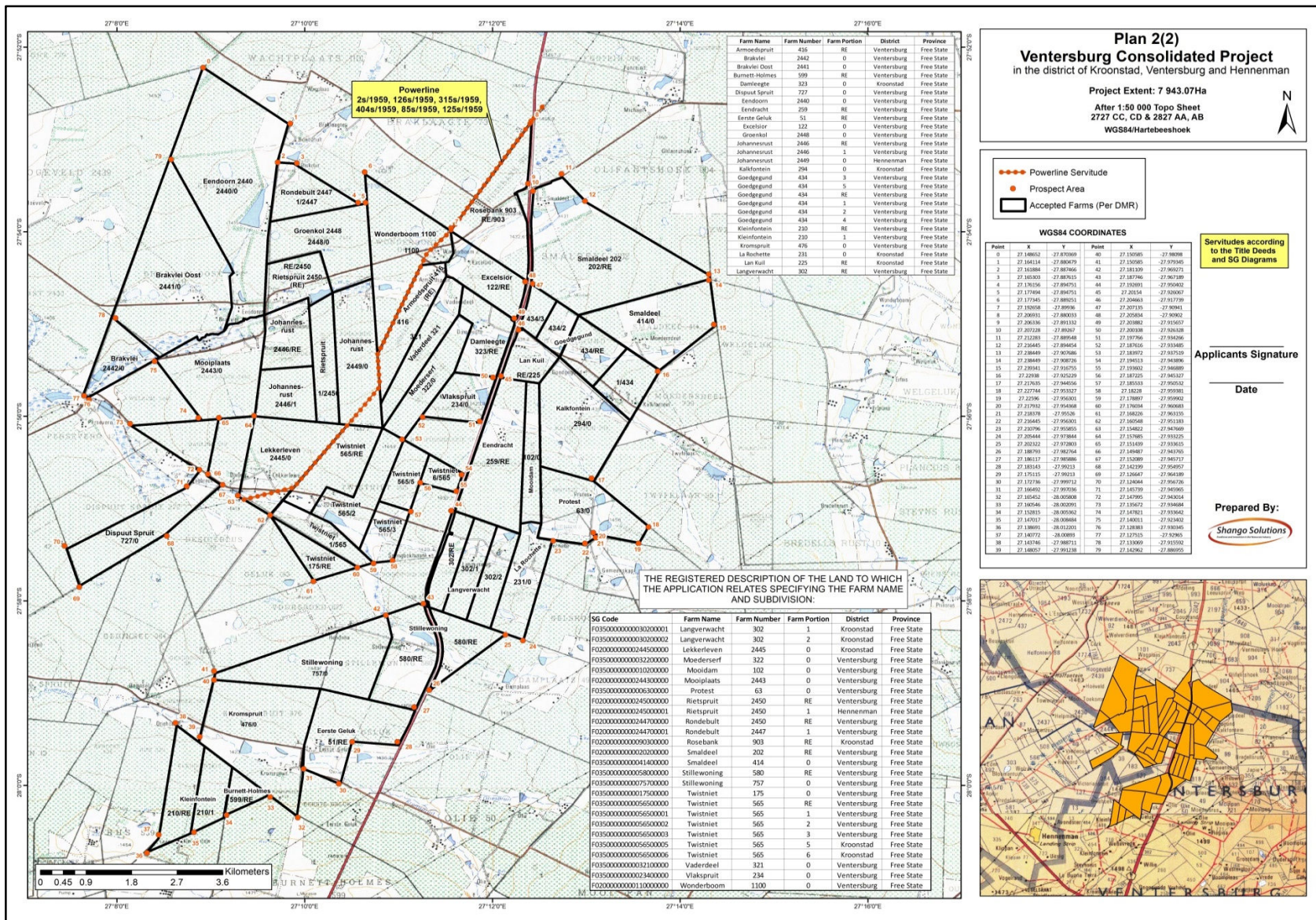


Figure 1: Locality map.

The area of interest occupies a total of approximately 7 943.07 hectares (ha) and it is located approximately 14 kilometres (km) north-northeast of Ventersburg in the Free State Province of South Africa. The proposed prospecting area is located in the Kroonstad, Ventersburg and Hennenman Magisterial Districts. Table 1 indicates the property details within the Prospecting Right application area. Fifty-three (53) farm portions extend over the application area (Figure 1).

4. PROJECT DESCRIPTION

Invasive and non-invasive prospecting activities will be undertaken as part of the proposed Prospecting Work Programme. The scope of these activities is as follows:

Phase 1

1.1 Investigate all sources for historical data [Year 1: 6 months]

Prospecting for gold in the Free State area started in the 1930's resulting in nearly 90 years' worth of exploration in the area. Hence, there exists a significant amount of historical exploration data in the Free State and over the project area. Obtaining and analysing this historical data will allow the fast-tracking of prospecting activities. Heavy mineral sands can also be investigated as a potential resource and as an aid to the development of the geological model.

1.2 Obtain all relevant historical data [Year 1: 6 months]

Historical data detailing the position and economic potential of the target horizons will be identified for potential acquisition. The data obtained is anticipated to be in the form of historical borehole information, cadastral maps, geological maps, geophysical surveys (including existing published gravimetric, radiometric, magnetic, seismic and remote sensing data), as well as any information pertaining to previous exploration or mining will be consulted and integrated. The data will be scrutinised and verified (QA/QC procedure).

Data acquisition will begin with commercial negotiations to allow Western Allen Ridge to gain access to the boreholes for use in the desktop study, geological model and potential resource estimate.

1.3 Desktop study [Year 1: 6 months]

A desktop study will be performed utilising all the historical reports obtained during Step 1.2.

Phase 2

2.1 Inventorise, capture and QA/QC all available historical data [Year 2: 5 months]

The data located and acquired during Year One will be inventorised in Microsoft Access databases for future reference and ease of access to relevant information. The capturing of data will transform hard copy information into an electronic format, creating a powerful tool for use in 3 dimensional (3D) geological modelling and efficient resource estimation.

2.2 Data synthesis and database creation [Year 2: 5 months]

The above data will be compiled into a geological database, which will be utilised to present the relevant data in useable Geographic Information System (GIS) digital map format. The different data sets will be plotted on a base map of the project and surrounding areas in order to develop a geological model. This model will be used to further refine the exploration programme for the target area.

2.3 Definition of regional geological characteristics [Year 2: 2 months]

With the improved geological and geophysical datasets it will be possible to increase the confidence in the basic sedimentological and structural geological models and identify areas where the initial geological model should be created.

Phase 3

3.1 Generate the initial geological model [Year 3: 6 months]

Utilising the historical data, a preliminary 3D geological model will be developed. This model will be employed to further refine the exploration programme for the prospect area.

3.2 Location of key historic borehole core, if available [Year 3: 6 months]

Based on the initial geological model, specific key boreholes previously drilled in the area will be identified and negotiations with the owners undertaken to obtain access to the core.

3.3 Re-logging and re-sampling of historical boreholes **[Year 3: 6 months]**

Once access to the historical core is obtained, the core will be re-logged and, if necessary, re-sampled. This activity will allow verification of the historical borehole logs and consequently increase confidence in the data underpinning the geological model.

Phase 4

4.1 Drilling of 4 diamond drill holes to a depth of 500m **[Year 4: 5 months]**

Depending on the initial geological model established, a diamond drilling programme (Figures 2 and 3) comprising of four boreholes will be undertaken.

Drilling will be conducted in a competent and environmentally responsible manner including rehabilitation of the drill sites to their original state. Plastic lining will be placed underneath the rig motors to prevent oil seepage. It is noted that no drilling fluids other than water for dust suppression, will be utilised in the case of diamond drilling. Environmental rehabilitation measures will be included in the contract with the drilling company and environmental rehabilitation costs will be included in the drilling costs.

4.2 Logging and sampling of drillholes **[Year 4: 4 months]**

Once the holes are drilled, logging and sampling will be performed to capture the drillhole information into the database.

4.3 Refinement of geological model **[Year 4: 3 months]**

The data obtained from the drilling and logging of the holes will be integrated into the geological model to confirm the geology and refine the future drilling targets. The updated geological model will be utilised to site the drillholes planned during the Year 5 drilling programme.

Phase 5

5.1 Drilling of 2 diamond drill holes to a depth of 500m **[Year 5: 7 months]**

Additional two diamond boreholes will be drilled. Should the drilling programme prove to be successful, additional holes will be considered. This will be indicated in the form of a S102 application together with the proposed revised prospecting plan and EMPR.

5.2 Logging and sampling of drillholes **[Year 5: 4 months]**

Once the holes are drilled, logging and sampling will be performed to capture the drillhole information into the database.

5.3 Finalisation of 3D geological model **[Year 5: 4 months]**

Based on the re-logging and re-sampling of the historical core, the 3D geological model will be updated and finalised for use during resource estimation.

5.4 Resource estimation **[Year 5: 2 months]**

Utilising the finalised geological model together with historical assay results and any results from re-sampling, a resource estimate will be performed.

5. GEOLOGICAL FORMATION AND PROSPECTING TARGETS

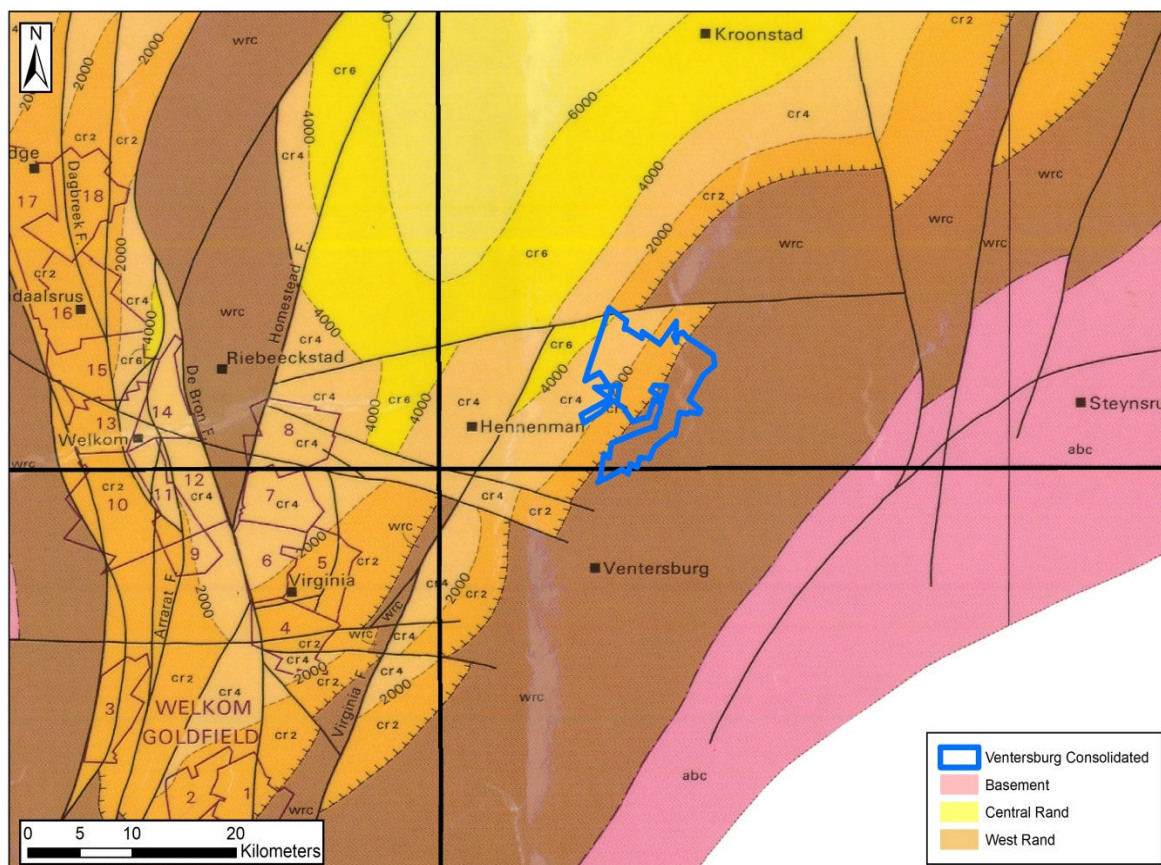


Figure 4: Map of the Witwatersrand Basin (Pretorius, 1964), together with depths to the Central Rand Group.

The application area has been selected based predominantly on historical data available for the region, which indicates the potential for economically viable resources to occur. The Free State Goldfield was discovered by geophysical means during the 1930's, when Dr. R Krahnmann delineated the edge of the Witwatersrand Basin by mapping magnetic shales of the West Rand Group with a magnetometer. This was followed by extensive diamond exploration drilling, which intersected the auriferous conglomerates of the Central Rand Group (Figure 4). As a result, one of the major goldfields on earth was developed.

Welkom, the largest town in the Free State Goldfield, is situated about 270 kilometres towards the southwest of Johannesburg, about 1 370 metres above mean sea level. The Welkom Goldfield hosted eleven mines in the triangle between Allanridge, Welkom and Virginia. These mines have collectively produced in excess of 9.6 million kilogrammes of gold.

The Central Rand Group of the Witwatersrand Supergroup is present within the proposed Ventersburg Consolidated Prospecting Right, with four potentially economic placer deposits, namely the Basal Reef, Big Pebble Conglomerate, A Reef and the B Reef. The main targets for prospecting are the potentially gold bearing conglomerates (reefs) of the Central Rand Group within the Witwatersrand Supergroup.

The Witwatersrand Supergroup which hosts gold is generally overlain by 500 metres of Karoo Supergroup strata, predominantly horizontally bedded sandstones and shales of the Eccca Group. The Eccca Group contains coal at shallow depths which might be exploitable. In addition to gold, the primary prospecting target, silver, uranium, sulphur, diamonds, rare earths and platinum group metals are currently and have been historically, extracted as by-products of gold. Base metals (cobalt, copper, manganese, molybdenum, nickel, lead, tungsten and zinc) could potentially be present in mafic intrusions.

6. REGULATORY REQUIREMENTS

South African law requires that the Environmental Authorisation be sought for certain activities prior to commencement. As part of the application process for Environmental Authorisation it is necessary to assess the environmental and social impacts associated with the activities, so as to identify any potential negative and/or positive consequences as result thereof. GN R. 324 (of 2017), Activity 12(b): The clearance of an area of 300 square metres or more of indigenous vegetation except where such clearance of such indigenous vegetation is required for maintenance purpose undertaken in accordance with a maintenance management plan (i) within any critically endangered or endangered ecosystem listed in terms of Section 52 of the NEMBA or prior to the publication of such a list, within an area that has been identified as critically endangered in the National Spatial Biodiversity Assessment 2004 and (ii) within critical biodiversity areas identified in bioregional plans.

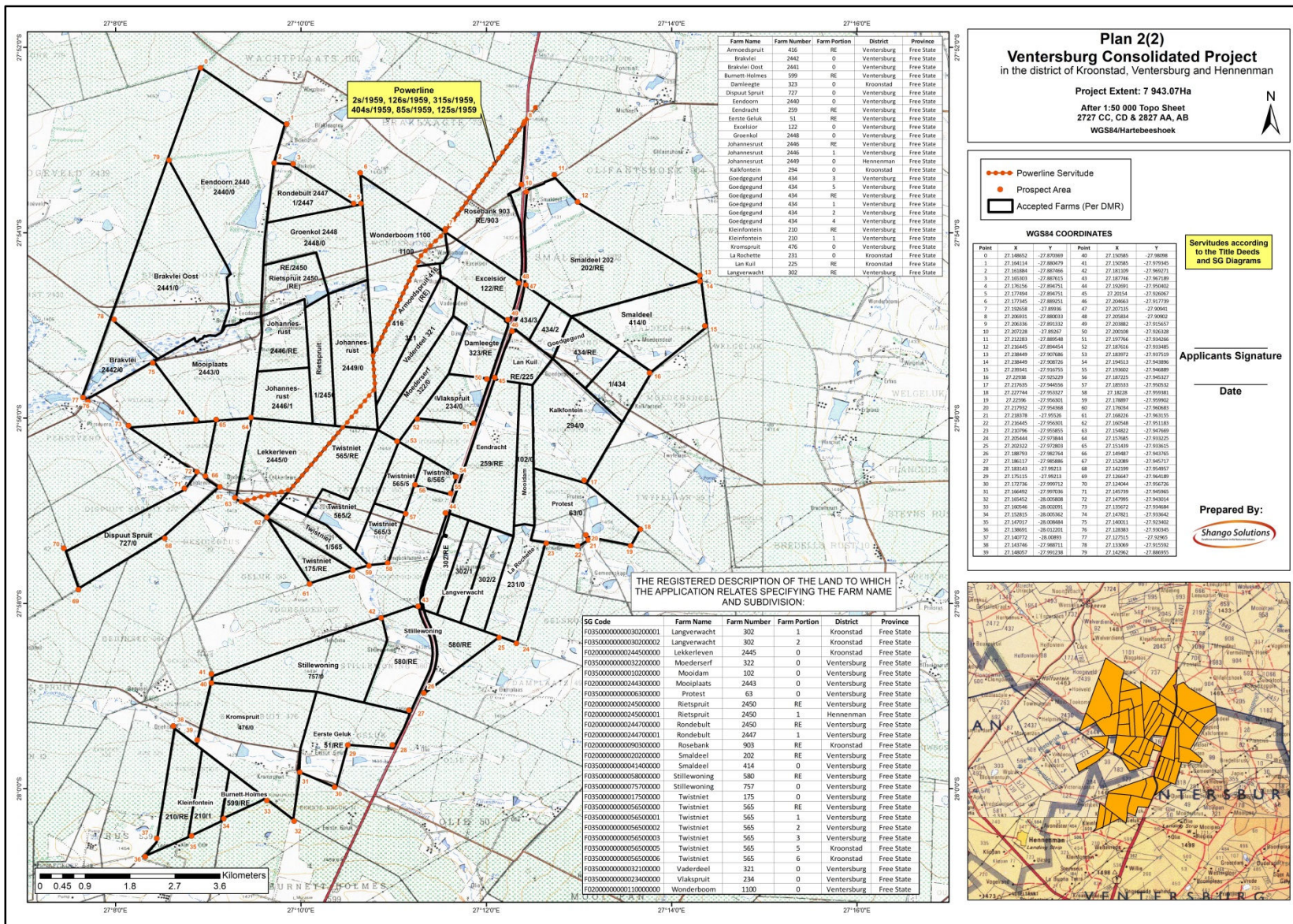

4. PROJEKBESKRYWING

Indringende en nie-indringende prospekteeraktiwiteite sal as deel van die voorgenome prospekteerwerkprogram onderneem word. Die omvang van hierdie aktiwiteite is soos volg:

Fase 1

1.1 Onderzoek alle bronne vir historiese data [Jaar 1: 6 maande]

Prospekteerwerk vir goud het in die 1930's in die Vrystaatgebied begin en tot amper 90 jaar se verkenning in die gebied gelei. Daar bestaan dus 'n beduidende hoeveelheid historiese eksplorasië in die Vrystaat en oor die projekgebied. Die bekom en ontleding van hierdie historiese data sal prospekteeraktiwiteite vinniger laat geskied. Swaarminerale-sand kan ook as 'n moontlike bron en as hulp in die ontwikkeling van die geologiese model ondersoek word.

1.2 Bekom alle relevante historiese data [Jaar 1: 6 maande]

Historiese data wat die posisie en ekonomiese moontlikheid van die teikenhorisonne uiteensit, sal vir moontlike aanskaffing geïdentifiseer word. Daar word verwag dat die data in die vorm van historiese boorgatinligting, kadasterkaarte, geologiese kaarte en geofisiese opnames (bestaande gepubliseerde gravimetrie, radiometrie, magnetiese, seismiese en afstandwaarnemingsdata ingesluit) bekom sal word; en enige inligting wat verband hou met vorige eksplorasië, of mynbou, sal ook geraadpleeg en geïntegreer word. Die data sal bestudeer en geverifieer word (GV/GB-prosedure).

Data-aanskaffing sal begin met kommersiële onderhandelinge om vir Western Allen Ridge toegang tot die boorgate vir gebruik in die lessenaarstudie, geologiese model en moontlike hulpbronskatting, te bewerkstellig.

1.3 Lessenaarstudie [Jaar 1: 6 maande]

'n Lessenaarstudie sal uitgevoer word deur al die historiese verslae wat in Stap 1.2 bekom is, te gebruik.

Fase 2

2.1 Inventariseer en GV/GB alle beskikbare historiese data, en lê dit vas [Jaar 2: 5 maande]

Die data wat gedurende die eerste jaar opgespoor en aangeskaf word, sal vir toekomstige verwysing en gerieflike toegang tot die betrokke inligting, in Microsoft Access-databasisse geïnteriseer word. Die vaslegging van data in fisiese kopieë na elektroniese formaat is 'n kragtige werktuig vir gebruik in driedimensionele (3D) geologiese modellering om 'n doeltreffende hulpbronskatting daar te stel.

2.2 Datasintese en skep van databasis [Jaar 2: 5 maande]

Bogenoemde data sal in 'n geologiese databasis saamgestel word, wat gebruik sal word om die betrokke data in (digitale kaartformaat voor te stel) in bruikbare geografiese inligtingstelsel (GIS). Die verskillende datastelle sal op 'n basiese kaart van die projek en die omliggende gebiede gekarteer word ten einde 'n geologiese model te ontwikkel. Die model sal gebruik word om die verkenningsprogram vir die teikengebied verder te verfyn.

2.3 Omskrywing van streeks geologiese kenmerke [Jaar 2: 2 maande]

Met die verbeterde geologiese en geofisiese datastelle sal dit moontlik wees om vertroue in die basiese sedimentologiese en strukturele geologiese modelle te versterk en gebiede waar die aanvanklike geologiese model geskep moet word, te identifiseer.

Fase 3

3.1 Skep die aanvanklike geologiese model [Jaar 3: 6 maande]

'n Voorlopige 3D geologiese model sal met gebruik van die historiese data ontwikkel word. Hierdie model sal gebruik word om die verkenningsprogram vir die prospekteergebied verder te verfyn.

3.2 Ligging van belangrikste historiese boorgate, indien beskikbaar [Jaar 3: 6 maande]

Op grond van die aanvanklike geologiese model sal spesifieke belangrike boorgate, wat voorheen in die gebied gesink is, geïdentifiseer word en sal daar met die eienaars onderhandel word om toegang tot die boorkern te verkry.

3.3 Beskrywing en hertoetsing van historiese boorgate

[Jaar 3: 6 maande]

Wanneer toegang tot die historiese kern verkry is, sal die kern weer beskryf en, indien nodig, hertoets word. Hierdie aktiwiteit sal die verifikasie van historiese boorgatlogboeke toelaat en gevolglik vertrouwe in die data wat die geologiese model ondersteun, verhoog.

Fase 4

4.1 Boor van 4 diamantboorgate tot op 'n diepte van 500m

[Jaar 4: 5 maande]

Afhangende van die aanvanklike geologiese model wat vasgestel is, sal 'n diamantboorprogram (Figure 2 en 3) bestaande uit vier boorgate, onderneem word.

Daar sal op bevoegde en omgewingsverantwoordelike wyse geboor word, wat die rehabilitasie van die boorterreine tot hul oorspronklike toestand insluit. Plastiekvoering sal onder die boortorings geplaas word om olieëkke te voorkom. Geen ander boorvloeistowwe buiten water sal in die geval van diamantboordery vir stofonderdrukking gebruik word nie. Omgewingsrehabilitasiemaatreëls sal in die kontrak met die boormaatskappy ingesluit wees en omgewingsrehabilitasiekoste sal by die boorkoste ingesluit wees.

4.2 Aantekening en toetsing van boorgate

[Jaar 4: 4 maande]

Wanneer die boorgate geboor is, sal die boorgatinligting getoets en in die databasis aangeteken word.

4.3 Verfyning van geologiese model

[Jaar 4: 3 maande]

Die data wat uit die boor en aantekening van die gate bekom word, sal by die geologiese model geïntegreer word om die geologie te bevestig en toekomstige boorteikens te verfyn. Die bygewerkte geologiese model sal gebruik word om die terrein vir die boorgate wat vir Jaar 5 se boorprogram beplan word, vas te stel.

Fase 5

5.1 Boor van 2 diamantboorgate tot op 'n diepte van 500m

[Jaar 5: 7 maande]

Twee bykomende diamantboorgate sal geboor word. Sou die boorprogram suksesvol wees, sal bykomende gate oorweeg word. Dit sal in die vorm van 'n S102-aansoek, saam met die voorgenome hersiene prospekterplan en OBPR, aangedui word.

5.2 Aantekening en toetsing van boorgate

[Jaar 5: 4 maande]

Wanneer die boorgate geboor is, sal die boorgatinligting getoets en in die databasis aangeteken word.

5.3 Finalisering van 3D geologiese model

[Jaar 5: 4 maande]

Die 3D geologiese model sal, op grond van die heraantekening en hertoetsing van die historiese kern, vir gebruik tydens hulpbronskatting bygewerk en gefinaliseer word.

5.4 Hulpbronskatting

[Jaar 5: 2 maande]

Die gefinaliseerde geologiese model, saam met historiese essaai-uitslae en enige uitslae van hertoetsing, sal gebruik word om 'n hulpbronskatting uit te voer.

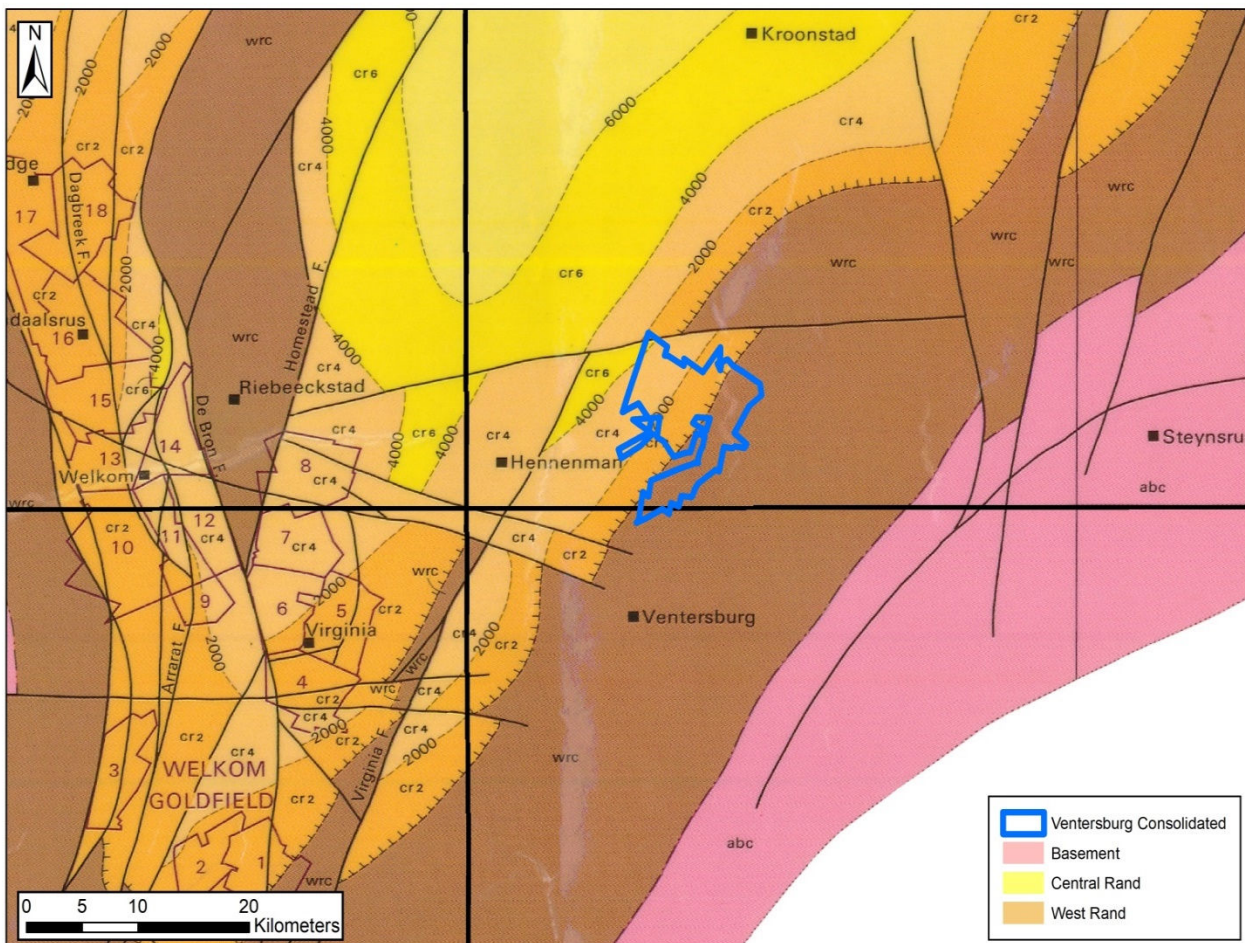
5. GEOLOGIESE FORMASIE EN PROSPEKTEERTEIKENS

Die gebied waarvoor aansoek gedoen is, is hoofsaaklik op grond van die historiese data, wat vir die streek beskikbaar is, gekies. Hierdie data dui op die moontlikheid dat ekonomies lewensvatbare hulpbronne voorkom. Die Vrystaatse Goudveld is gedurende die 1930's op geofisiese wyse ontdek, toe Dr. R Krahnmann die rand van die Witwatersrandkom afgebaken het deur die magnetiese skalie van die Wes Rand-groep met 'n magnetometer te karteer. Dit is gevolg deur uitgebreide eksplorasië boorwerk vir diamante, wat die goudhoudende konglomeraat van die Sentrale Rand-groep (Figuur 4) gesny het. Die gevolg was die ontwikkeling van een van die grootste goudvelde op aarde.

Welkom, die grootste dorp in die Vrystaatse Goudveld, lê ongeveer 270 kilometer suidwes van Johannesburg, en ongeveer 1 370 meter bo gemiddelde seevlak. Welkom se goudveld het elf myne in die driehoek tussen Allanridge, Welkom en Virginia opgelewer. Hierdie myne het gesamentlik meer as 9.6 miljoen kilogram goud gelewer.

Die Sentrale Rand-groep van die Witwatersrand-supergroep is binne die voorgenome Ventersburg Consolidated Prospekterreg teenwoordig, met vier moontlike ekonomiese spoelersafsettings, naamlik Basaarif, Big Pebble-konglomeraat, A-rif en B-rif. Die hoofteikens vir prospekterwerk is die moontlike gouddraende konglomerate (riwwe) van die Sentrale Rand-groep binne die Witwatersrand-supergroep.

Die Witwatersrand-supergroep, wat goud dra, is oor die algemeen bedek deur 500 meter Karoo-supergroepstrata – hoofsaaklik horisontale lae sandsteen en skalie van die Ecca-groep. Die Ecca-groep bevat steenkool op lae vlakke, wat ontginbaar kan wees. Bykomend tot goud, is die primêre prospekterteikens silwer, uraan, swael, diamante, seldsame aardelemente en metale in die platinumgroep tans en ook histories as neweprodukte van goud onttrek. Basismetale (kobalt, koper, mangaan, molibdeen, nikkel, lood, wolfram en sink) kan moontlik in mafiese intrusies teenwoordig wees.

6. REGULATORIESE VEREISTES

Suid-Afrikaanse wetgewing vereis dat die omgewingsmagtiging vir sekere aktiwiteite voor aanvang bekom word. As deel van die aansoekproses vir omgewingsmagtiging is dit nodig om die maatskaplike en omgewingsimpakte wat met die aktiwiteite gepaard gaan vas te stel, sodat enige moontlike negatiewe en/of positiewe gevolge wat daaruit kan spruit, geïdentifiseer kan word. Maatreëls moet voorgestel word om hierdie impakte te vermy of tot die minimum te beperk.

Kragtens die WNOB en die gepaardgaande OIA-regulasies (RK R. 324/RK R. 325/RK R. 327) kan die volgende gelyste aktiwiteit vir die voorgename projek geld en as sodanig is die aansoek aan 'n proses vir 'n basiese assesseringsverslag onderhewig:

- **RK R. 327 (van 2017), Aktiwiteit 20:** Enige aktiwiteit, ingeslote die bedryf van 'n aktiwiteit wat 'n prospekterreg kragtens artikel 16 van die Wet op die Ontwikkeling van Minerale en Petroleumhulpbronne, 2002 (Wet 28 van 2002), vereis, ingeslote (a) gepaardgaande infrastruktuur, strukture en grondwerk, wat direk verband hou met prospektering vir 'n mineraal, of (b) die primêre verwerking van 'n minerale hulpbron, ingeslote winning, onttrekking, klassifikasie, konsentrasie, vergruising, sifting of was; maar uitgeslote die sekondêre verwerking van 'n minerale hulpbron, ingeslote smelting, veredeling, reduksie, raffinering, kalsinering, of vergassing.
- **RK R. 324 (van 2017), Aktiwiteit 12(b):** Die verwydering van inheemse plantegroei oor 'n gebied van 300 vierkante meter of meer, buiten waar sodanige verwydering van sodanige inheemse plantegroei vir onderhoudsdoeleindes, onderneem in ooreenstemming met die onderhoudsplan, nodig is (i) binne enige krities bedreigde of bedreigde ekosisteme wat ingevolge artikel 52 van die WNOB gelys is, binne 'n gebied wat as krities bedreigd in die Nasionale Ruimtelike Biodiversiteitsassessering 2004 geïdentifiseer is en (ii) binne kritieke biodiversiteitsgebiede soos in biostreeksplanne geïdentifiseer.

7. TIPIESE IMPAKTE WAT MET HIERDIE AKTIWITEITE VERBAND HOU

Die volgende impakte sal, onder andere, deur die basiese assesseringsverslag beoordeel en daarby ingesluit word:

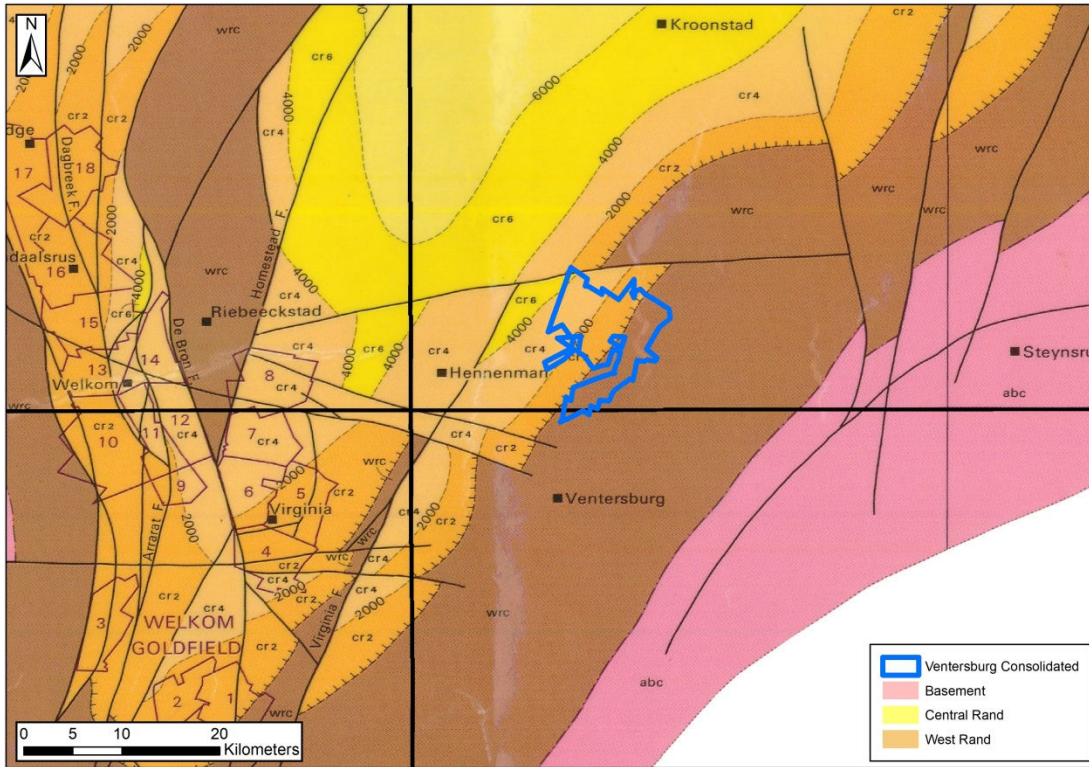
