**ENVIRONMENTAL IMPACT ASSESSMENTS AND A WASTE MANAGEMENT LICENSE
APPLICATION FOR THE PROPOSED NEW 30 YEAR ASH DISPOSAL FACILITY AND
ASSOCIATED INFRASTRUCTURE AT KENDAL POWER STATION**

As you may recall, during the last week of November 2012 Zitholele Consulting announced the commencement of the Environmental Impact Assessment (EIA) process and Waste Management License Application for the proposed above-mentioned project through the placement of advertisements, erection of site notices, distribution of notification letters and a background information document and personal telephone calls. This announcement and notification activity was done simultaneously with the announcement and notification of the Integrated Environmental Authorisation and Water Use License Application for the proposed Continuous Ash Disposal Facility at Kendal Power Station (DEA Reference 14/12/16/3/3/3/63).

Your comments and/or concerns raised to date regarding this proposed project thus far is appreciated.

DRAFT SCOPING REPORT FOR REVIEW AND COMMENT

We would like to make use of this opportunity to inform you that the Draft Scoping Report (DSR) will be available for public review from **Thursday, 6 June 2013 to Tuesday, 18 July 2013**. Thereafter, the report will be updated with comments received and submitted to the Department of Environmental Affairs (DEA). The DEA will, in consultation with the environmental authorities of Mpumalanga, consider the scope covered by the specialist studies and either accept the Scoping Report and approve the Plan of Study for EIA, or request amendments to the DSR.

In accordance with the EIA Regulations, the purpose of a DSR is to outline the scope of the project and to identify areas where additional studies are required in order to make an informed decision. Interested and affected parties (I&APs) also have an opportunity to verify that their contributions to date have been captured and correctly understood by the project team. All issues raised by the I&APs, along with issues identified by the environmental technical specialists, have been used to define the terms of reference for the Specialist Studies that will be conducted during the Impact Assessment Phase of the EIA.
