Effluent from the wash bay should be disposed of in a properly constructed drain and must be situated as far as possible from a watercourse. Only domestic wash water should be allowed to enter the drain and any effluent containing oil and grease or other industrial substances must be collected in a suitable receptacle and removed from site. The name of the company to handle the hazardous waste should be forwarded to DWS. A written agreement between the applicant and the said company should also be submitted to DWS. The applicant should ensure that the septic tank is approved and is sited in such a way that it does not cause water or other pollution. Mitigation measures must be in place to prevent contamination of local groundwater and surface water. The applicant should indicate where the effluent will be discharged after it is drained from the septic tank.
