APPLICATION FOR AN ENVIRONMENTAL AUTHORISATION AND A WATER USE AUTHORISATION FOR THE CONSTRUCTION OF A PIPELINE BETWEEN THE BAVIAANSPOORT CORRECTIONAL SERVICES PUMP STATION AND THE BAVIAANSPOORT MUNICIPAL WASTEWATER TREATMENT WORKS, GAUTENG PROVINCE INVITATION TO REGISTER, PARTICIPATE AND COMMENT ON THE ENVIRONMENTAL AND WATER USE AUTHORISATION PROCESSES

Notice is hereby given, that the Department of Public Works (DPW) is applying for an Environmental Authorisation (EA) and Water Use Authorisation (WUA) for the construction of a pipeline between the Baviaanspoort Correctional Service Pump Station and the Baviaanspoort Municipal Wastewater Treatment Works at Baviaanspoort. DPW is planning to replace the existing pipeline that carries wastewater between the Baviaanspoort Correctional Services Pump Station and the Baviaanspoort Municipal WWTW. The pipeline will cross the Pienaar's River and together with the general refurbishment and upgrading of infrastructure at the Baviaanspoort Wastewater Care Works and Correctional Services Pump Station will require a Section 21 (c) and (i) WUA as stipulated in the National Water Act, 1998 (Act 36 of 1998). The project will also require an Environmental Authorisation (EA) in terms of the National Environmental Management Act (Act No. 107 of 1998) (NEMA).

Proponent: Department of Public Works (DPW)

Location: The project falls within City of Tshwane Metropolitan Municipality, in the Gauteng Province of South Africa. The details of the affected properties are provided in Table 1-1.

ENVIRONMENTAL AUTHORISATION PROCESS:

The project triggers the listed activities in Listing Notice 1 and 3 of the National Environmental Management Act, 1998 (Act 107 of 1998) (NEMA) and requires an Environmental Authorisation (EA). A section of the proposed pipeline will be located within the 1: 100-year Floodlines of the Pienaar's River and will therefore require a Section 21 (c) and (i) Water Use Authorisation from the Department of Water and Sanitation (DWS).
