LAND CLAIMS ENQUIRY - DRIEKOP 253 KT

We refer to your letter dated 21 July 2022.

We confirm that there is an existing land claim against the Property. The claim was lodged by Marota Madibong Community with Ref: R/5/121/465/144308 on the

The claim was lodged in terms of the Restitution of Land Rights Amendment Act, 2014 (Act No 15 of 2014) ("the Amendment Act") which, amongst others, reopened the lodgement of claims for a period of five years.

The validity of the Amendment Act was challenged in the Constitutional Court. The Constitutional Court found the Amendment Act to be invalid because of the failure of Parliament to facilitate public involvement as required by the Constitution. The Amendment Act ceased to be law on 28 July 2016.

The Constitutional Court ordered that the claims that were lodged between 1 July 2014 and 27 July 2016 are validly lodged, but it interdicted the Commission from processing those claims until the Commission has finalised the claims lodged by 31 December 1998 or until Parliament passes a new law providing for the re-opening of lodgement of land claims.

The Commission will therefore not be processing the above claim until it finishes claims lodged by 31 December 1998 or until Parliament passes a new law providing for re-opening of lodgement of claims.

It is important to note that the provisions of section 11 (7) of the Restitution of Land Rights Act, 1994 do not apply until after the Commission has accepted the claim for investigation and published its details in the Government Gazette. That will only be done on the happening of either event in the previous paragraph.

SCOPING REPORT FOR THE DEVELOPMENT OF A PROPOSED SOLAR PHOTOVOLTAIC FACILITY AT THE MARULA PLATINUM MINE, LIMPOPO PROVINCE – AVAILABLE FOR PUBLIC REVIEW

Notice is hereby given: Marula Platinum (Pty) Ltd (Marula), applied for Environmental Authorisation and to undertake a public participation process in terms of the Environmental Impact Assessment (EIA) Regulations, 2014 (published under Government Notice No. R. 982 (No. 38282 of 4 December 2014), and amended by Government Notice No. 326 (No. 40772 of 7 April 2017), Government Notice No. 706 (No. 41766 of 13 July 2018), Government Notice No. 599 (No. 43358 of 29 May 2020) and Government Notice No. 517 in (44701 of 11 June 2021) for the development of a Solar Photovoltaic (PV) facility.

Overview of project including, nature, location, and property details: Marula, an existing platinum producer and a subsidiary of Impala Platinum Holdings Limited, owns and operates Marula Mine. The Marula Mine is situated along the R37, approximately 30 km to the north-west of the town Burgersfort and has been operational since 2001.

Marula is proposing to establish a Solar Photovoltaic (PV) facility, with a generation capacity of up to 33 MW, within its existing Mining Right Area for self-generation only (the solar PV facility is hereafter referred to as the proposed Project). The Proposed Project is located on the farms Driekop 253 KT and Clapham 118 KT. The proposed solar PV facility will be connected through the expansion of the Marula Mine's existing transmission infrastructure and substation.



Jeff Mabuza has passed away in Mbombela on Monday.

STEELPOORT

ocal businessman Jeff
Mabuza has sadly
passed away. Locals
learnt of the shock
news on Monday afternoon.
Mabuza died in a tragic plane
crash near the old Nelspruit
Airfield outside Mbombela on
Monday afternoon, at about
15:30.

According to the South African Civil Aviation Authority (SACAA) the crash occurred west of the old Nelspruit Airfield.

"SACAA preliminary report on the plane crash will

be released within the next 30 days. They are currently investigating the crash of the light aircraft," said SACAA's 'Siza Majola.

Meanwhile Mpumalanga SAPS confirmed they have lodged an inquest after a 44-year-old man died when his aircraft crashed in Mbombela.

Police spokesperson Brigadier Selvy Mohlala said reports indicate he was flying alone in a mountainous area near Kaapsehoop Road from Steelpoort.

"He was heading to the old Nelspruit airport when the accident occurred. Emergency service personnel were called to the scene, but "his lifeless and decapitated body was found next to the crash site and paramedics certified him dead

"A preliminary probe revealed Mabuza owned the aircraft, but the cause of the crash was unclear and the SACAA would investigate."

Mabuza who is from Longtill is known as one of the directors and owners of Mbonjomane, Construction and Plant Hire, a company which operates around the Fetakgomo Tubatse area.

Addressing the structures, Mathope said he was disappointed by the progress made to date and lambasted both the officials and ANC deployees, to the district municipality due to indecisiveness in dealing with water challenges. "Water provision is very

crucial in repositioning and reclaiming the position on the ANC in communities. Anyone who stands against this programme of providing water to our people will be dealt with harshly," warned

Mathope.

He indicated that it is unacceptable to have little progress by now, especially in ensuring that repairs and maintenance function get devolved to local municipality.

"The ANC has full powers to redeploy councillors that fail to hold the administration accountable to effectively. If the accounting officer has deadwood in the system, consequence management must be implemented," he said.

The session resolved to revamp the Rapid Response

Teams (RRT) in clusters until the municipal level and further decided to establish the monitoring and evaluation team, which will strengthen the Office of the Regional Secretary.

"The ANC is confident that there will be no stone left unturned until the people of Sekhukhune land have access to safe drinking water," concluded Mathope.

Sekhukhune is one of the areas currently experiencing a serious shortage of drinkable water, with some of residents resorting to fetching drinking water from nearest rivers, wells and streams.

Other community members survive by drilling boreholes in their yards as a permanent solution to the problem.

Billions of rands were since allocated for major water provision projects such as the De Hoop Dam Project, Moutse Bulk Water Supply Project, Moutse Draught Relief Projects and the Malekana Water Treatment Plant.

However, the projects were never completed due to alleged corruption and tender irregularities within the district municipality.

Heavy rains destroys properties in Limpopo

Heavy rains left many homeless when buildings were destroyed in Limpopo, including villages in the Fetakgomo Tubatse on Sunday, January 29.

Those hugely affected by the rains included local schools, street vendors and home owners.

Livestock such as chickens were also allegedly killed by the storms.

"We are thankful, it was on a Sunday, because pupils would have been endangered by the storms," indicated a resident from Riba Cross outside Burgersfort. He said several shacks were damaged by the storms. Meanwhile, the provincial disaster management centre released a statement.

"We had several reports from people saying that their homes had been damaged and livestock killed. A few cars' windscreens had also been shattered as people drove through the storm."

According to the disaster management centre, people could report any weather disaster, including veld fires, toll-free on 0800 222111.

The South African Weather Services (SAWS), said heavy rains are expected in Mpumalanga, Gauteng and Limpopo provinces in the coming weeks.

Brigadier Motlafela Mojapelo, Limpopo Provincial Police Spokesperson, indicated that soon after becoming aware of the video, General Hadebe ordered the Family Violence, Child Protection and Sexual Offences unit to conduct an immediate probe into the incident with a view of apprehending the policewoman and removing the child to a place of safety.

Mojapelo informed that a case of rape of a minor with additional charges of creating and distributing child pornographic material and sexual grooming of a child was opened on Friday 20 January 2023 and that the suspect was arrested on the same day.

"Internal police processes have already kicked in following her arrest and will run parallel with criminal investigation that has been taken over by the Independent Police Investigations Directorate (IPID), added Mojapelo.

General Hadebe said that the actions of the woman were deplorable and deserved harsh condemnation and that even though the suspect allegedly committed the crime when she was still a Public Service Act employee of the South African Police Service (SAPS), she should have known better that such unbecoming behaviour deserved harsh consequences.

She further said that the SAPS did not have space for such people who tarnish its image and ordered that the suspect be subjected to immediate internal processes in terms of the SAPS disciplinary regulations.

The suspect, aged 39, appeared in the Mdutjane Magistrate's Court in Siyabuswa outside Marble Hall facing charges of rape and sexual grooming of children and her case was postponed to today Thursday, 02 January 2023 for formal bail application.

Her identity cannot be divulged to protect the child who has been removed to a place of safety where he will be given psychological treatment and assistance.

Corrie Pretorius sentenced

GROBLERSDAL - Corrie Pretorius who was arrested for assaulting a 16 year-old boy on 15 June 2022 evening at one of the food-outlets in Groblersdal Town and granted R20 000 bail on Wednesday, 07 September 2022 by the Polokwane High Court was sentenced to 12 months imprisonment or R12 000 fine by the Groblersdal Magistrate's Court on 28 January 2023

Pretorius faced charges of assault with intent to cause grievous bodily harm on the 16 year-old boy and pointing of a firearm.

The 50 year-old Pretorius, who was seen brandishing a gun in a video that circulated on social media platforms while assaulting the teenager, was arrested on 16 June 2022 morning after an intensive investigation by the local police.

On the night, other shoppers watched helplessly as the gun-wielding Pretorius assaulted the boy until he eventually left him lying on the ground. The victim was later taken to the Groblersdal Hospital and discharged.

It is alleged that the teenager and his cousin were at the foot-outlet in the town when he asked to use the same seasoning as the accused. He became furious and started assaulting the minor. A video of the incident was captured and posted on social media.

Mashudu Malabi-Dzangi, NPA Limpopo Spokesperson, indicated that the accused

pleaded guilty to the offence and was remorseful. Malabi-Dzangi said that sate advocate, Billy Mudavhi submitted that the offence was serious and had the interest of the community.

'It is for this reason that the MQA is participating in the development of the Sekhukhune TVET College Skills Development Centre, as a response to the call by the college to construct a skills development centre," he said.

Tom Mkhwanazi, CEO of Wholesale and Retail SETA, provided an overview of how the R131 Million project was initiated, which was anticipated to be completed by 2025.

After its completion, the skills development facility is expected to produce one of the scare artisan skills in South

It forms part of SETA's R240 Million special infrastructure projects in the country for TVET colleges, with the other R109 Million allocated to support newly established community education and training colleges throughout all

ix suspects were arrested and appeared before the Marble Hall Magistrate's after being found loading illicit cigarettes into a gas tanker at Tooitskraal on Friday, 27 January.

The six suspects appeared before the Marble Hall Magistrate's court and were remanded to custody until a date to be announced.

Colonel Malesela Ledwaba, Limpopo Provincial Police Spokesperson, said that the six foreign nationals were intercepted after police received information about suspects who were busy offloading illicit cigarettes from a gas tanker into cargo trucks.

Ledwaba added that according to information, the suspects parked the tanker and two cargo trucks at one of the farms in Tooitskraal.

"Police responded swiftly and managed to

apprehend the suspects. It is further alleged that the gas tanker was form Musina and was being escorted by a white Toyota Auries while the two cargo trucks were reportedly from Gauteng. The said illicit cigarettes, worth over twelve million rands together with the vehicle used to transport the consignment were confiscated," explained Ledwaba.

The suspects are facing charges of possession of suspected stolen goods and smuggling of illicit cigarettes into the Republic of South Africa from neighbouring countries.

The provincial commissioner of SAPS in Limpopo Lieutenant General Thembi Hadebe has issued a stern warning to community members who continue to report false cases .

The warning comes after the police in Hlogotlou opened a missing person file on January 6 following a report that a woman left her kids on December 31, informing her aunt that she was going to visit her boyfriend at Roossenekal and never came back. "Soon after the matter was reported to the police, a search operation was immediately launched around Roossenekal and even extended to Dullstroon in Mpumalanga Province.

"Social media platforms were also used to report her missing. While still searching, the victim called her family and informed them that she is not missing as reported on social media platforms. She also promised them that she will come back home the following

week," said Hadebe.

The commissioner added, "The police managed to speak to her and she confirmed that she never disappeared and that police must stop wasting state resources trying to locate her as she is not missing."

Hadebe said the number of reported cases of missing persons continue to escalate across Limpopo, and require deployment of more police resources to conduct search operations.

She said a case of missing person is very serious and is treated as a priority at every Police Station in order to save the lives of many people.

"If people report false cases and we divert our resources in search of those people, police efforts to fight crime could be negatively impacted."

Community members are urged to inform family members when visiting friends or relatives as failure to do so, panic will kick in and they will be reported missing.

The proposed Project will require an EA as the project includes activities listed under the Environmental Impact Assessment Regulations, 2014 (GN R 982 of 2014) (EIA Regulations, 2014)³ promulgated in terms of Chapter 5 of National Environmental Management Act, 1998 (No. 107 of 1998) (NEMA). Listed activities are prohibited from commencing until written authorisation is obtained from the Competent Authority (CA), which in this case is the Limpopo Province office of the Department of Mineral Resources and Energy (DMRE). In terms of Section 102 of

the Minerals and Petroleum Resources Development Act, 2002 (No. 28 of 2002) (MPRDA), an EMPr may not be amended or varied without the written consent of the Minister of Mineral Resources.

The MPRDA and NEMA require that an applicant submit the relevant environmental reports required in terms of NEMA. The EIA Regulations set out the assessment process and reporting requirements where authorisation is required. Prior to the commencement of the proposed Project the following is required:

- An amended EMPr in terms of Section 102 of the MPRDA from the DMRE.
- An EA is required in terms of the NEMA for listed activities in the EIA Regulations Listing Notice 1, 2014 (GN R 983 of 2014), Notice 2, 2014 (GN R 984 of 2014) and Notice 3, 2014 (GN R 985).

In addition, the proposed Project also requires authorisation from the DWS for specific water uses listed under Section 21 of the National Water Act, 1998 (No. 36 of 1998) (NWA). This Scoping Report does not address the requirements of a water use licensing process. This will be undertaken as part of a separate process with the DWS. This Scoping and Environmental Impact Assessment process (S&EIA) process does not cover occupational health and safety legislative requirements.

SLR, an independent firm of Environmental Assessment Practitioners (EAPs), has been appointed by Marula to manage the S&EIA process required to inform the proposed Project.

PROJECT ALTERNATIVES


Figure 1: Site Alternatives

For the proposed Project, three site alternatives were taken into consideration, but only the "preferred" site will be further investigated as part of the EIA phase. The preferred Solar PV Plant site and the two alternative sites are shown in Figure 1: Site Alternatives



Figure 2In general, the site selection process of a site for the development of a solar PV facility is dependent on several aspects of which are favourable at the identified project site for the construction and operation of the solar plant project. These aspects include the solar irradiation, topography, extent of the area available for development, proximity of the site to the nearest grid connection point and access to the site.

Technology Alternatives

Based on the solar irradiation resource available and the topography of the site, the placement of solar PV facilities is considered to be the preferred option from a technology perspective. Furthermore, the IRP 2019 has allocated 6000 MW to be procured from solar PV facilities up to 2030 and no allocation has been made for Concentrated Solar Power (CSP) facilities. PV technology is considered as the preferred option in comparison to CSP as it is associated with limited water demand requirements and a lower visual profile.

DESCRIPTION OF THE ACTIVITIES TO BE UNDERTAKEN

Solar energy systems produce energy by converting photons "solar radiation" into electrons which then flow as electricity or heat. This process is referred to as the 'Photoelectric Effect'. Three types of solar panels are proposed and will be assessed in the Impact Assessment Phase for the Proposed Project. These include monocrystalline, polycrystalline, and thin film modules solar panels.

The main components of solar PV technology to be utilized for this project are provided in Table 1.

- An assessment of the potential biophysical, cultural, and socio-economic impacts of the project will be undertaken. The assessment will be informed by specialist and project team input and comments and concerns received from I&APs during the authorisation process. Mitigation and management measures to reduce potential negative impacts, and enhance positive impacts will be included as part of the findings of the EIA and EMPr;
- The EIA and EMPr will be made available for the public, the competent authority, and other relevant stakeholders during a review period comprising 30 calendar days;
- The EIA and EMPr will be updated with any comments raised during the review period and will be made available to the DMRE for decision making purposes; and
- I&APs will be informed of the DMRE's decision.




Figure 2: Regional setting




