It is defined as "primary processing" and triggers Activity 21 of Listing Notice 2 of the NEMA EIA Regulations, 2014, and the procedures as prescribed in regulations 21, 22, 23 and 24 of the NEMA EIA Regulations, 2014 has to be followed.

Response from Applicant:

Upon discussions with DMR the applicant decided to remove crushing and screening from the proposed mining method. The hard rock will therefore only be blasted, the loosened rock loaded onto trucks upon which it will be transported from site.

In the light of the change in mining procedure, the proposed activity does not trigger Listing Notice 2 and the Basic Assessment Process can continue.

The uThungulu District Municipality (UDM) responded with the following comments on the DBAR:

- Proof of notification is not satisfactory; the copy of a newspaper advert must be included in the report notifying all the interested and or
 affected parties (I&AP).
- Stockpiled topsoil awaiting the rehabilitation must be properly protected against soil erosion.
- Fuelling the tracked vehicles in the quarry due to logistics as indicated in the report may cause risk of contaminating the soil in any case that the spill has occurred.
- The river on the south of the quarry must not be disturbed in anyway, therefore it must remain a 'No-go area'.

Greenmined responded as followed to the comments of the UDM:

- The proposed project was advertised in the Zululand Observer on the 20th of February 2015. Proof of the newspaper advertisement was attached to the DBAR as Appendix E Proof of Public Participation Process on page 39 and 40. The project was further advertised through on-site notices that were placed at the entrance to the farm from the N2 as well as along the north-western boundary of the property along the provincial road passing the property. All stakeholders on the project was directly contacted and informed of the project by means of background information documents. Please see Appendix E of the DBAR for a full account with proof of the public participation process.
- The proposed management of topsoil during the site establishment / construction phase is discussed on page 8, 44 and 63 of the Draft Basic Assessment Report. In order to protect the topsoil against erosion and weed invasion it was proposed that the berm be vegetated should vegetation not establish naturally within 6 months of stockpiling. Your comment is thus supported and will be highlighted in the Final Basic Assessment Report.
- We take note of your concern and will add the following mitigation measures to the FBAR to address the matter:
 - o The diesel bowser needs to be equipped with a drip tray at all times.
 - o Drip trays have to be used during each and every refuelling event.
 - o The nozzle of the bowser needs to rest in a sleeve to prevent dripping after refuelling.
 - Site management must ensure drip trays are cleaned after each use. No dirty drip trays may be used on site.
 - All mining will be contained within the boundary of the proposed mining area and the river will not be disturbed in anyway. A
 condition will be added to the FBAR declaring the river a no-go area.
