



Dr Bothma distributed the attendance register for signature.

Mr Schlebusch displayed the preliminary plans compiled for the widening of the bridge. He explained that the reason for the widening of the bridge is that the current situation at the bridge is very dangerous as the bridge is currently narrower than the current road width. The bridge will therefore, be widened with 300m of road to accommodate wider traffic lanes and pedestrian sidewalks, $2 \times 3.7m$ lanes in each direction and 2.5m shoulders.

Mr Mashola enquired when construction will commence. Dr Bothma indicated that the project will only be able to go out on tender once the environmental authorisation is received from GDARD. Mr Schlebusch indicated that it is envisaged that construction will commence towards the end of 2017.

Dr Bothma indicated that a draft Basic Assessment report will be compiled once the public participation process is completed. The draft BAR report will then be submitted to the public for comment for a 30 day period. The final BAR will then be submitted to the GDARD for authorisation. She indicated that Mr Mashola will be kept up to date as to the progress of the environmental process.

Mr Mashola indicated that he supports the project.

Dr Bothma thanked them for the meeting and indicated that they can contact her for any additional questions or issues regarding the project.
