## INVITATION TO REGISTER, PARTICIPATE AND COMMENT ON THE ENVIRONMENTAL AUTHORISATION PROCESS

Notice is hereby given in terms of the Environmental Impact Assessment (EIA) Regulations, amended on 7 April 2017, promulgated in terms of the National Environmental Management Act, 1998 (Act No. 107 of 1998) (NEMA), that Kimberly Rehabilitation and Development (KRD) is applying for Environmental Authorisations (EAs) for the proposed "changing the face of a city" project in Kimberly, Northern Cape Province.

Proponent: Kimberley Rehabilitation and Development (KRD)

Location: The proposed project sites are located in and around Kimberly City in Sol Plaatje Local Municipality within the Frances Baard District Municipality, Northern Cape Province. The details of the affected properties are provided in Table 1.

#### ENVIRONMENTAL AUTHORISATION PROCESS:

The proposed project triggers activities listed in terms of Listing Notices 1 and Listing Notice 2 of the NEMA (Table 2) and will therefore require EAs from the Northern Cape Department of Environment and Nature Conservation (DENC). Government Notice Regulation (GNR) 326 of the NEMA stipulates that where only Listing Notice 1 is triggered (BMW, Colville, Vooruitzigt and St Augustine sites), a Basic Assessment process be followed and where both Listing Notice 1 and 2 activities are triggered (Roodepan Brick Making Site), a full Environmental Impact Assessment (EIA) including Scoping and Impact Assessment will be followed.

Listing Notice 2 (GNR 325): Activity 28 Commencing of an activity, which requires an atmospheric emission license in terms of Section 21 of the National Environmental Management: Air Quality Act, 2004 (Act No. 39 of 2004),

The proposed project will also require Water Use Authorisations (WUAs) from the Department of Water and Sanitation (Section 21 ( c), (i) and (g) for various water uses, permits for the destruction of heritage resources from the Northern Cape Provincial Heritage Resources Authority, Air Emissions licence (AEL) from Francis Baard District Municipality for brick making activities at the Roodepan Quarry and permits for the relocation of Vachellia erioloba (protected trees) from the DENC. KRD has appointed Ndi Geological Consulting Services (Pty) Ltd as the Independent Environmental Assessment Practitioner (EAP) to undertake the required EA applications and associated public participation processes for the proposed project. The EA applications will be submitted to the Competent Authority, the DENC. PUBLIC COMMENT INVITED:
