The development is listed in terms of Government Notice R544, Listing Notice 1 under Chapter 5 of the National Environment Management Act (Act No. 107 of 1998), and therefore requires an Basic Assessment to be undertaken. The activity falls under the following:

23 (ii)The transformation of undeveloped, vacant or derelict land to residential, retail, commercial, recreational, industrial or institutional use, outside an urban area and where the total area to be transformed is bigger than 1 hectare but less than 20ha.
