

BACKGROUND INFORMATION DOCUMENT FOR THE PROPOSED SU CASA BURIAL ESTATE ON FARM DOORNRUG 302 JS PORTION 10, IN EMALAHLENI MUNICIPALITY IN THE MPUMALANGA PROVINCE

Purpose of the document

The purpose of this document is to provide the public with information pertaining to the proposed Su Casa Burial Estate Project and afford them an opportunity to participate in the project.

Background and Motivation for the Project

Some of the existing cemetery sites in Emalahleni are reaching capacity and as a result Su Casa Burial Estate has proposed to develop a new burial site to provide the community with capacity for the future. Consequently, Eaglesage (Pty) Ltd has been appointed by Su Casa Burial Estate to undertake a Basic Assessment process and Water Use License Application and obtain the requisite authorisations prior to the development of the proposed Su Casa Burial Estate.

Project location

The proposed project is located on Farm Doornrug 302 JS Portion 10 in Emalahleni Municipality in the Mpumalanga Province. Refer to Appendix A for the locality map.

Project Scope

The proposed activities entail but are not limited to the Su Casa Burial site, chapel, dining hall, ablution facilities, admin offices, cross landmark, fencing, landscaping, ash scattering garden, upgrade of the existing borehole, establishment of a new borehole, establishment of two ponds, wall of remembrance and upgrade of the existing road.



In addition, the project will require authorisation in the form of a Water Use Licence or General Authorisation in terms of the National Water Act, 1998 (Act 36 of 1998).




