Agri Boereplaas het 'n behoeftige geïdentifiseer in opleiding en praktiese kennis by hul onderskeie plaswerkers en veral opkommende hoere.

Uit gesprekke en vergaderings is dit besluit om iets positiefs vir die hoeregemeenskap te doen. oogbehandeling, uitwendige en inwendige paraserbehandeling deur die toediening van opgrut middels is gekontrasterende noedeling van neuraal vergiftiging, 'n opgeblase buik en ander abdominale kwale deur 'n maagbuis in te plas asook die korrekte metode van onthoring. Die Departement van Landbou se Jerry Vermaak en van sy kollegas, asook verskeie plaaswerkers en huere van Amendoekvlakte het die dag bygewoon.

Dan is sertifikate oorhandig en na die tyd kon almal lekker saam kuier en eet.

"Die sertifikate betrekken geweldige baie vir ons werkers omdat baie van hulle nie kan lees en skryf nie. Die sertifikate kan ook gebruik word as 'n evidensie vir benodigd woorde vir toekoms," het Steyn hygevoeg. Agri Boereplaas besef dat dié tipe opleiding definitief moet voortgaan, sodat elkeen kan help 'grootskaal' aan die opkommende boere en sodien verskeker dat hulle en plaaswerkers bemagtig word. She was identified as a deserving case for an emergency house during the Bokone Bophirima provincial government intensive service delivery programme, Setsokotsane.



MEC Gaolaolwe encouraged other businesses to work with government to alleviate poverty and develop the lives of the impoverished.

Rachel Molamu the Director of the construction company won the best woman contractor in the provincial Govan Mbeki Awards said it was not an easy project as acquiring and delivering material was a hustle as well as getting skilled labour.

"The fact that I was ploughing back to a deserving family that keep on going, despite all these and many other challenges", said Molamu. Puleng who slept for the first in her new home couldn't stop thanking the donors and government.
