Background

Aurecon South Africa (Pty) Ltd was appointed by the City of Tshwane Metropolitan Municipality - Environmental Management Services Department to provide environmental services for the Basic Assessment (BA) for the proposed expansion of the existing cemetery site located on the Remainder of Portion 3 of the farm Sjambok Zyn Oude Kraal 258 JR in Ga-Rankuwa. The proposed site is currently operating as a cemetery; however, the existing cemetery has reached full capacity. The proposed area of expansion measures approximately 11.83 Ha.

Legal Requirements

The Environmental Impact Assessment Regulations, Regulation GN 983 of 2014, promulgated in terms of the National Environmental Management Act (NEMA), lists activities which may not commence without a BA process and environmental authorisation from the competent authority, in this case the Gauteng Department of Agriculture and Rural Development (GDARD).

The relevant listed activities read as follows:

• GN 983 of 2014, Activity 44: "The expansion of cemeteries by 2500 square metres or more".

What is a Basic Assessment?

A BA is a short environmental impact assessment process used to identify and assess potential negative and positive consequences of a proposed project and recommend ways to enhance positive impacts and to avoid or reduce negative impacts. The BA process will include:

- a) Stakeholder engagement;
- b) Assessment of current site conditions;
- c) A description of the proposed activity;
- d) Description of the environment which may be affected;
- e) Description of the need and desirability of the proposed activity and identification of alternatives.

Authority and stakeholder comment incorporation into documentation will occur between phases e) and f).

Process to be followed

The BA process as per the Environmental Impact Assessment Regulations 2014 is to be undertaken for this project. During this phase (which is currently running) it is usual to consult with:

- Relevant authorities at various levels;
- Relevant stakeholders;
- The proponent; and
- The public at large.

The following activities will be utilised to achieve the aforementioned objectives:

- Advertising on-site and in local newspapers (The Citizen and Noweto Rekord);
- Supplying all affected parties with the opportunity to comment and register; and
- Interested and Affected Party (I&AP) opportunity to comment of the Draft BA Report (BAR) prior to submission.

Once the authorisation has been received letters will be sent out notifying the registered I&APs of the authorisation and where it will be available to view.

Please note that some project details may change as engineering investigations proceed.






Figure 1: Locality map of the proposed Ga-Rankuwa cemetery expansion
