## 1. INTRODUCTION

The Public Participation Process (PPP) for this Basic Assessment Process will be undertaken in accordance with section 54 of NEMA and regulation 41 of the Environmental Impact Assessment Regulations (2014). The manner in which the Public Participation Process will be undertaken is outlined below in a Public Participation Plan as stipulated in the Directions regarding measures to address, prevent and combat the spread of Covid-19 relating to national environmental permits and licences (Government Notice No. 650 on 05 June 2020). In general, the public and relevant authorities and stakeholders will be notified on the proposed project in a manner that is line with the regulations issued in terms of section 27(2) of the Disaster management Act,2002 (Act no. 57 of 2002).

## 2. PUBLIC PARTICIPATION PROCESS

The means of notifying the Organs of State, Stakeholders and Interested and Affected Parties about the proposed development and commenting periods are described below.

### 2.1 Notification of Stakeholders And I&APS

Stakeholders (landowner and adjacent landowners) and I&APs will be directly informed of the proposed project through the distribution of a Background Information Document (BID) via email. Where it is not possible to inform Stakeholders and I&APs via email, a hardcopy of the BID will be delivered to them. At the initiation of the 30-day PPP the draft Basic Assessment Report (BAR) and a link to access the supporting documents will be sent to all Stakeholders and I&APs. The email will inform the Stakeholders and I&APs of the 30-day commenting period which is expected to open from **11 November 2021**. Where it is not possible to send electronic copies of the draft BAR to I&APs, a hard copy of the Pre-Application BAR will be placed at Bulhoek Farm (25°34'40.86"S; 26°54'28.60"E). Comment forms and a comments box will be provided where I&APs can submit their comments. I&APs will also be able to submit comments via email.

The landowner and adjacent landowners and their email addresses can be found in Appendix A. Potential I&APs identified, who will be notified during the first PPP, can also be found in Appendix A.

Stakeholders and I&APs will be requested to submit their comments for both commenting periods to the Environmental Assessment Practitioner via email or via the comments box that will be provided.

### 2.3 Notification of Governmental and Other Authorities

A number of Authorities and Organs of State will be directly informed, via email, of the proposed project. At the initiation of the 30-day PPP, the draft BAR, Background Information Document and a link to access supporting documentation will be distributed via email to all identified Authorities and Organs of State, informing them of the 30-day commenting period which is expected to open from **11 November 2021**. Authorities and Organs of State will be requested to submit their comments to the Environmental Assessment Practitioner via email.

## 2.5 Site Notices

The site notices will be placed in areas easily noticeable to the public, prior to the 30-day PPP's. Site notices will be placed on the boundary of the site as well as at two public locations. There will be no involvement with public during the site notice placements and the regulations issued in terms of section 27(2) of the Disaster management Act,2002 (Act no. 57 of 2002) will be adequately adhered to. The advert will provide the Listing Notice Activity triggered by the development, the dates of the commenting period and the EAPs contact details.

## 2.7 Comments and Responses during the Public Announcement of the Project

The EIA Regulations, 2017 specify that I&APs must have an opportunity to verify that their issues have been captured, through the inclusion of a Comments and Response Report (CRR) in the Draft and Final Basic Assessment Report. Comments received from I&APs will be included in a CRR.
