The Khai-Ma & Korana Wind Energy Facilities received Environmental Authorisations (EA's) on 28 May 2015 (DEA Ref.No. 14/12/16/3/3/2/680 and DEA Ref.No. 14/12/16/3/3/2/682). Subsequent to the EA's dated 28 May 2015, Amendments to the EA's for the extension of the validity period for both wind energy facilities were received on 06 June 2018 (DEA Ref.No. 14/12/16/3/3/2/680/AM1 & DEA Ref.No. 14/12/16/3/3/2/682/AM1). On the 10 March 2020 & 02 March 2020 respectively, amendments to the EA's were granted for changes in the turbine specifications for both wind energy facilities (DEA Ref.No. 14/12/16/3/3/2/680/AM2 and DEA Ref.No. 14/12/16/3/3/2/682/AM2).

The Korana Solar Energy facility received an Environmental Authorisation (EA) on the 19 May 2015 (DEA Ref No.: 14/12/16/3/3/2/683). Subsequent to the EA dated 19 May 2015, an Amendment to the EA for the extension of validity was received on the 07 June 2018 (DEA Ref No.: 14/12/16/3/3/2/683/AM1).

In the original Environmental Impact Assessment Reports dated 2015 for the wind energy facilities and the solar facility, two access road alternatives were proposed i.e. Alternative 1 (Namies Suid North) and Alternative 2 (Poortjies South).

• Alternative 1 (Namies Suid North) – This route is an existing gravel road which is approximately 49.5km long with an average width of about 7.5 m. For the Namies Suid North access adjustments to the width and vertical alignment will have to be undertaken before safe abnormal load access can be guaranteed. There are also sections through the proposed land parcels that may require widening to accommodate abnormal load access. Approximately 5.3 km of new road will have to be constructed within the site.

• Alternative 2 (Poortjies South) – This route is an existing gravel road that is approximately 63km long with an average width of about 10 m. The access road is longer but has a more suitable vertical and horizontal alignment for abnormal access. There is only one corner that may require horizontal re-alignment within the current road reserve.

Both Alternatives were assessed from a fauna, flora, hydrological, avifauna, bats, agricultural, visual, noise, archaeological and socio-economic perspective and both were deemed acceptable with a preference (at the time) being route Alternative 1. Upon review of the access road alternatives, South Africa Mainstream Renewable Power Developments (Pty) Ltd (hereafter referred to as the Developer) now wishes to amend the EA to reflect that Alternative 2 be the authorised access road alternative from a technical feasibility perspectiveThe Part 2 Amendment process notification for the Khai-Ma & Korana Wind Energy Facilities distributed on 13 July 2020 has reference.

Amendments to change the authorised access route from Alternative 1 (Namies Suid) to Alternative 2 (Poortjies South) is therefore being submitted to the Department of Environmental Affairs (DEA) for both wind energy facilities and the solar energy facility.

In order to verify the potential for a change in the impacts on biodiversity, noise, heritage and the aquatic environment, specialist input into the amendment motivation reports has been included.

Savannah Environmental was appointed as the independent environmental consultant to undertake the amendment application and to identify and assess all potential environmental impacts as well as compiling the Motivation reports and the required public participation process for the amendment applications.
