NOTIFICATION OF ENVIRONMENTAL BASIC ASSESSMENT

Relocation of a section of the 275 kV Eskom power line at Sishen Mine


The Sishen Iron Ore Company (SIOC) is in the process of relocating linear infrastructure, which currently runs through the Sishen Iron Ore Mine (Sishen Mine) property to the perimeter of their property. The relocation is necessary due to the continued progression of the opencast mine pit in a westerly and south-westerly direction. The infrastructure earmarked for relocation is not all mining-related and is owned and operated by a variety of stakeholders including Eskom, Transnet Limited, Sedibeng Water Board, SIOC and the Northern Cape Department of Roads and Public Works. SIOC has all the necessary environmental approvals in place and construction of the new infrastructure is underway, except for the relocation of the 275 kV Eskom power line.

An approximate 12 km section of the 275 kV power line will have to be relocated. The power line currently running north-south through the Sishen Mine property will be relocated within a 1 km wide corridor to which all the above mentioned linear infrastructure will eventually be relocated. Environmental authorisation (DEA Ref: 12/12/20/1436) was granted for the infrastructure corridor through a thorough environmental impact assessment (EIA) process in terms of the National Environmental Management Act (NEMA, No 107 of 1998) and the EIA Regulations (Government Notice Regulation (GNR) 386 and 387, published 21 April 2006) by the National Department of Environmental Affairs (DEA) in March 2010. Even though the relocation of a section of the 275 kV power line was not authorised per se, details regarding this activity were provided throughout the abovementioned EIA process and all potential impacts that might result from this activity were assessed.

Although an EIA is required for relocation of this power line in terms of the NEMA and the EIA Regulations (GNR 543 to 546, published 18 June 2010), a motivation for permission to downscale from a Scoping and EIA to a basic assessment (BA) process as permitted in terms of Section 20 (4) of the EIA Regulations, was approved by the DEA on 19 March 2013.

Background Information Document

Environmental basic assessment for the relocation of a section of the 275kV Eskom power line at Sishen Mine

NEAS Ref: DEA/EIA/0001735/2013

DEA Ref: 14/12/16/3/3/2/467

Sishen Iron Ore Mine (Sishen Mine, owned by the Sishen Iron Ore Company (SIOC), is one of the largest open pit mines in the world. It is situated in the north-eastern part of the Northern Cape Province, within the John Taolo Gaetsewe District Municipality and the Gamagara Local Municipality. It is located ~280 km northwest of Kimberley along the N14 national road between Vryburg and Upington. The towns in close proximity to Sishen Mine are Kathu (directly north-east), Dingleton (directly south-west), Sesheng (directly north) and Debeng (~21 km north-west).

PURPOSE OF DOCUMENT

This document forms part of the required public participation process for the project and serves to:

- Inform you as a potential interested or affected party (IAP) about the environmental basic assessment processes for the aforementioned project.
- Provide background information about this project.
- Present the purpose and methodology of an environmental BA.
- Describe opportunities for you to participate in the environmental BA processes, specifically the public participation process.

PROJECT DESCRIPTION

The Sishen Iron Ore Company (SIOC) is in the process of relocating linear infrastructure, which currently runs through the Sishen Iron Ore Mine property as part of the Sishen Western Expansion Project (SWEP). The relocation is necessary due to the continued progression of the opencast mine pit in a westerly and south-westerly direction. The infrastructure earmarked for relocation is not all mining-related and is owned and operated by a variety of stakeholders including Eskom, Transnet Limited, Sedibeng Water Board, SIOC and the Northern Cape Department of Roads and Public Works. SIOC has the necessary environmental approvals in place and construction of the new infrastructure is underway.

An Environmental impact assessment (EIA) process for the relocation of the rail and associated infrastructure was undertaken by Synergistics Environmental Services (Pty) Ltd during the course of 2008 and 2009 in order to authorise the relocation of the above mentioned linear infrastructure at Sishen Mine. The final EIA was submitted to the National Department of Environmental Affairs (DEA) at the end of 2009 and the environmental authorisation (DEA Reference: 12/12/20/1436) was granted in March 2010.

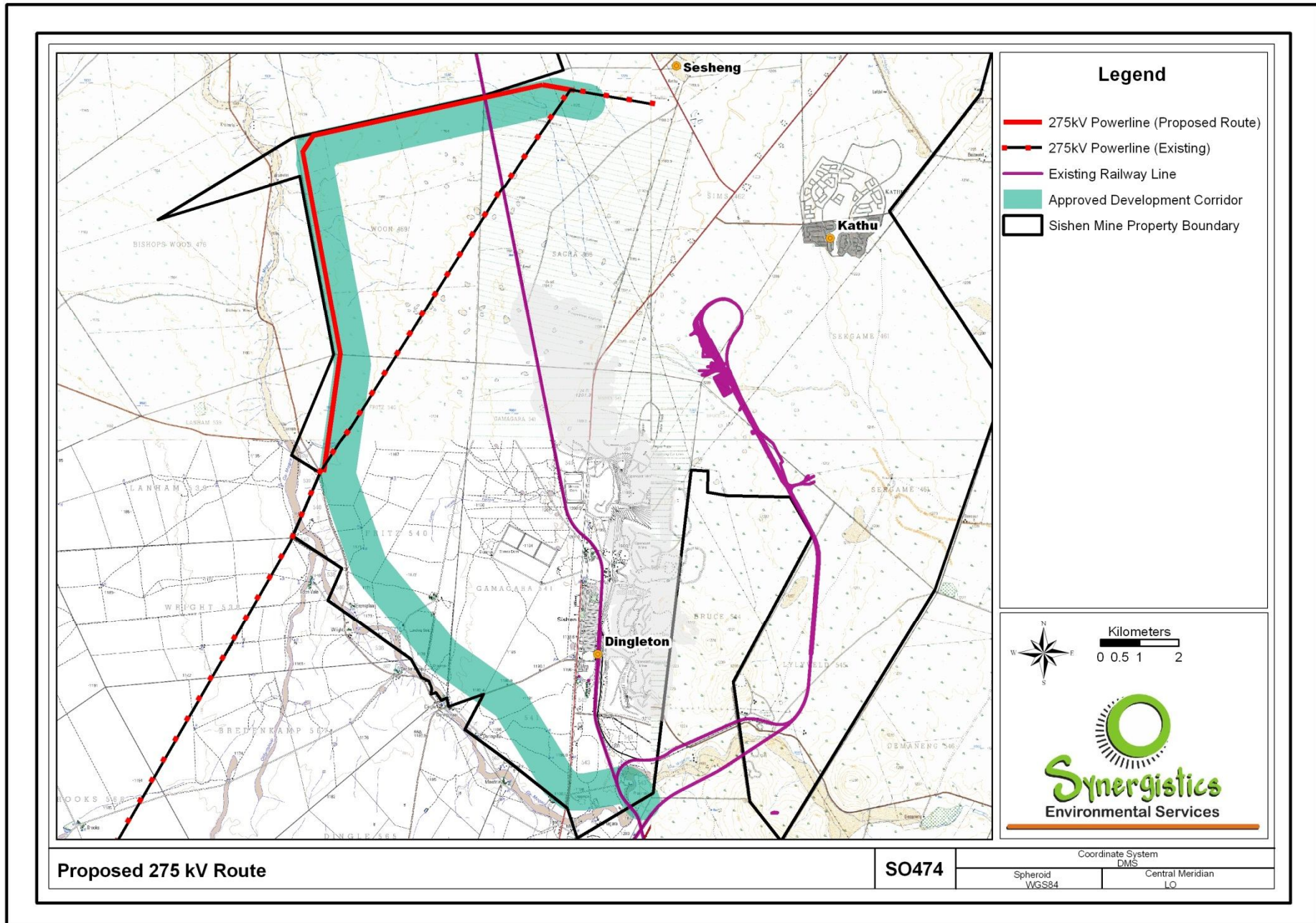


Figure 1: Location of the existing and proposed route for the ~12km section of the 275 kV power line to be relocated.

During this EIA process a ~1 km wide corridor to which all the linear infrastructure will be relocated was assessed in detail in order to determine the potential impacts of the relocation process – see Figure 1. Specialist studies were conducted on the infrastructure corridor and an environmental management programme (EMPr) and mitigation measures were identified. The EMPr also includes the conditions as set out by the DEA in the environmental authorisation granted to SIOC. Construction of relocated infrastructure is currently underway and provides for the implementation of the mitigation measures. All construction activities are also audited quarterly based on the conditions set out in the final EMPr. No major environmental incidents have been recorded and construction complies with the EMPr.

A ~12km section of the 275 kV Eskom power line running north – south through SIOC's property (see Figure 1) has to be relocated as part of the larger relocation process. The relocation of this section of the power line was not authorised in the environmental authorisation issued by the DEA in 2010. The SIOC has now taken on the responsibility to relocate the required section of power line on Eskom's behalf and requires environmental authorisation. The following properties will be affected by the relocation:

- Portion 1 of the Farm Sacha 468;
- Remaining Extent of the Farm Nooitgedacht 469;
- Portion 1 of the Farm Fritz 540; and
- Portion 5 of the Farm Fritz 540.

Even though the relocation of the section of the 275 kV power line was not authorised per se, details regarding this activity were provided and all the potential impacts that might result from this activity were assessed in the initial EIA as the construction of the relocated power line will take place within the authorised corridor. No additional impacts, other than those described in the EIA, are foreseen. In the EIA process the public was made aware of the details of this activity. The public was also informed that the relocation of this section of the 275 kV power line would take place as a future development.

Privately owned land will not be crossed or affected by the proposed power line route. Existing infrastructure and services that may be affected include farm roads and water furrows/canals, entirely owned by the SIOC.

Construction activities will involve clearing of natural vegetation and the establishment of contractor lay down areas along the power line route.

The relocation of the section of the 275 kV power line triggers, among others, Activity 8 of Listing Notice 2 of the Environmental impact assessment Regulations, 2010 (Government Notice Regulation (GNR) 545). In terms of the EIA Regulations (2010), a scoping and EIA process is required in order to obtain Environmental authorisation for such an activity.

However, the impacts that may result from this activity have been assessed in the EIA as the construction the new power line will take place solely within the approved corridor which is already disturbed through the relocation of the approved linear infrastructure. Therefore a motivation for permission to downscale from a Scoping and EIA to a BA process in terms of the EIA Regulations as permitted by Section 20 (4) was submitted to the DEA and approved on 19 March 2013.

ENVIRONMENTAL LEGAL PROCESSES

EIA regulations have been published GNR 543 to 546 in terms of the National Environmental Management Act (No 107 of 1998) as amended (NEMA). Activities listed in the EIA regulations require authorisation from the National DEA prior to commencement. A BA process is required in support of the application for authorisation.

The table below indicates the activities to be undertaken that require authorisation in terms of the EIA Regulations.

PROJECT LOCATION AND LAYOUT

ENVIRONMENTAL AUTHORISATION PROCESS

An EIA process for the relocation of rail and associated infrastructure at Sishen Mine was initiated in 2008. The process included a thorough public participation process of the relocation of the following infrastructure at the Sishen Mine:

Rail and Associated Infrastructure

- A section of the Postmasburg-Hotazel Transnet freight railway line;
- A section of the Sishen Lylyveld rail turnout to Sishen load-out stations
- Associated infrastructure displaced by relocation of the railway lines:
 - Two Transnet traction substations,
 - Two 132 kV Eskom power lines to supply the traction substations,
 - A section of the Dingleton-Debeng public gravel road (for the western route option of the Postmasburg-Hotazel railway line).

Power lines (not associated with rail infrastructure)

- Eskom power lines:
 - **A section of the 275 kV Eskom power line,**
 - A section of the 400 kV Eskom servitude.
- Sishen Mine internal power lines:
 - Relocation of a 66kV Power line and the Bruce Sub-station.

Water Pipeline

- A section of the Vaal-Gamagara water pipeline.

The project components listed above are not all mining-related and are owned and operated by a variety of stakeholders, as mentioned.

Due to the involvement of different stakeholders and implementation timeframes for the individual project

components, the applications for environmental authorisation had to be split into separate applications of which numerous have been completed.

This document covers the BA for the relocation of a section of the 275 kV Eskom power line.

Basic Assessment

A BA process is a confined environmental analysis of proposed activities, but on a smaller scale, and with less significant and easy manageable environmental impacts. Although a Basic Assessment Report (BAR) comprises less detail than a thorough EIA, it still requires: a complete public participation process; the consideration of potential impacts due to the proposed activity; the assessment of possible mitigation measures; and an assessment to whether any significant issues should be investigated further.

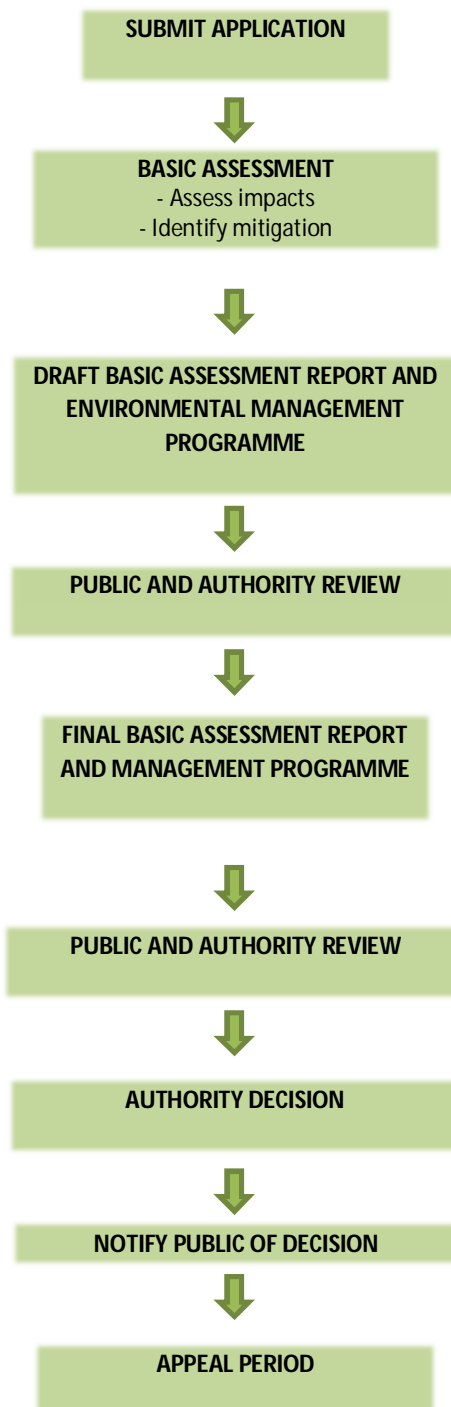
Specialist studies were conducted as part of the EIA process for the Rail and Associated Infrastructure on the infrastructure corridor and an EMP_r and mitigation measures were accordingly set in place. The impact assessment and mitigation measures for the proposed relocation of a section of the 275 kV Eskom Power line will be based on the findings from the above mentioned EIA.

The findings of the impact assessment and the proposed measures identified to mitigate such impacts will be documented in a BAR. The draft report and final report will be made available for public comment.

Environmental Management Programme

An activity and project specific EMP_r will be developed aimed at addressing impacts identified and reducing risks to acceptable levels.

ENVIRONMENTAL AUTHORISATION PROCESS



The enclosed background information document (BID) provides more information regarding the proposed relocation project.

Notification is hereby given that Eskom is applying for environmental authorisation from the DEA in terms of the National Environmental Management Act (No 107 of 1998) and the EIA Regulations (NEAS Ref: DEA/EIA/0001735/2013, DEA Ref: 14/12/16/3/3/2/467).

In accordance with the EIA Regulations, the draft basic assessment report (BAR) will be submitted to the DEA. At the same time it will be made available for review by the public, relevant organs of state and other government departments for a period of 40 days.

The public review period will be **mid May 2013**. Further correspondence will provide specific review dates. Thereafter the reports will be updated and resubmitted to the registered interested and affected parties (IAP's) and to the DEA as the final BAR. Hervestiging van 'n gedeelte van die 275 kV Eskom kraglyn by Sishen Myn

Die Sishen Ystererts Maatskappy (SIOC) is in die proses om liniêre infrastruktuur te hervestig wat huidiglik deur die middel van hul eiendom by die Sishen Myn strek na die grens van hul eiendom deur middel van 'n projek wat bekend staan as die Sishen Westelike Uitbreidingsprojek (SWEP). Die hervestiging is nodig as gevolg van die voortgesette vordering van die oopgroef-steenkoolmyn in 'n westelike en suid-westelike rigting. Die infrastruktuur wat hervestig moet word is nie almal aan die myn verwant nie en word besit en bedryf deur verskeie rolspelers soos Eskom, Transnet Beperk, Sedibeng Water Raad, SIOC en die Noord-Kaapse Departement van Paaie en Openbare Werke. SIOC het al die nodige omgewingsmagtigings in plek en die konstruksie van die nuwe infrastruktuur is reeds onderweg behalwe die hervestiging van die gedeelte van die 275 kV Eskom kraglyn.

'n Gedeelte van ongeveer 12 km van die 275 kV kraglyn sal verskuif moet word. Die kraglyn wat tans noord-suid deur die Sishen-myn eiendom strek sal verskuif word na 'n 1 km breë korridor waarna al die bogenoemde liniêre infrastruktuur uiteindelik verskuif sal word. Omgewingsmagtiging (DEA Verw: 12/12/20/1436) is deur middel van 'n deeglike omgewingsimpakstudie (EIA) proses toegedien vir die infrastruktuur korridor in Maart 2010 deur die Nasionale Departement van Omgewingsake (DEA). Die proses was onderneem in terme van die Wet op Nasionale Omgewingsbestuur (NEMA, No 107 van 1998) en die EIA-regulasies (Goewermentskennisgewing Verordening (GNR) 386 en 387, gepubliseer 21 April 2006). Al is die hervestiging van die gedeelte van die 275 kV kraglyn nie wetlik goedgekeur nie, is besonderhede oor hierdie aktiwiteit verskaf en al die potensiële impakte wat mag voortspruit uit hierdie aktiwiteit ondersoek gedurende die bogenoemde EIA-proses.

Hoewel 'n EIA vereis word vir die hervestiging van hierdie kraglyn in terme van die NEMA en die EIA Regulasies (GNR 543-546, gepubliseer 18 Junie 2010), is 'n motivering vir toestemming om af te skaal van 'n omvangsbepaling en EIA-proses na 'n basiese assessering (BA) proses soos toegelaat in terme van Artikel 20 (4) van die EIA Regulasies ingedien. Die aansoek is goedgekeur deur die Nasionale Departement van Omgewingsake (DEA) op 19 Maart 2013.

Hiermee word kennis gegee dat Eskom 'n BA aansoek ingedien het vir die hervestiging van 'n gedeelte van die 275 kV kraglyn aan die DEA as die bevoegde owerheid (NEAS Ref: DEA/EIA/0001735/2013, DEA Ref:14/12/16/3/3/2/467).

Die gepaardgaande agtergrond inligtingsdokument verskaf meer inligting rakende die voorgestelde hervestigingsprojek.

Hiermee word kennis gegee dat Eskom aansoek doen vir omgewingsmagtiging by die DEA in terme van die Wet op Nasionale Omgewingsbestuur (Wet Nr 107 van 1998) en die EIA Regulasies (NEAS Ref: DEA/EIA/0001735/2013, DEA Ref: 14/12/ 16/3/3/2/467).

Sishen Ystererts Myn (Sishen Myn), wat deur die Sishen Ystererts Maatskappy (SIOC) besit word, is een van die grootste oopgroefmyne in die wêreld. Dit is geleë in die noord-oostelike deel van die Noord-Kaap Provinsie in die John Taolo Gaetsewe Distriksmunisipaliteit en die Gamagara Plaaslike Munisipaliteit. Dit is geleë ongeveer ~280 km noordwes van Kimberley langs die N14 nasionale pad tussen Vryburg en Upington. Die dorpe in die nabyheid van Sishen Myn is Kathu (direk noord-oos), Dingleton (direk suid-wes), Sesheng (direk noord) en Debeng (~21 km noord-wes).

Gedurende hierdie EIA-proses is 'n ~1 km wye korridor, waarna al die liniêre infrastruktuur hervestig sal word, noukeurig ondersoek ten einde die potensiële impak van die hervestigingsproses te bepaal (sien Figuur 1). Spesialis studies is uitgevoer op die infrastruktuur korridor en 'n omgewingsbestuursprogram (EMPr) en versagtende maatreëls is geïdentifiseer. Die EMPr sluit ook die voorwaardes in soos uiteengesit deur die DEA in die omgewingsmagtiging toegestaan aan SIOC. Konstruksie van die hervestigde infrastruktuur is tans onderweg en maak voorsiening vir die implementering van die versagtende maatreëls. Alle konstruksie aktiwiteite word ook kwartaallikse geoudit, gebaseer op die voorwaardes uiteengesit in die finale EMPr. Geen noemenswaardige omgewingsvoorvalle is tot op datum aangeteken nie en konstruksie aktiwiteite voldoen aan die EMPr.

'n ~12 km gedeelte van die 275 kV Eskom kraglyn wat noord - suid deur SIOC se eiendom strek (sien Figuur 1) moet hervestig word as deel van die grootter hervestigingsproses. Die hervestiging van hierdie gedeelte van die kraglyn is nie goedgekeur in die omgewingsmagtiging uitgereik deur die DEA in 2010 nie. Die SIOC neem nou verantwoordelikheid om die nodige gedeelte van die kraglyn namens Eskom te hervestig en dit vereis omgewingsmagtiging. Die volgende eiendomme sal beïnvloed word deur die hervestiging:

- Gedeelte 1 van die Plaas Sacha 468;
- Restant van die Plaas Nooitgedacht 469;
- Gedeelte 1 van die Plaas Fritz 540; and
- Gedeelte 5 van die Plaas Fritz 540.

Al is die hervestiging van die gedeelte van die 275 kV kraglyn nie wetlik goedgekeur nie, is besonderhede oor hierdie aktiwiteit verskaf en al die potensiële impakte wat mag voortspruit uit hierdie aktiwiteit ondersoek gedurende die aanvanklike EIA. Die rede hiervoor is dat die konstruksie van die gedeelte van die kraglyn wat hervestig gaan word gaan plaasvind alleenlik binne die goedgekeurde korridor. Geen addisionele impakte, anders as dié soos beskryf in die EIA, word voorsien nie. Gedurende die EIA-proses was die publiek bewus gemaak van die besonderhede van hierdie aktiwiteit. Die publiek is ook in kennis gestel dat die hervestiging van hierdie gedeelte van die 275 kV kraglyn sal plaasvind as 'n toekomstige ontwikkeling.

Grond in privaat besit sal nie gekruis of geaffekteer word deur die voorgestelde kraglyn roete nie. Bestaande infrastruktuur en dienste wat beïnvloed kan word sluit in plaaspaaie en watervore / kanale wat geheel en al besit word deur die SIOC.

Konstruksie-aktiwiteite sal die verwydering van natuurlike plantegroei en die vestiging van die kontrakteur storingsareas langs die kraglyn roete behels.

In terme van die EIA Regulasies (2010), word 'n omvangsbepaling en EIA-proses vereis ten einde omgewingsmagtigting te verkry vir die hervestiging van die gedeelte van die 275 kV kraglyn, siende dat dit aanleiding gee tot Aktiwiteit 8 van die Goewermentskennisgewing Verordening (GNR) 545.

Die impakte wat mag voortspruit uit hierdie aktiwiteit is reeds geassesseer gedurende die EIA vir die hervestiging van die spoor-en verwante infrastruktuur, siende dat die konstruksie van die nuwe kraglyn slegs binne die goedgekeurde korridor sal plaasvind. Die korridor is reeds versteur deur die hervestiging van die goedgekeurde lineêre infrastruktuur. Dus is 'n motivering vir toestemming om af te skaal vanaf 'n omvangsbepaling en EIA na slegs 'n BA proses in terme van Artikel 20 (4) van die EIA-regulasies, is aan die DEA voorgelê en is goedgekeur op 19 Maart 2013.

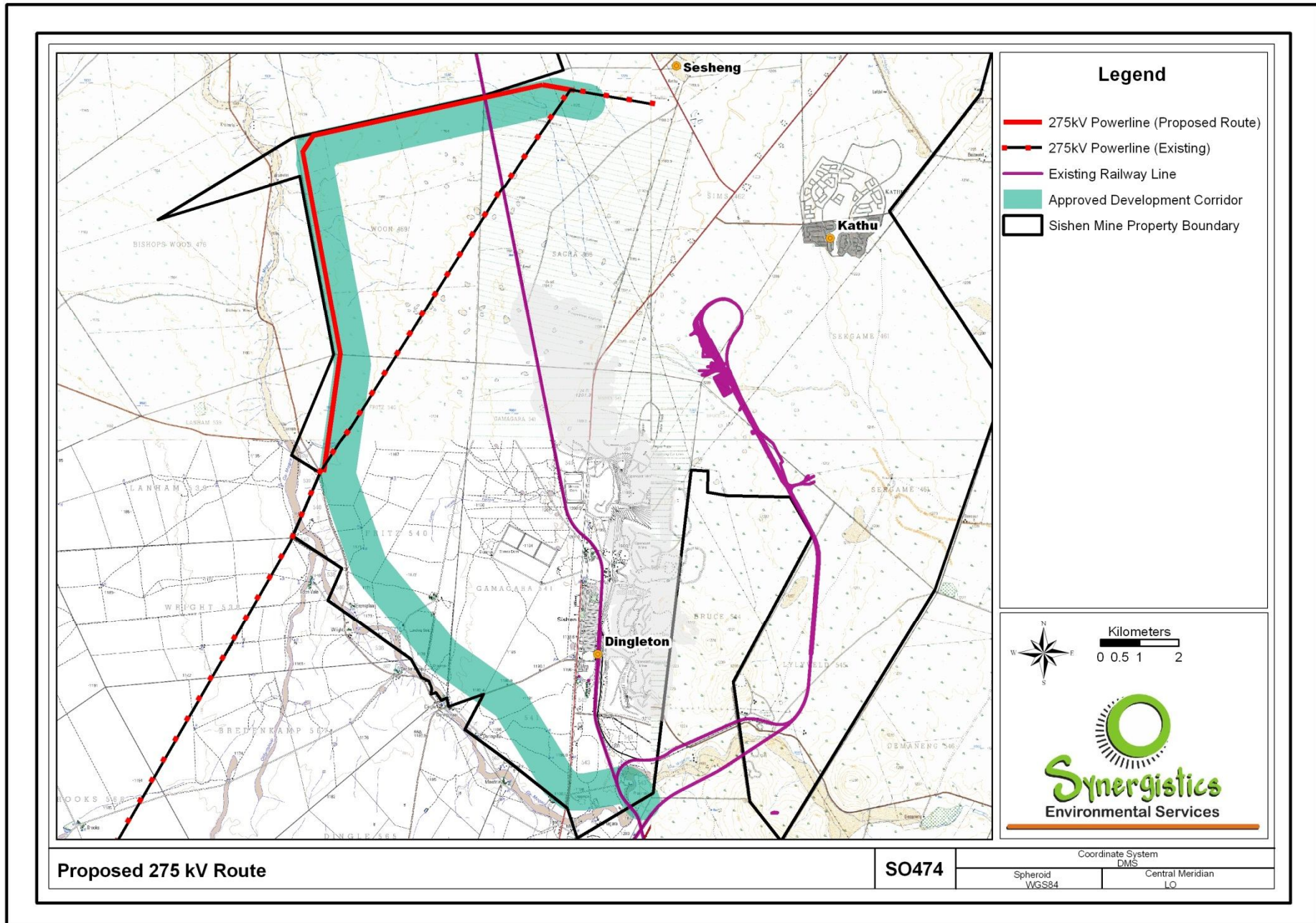

As gevolg van die betrokkenheid van die verskillende belanghebbendes en implementeringstydraamwerk vir

die individuele projek komponente, was die aansoeke vir omgewingsmagtiging verdeel in aparte aansoeke waarvan talle reeds afgehandel is.

Hierdie dokument dek die BA vir die hervestiging van 'n gedeelte van die 275 kV Eskom kraglyn.

Basiese Assessering

'n BA proses is 'n beperkte omgewingsanalise van voorgestelde aktiwiteite, maar op 'n kleiner skaal, en met minder belangrike en maklik hanteerbare omgewingsimpakte. Hoewel 'n basiese assesseringsverslag (BAR) uit minder besonderhede bestaan as 'n volledige EIA, vereis dit egter steeds 'n volledige publieke deelname proses, die oorweging van die potensiële impakte as gevolg van die voorgestelde aktiwiteit, die beoordeling van moontlike versagtende maatreëls en 'n assessering of enige belangrike kwessies verder ondersoek moet word.

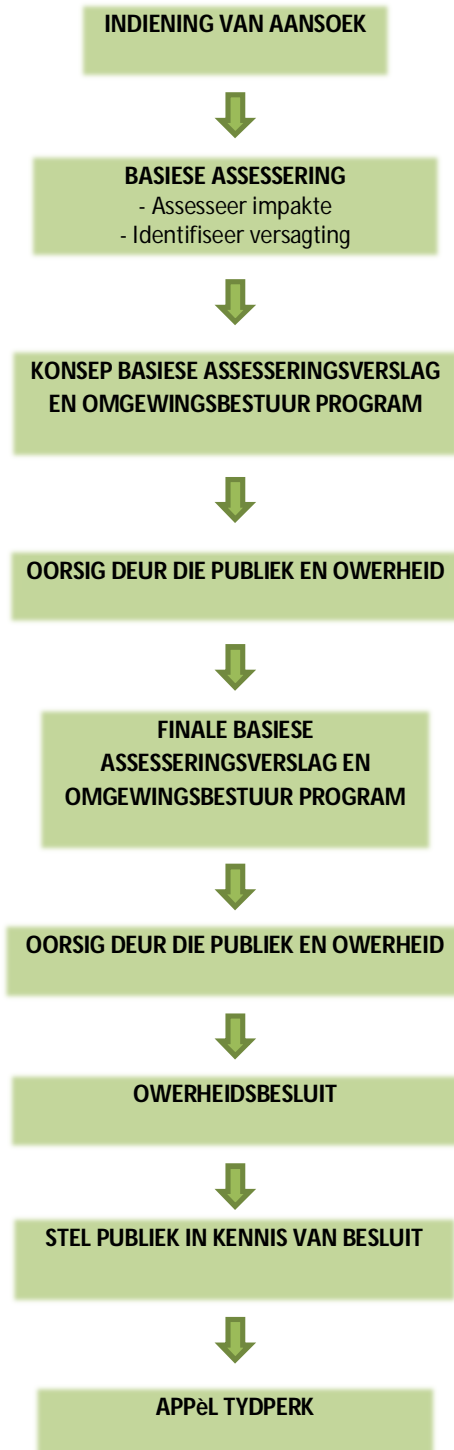

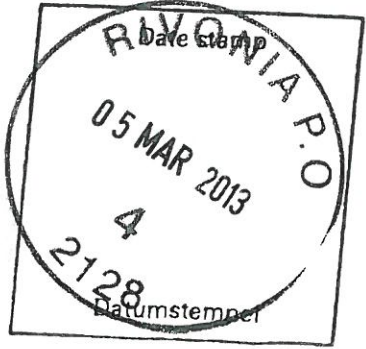

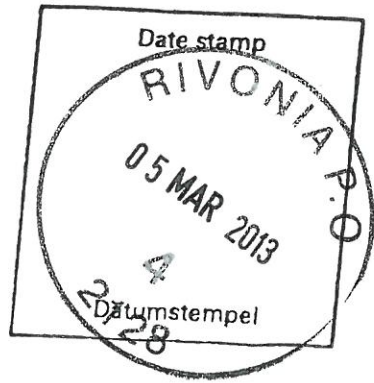

Relocation of a section of the 275 kV Eskom power line at Sishen Mine

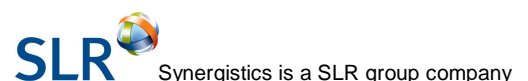
The Sishen Iron Ore Company (SIOC) is in the process of relocating linear infrastructure, which currently runs through the Sishen Iron Ore Mine (Sishen Mine) property to the perimeter of their property. The relocation is necessary due to the continued progression of the opencast mine pit in a westerly and south-westerly direction. The infrastructure earmarked for relocation is not all mining-related and is owned and operated by a variety of stakeholders including Eskom, Transnet Limited, Sedibeng Water Board, SIOC and the Northern Cape Department of Roads and Public Works. SIOC has all the necessary environmental approvals in place and construction of the new infrastructure is underway, except for the relocation of the 275 kV Eskom power line.

An approximate 12 km section of the 275 kV power line will have to be relocated. The power line currently running north-south through the Sishen Mine property will be relocated within a 1 km wide corridor to which all the above mentioned linear infrastructure will eventually be relocated. Environmental authorisation (DEA Ref: 12/12/20/1436) was granted for the infrastructure corridor through a thorough environmental impact assessment (EIA) process in terms of the National Environmental Management Act (NEMA, No 107 of 1998) and the EIA Regulations (Government Notice Regulation (GNR) 386 and 387, published 21 April 2006) by the National Department of Environmental Affairs (DEA) in March 2010. Even though the relocation of a section of the 275 kV power line was not authorised per se, details regarding this activity were provided throughout the abovementioned EIA process and all potential impacts that might result from this activity were assessed.

Eskom, the applicant, has applied for environmental authorisation from the DEA in terms of the National Environmental Management Act (No 107 of 1998) and the EIA Regulations (2010). The application was accepted by the DEA on 19 February 2013.

Although an EIA is required for relocation of this power line in terms of the NEMA and the EIA Regulations (GNR 543 to 546, published 18 June 2010), a motivation for permission to downscale from a Scoping and EIA to a basic assessment (BA) process as permitted in terms of Section 20 (4) of the EIA Regulations, was approved by the DEA on 19 March 2013.

The proposed project was announced in March 2013 with the distribution of notification letters and a background information document.

The draft BA report has been prepared in terms of the EIA Regulations (2010). In accordance with the EIA Regulations, the draft BA report will be submitted to the DEA. At the same time it will be made available for review by the public, relevant organs of state and other government departments for a period of 40 days.

The public review period will be from **19 September until 31 October 2013**. The reports will be available for review at the following locations:

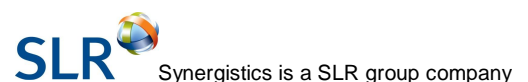
