MA, TWEE KINDERS IN KAMER VERGAS

Centurion-vrou 'het dalk lank beplan'

Verslagspan

Die familie en vriende van 'n "gelukkige en opgeruimde" ma van Centurion probeer nog tot verhaal kom nadat sy vermoedelik eers haar twee jong kinders en toe ook haarself in die slaapkamer van hul huis op 'n landgoed in Wierdapark om die lewe gebring het.

Billie-Jean Joubert (40) het vermoedelik tussen Saterdag- en Sondagoggend eers haar twee kinders, Dylan (Bear) (6) en Robyn (4), en toe haarself in 'n slaapkamer van hul huis op die Wierda Glenlandgoed vergas.

'n Familielid, wat ook lid van die plaaslike gemeenskapspolisieringsforum (GPF) is, het eers Maandagoggend op die gesin se lyke afgekom nadat niemand hulle sedert Saterdagoggend in die hande kon kry nie.

Kol. Dimakatso Nevhuwuli, polisiewoordvoerder in Gauteng, het die voorval gister aan Netwerk24 bevestig.

Volgens haar is 'n selfdoodbrief op die toneel gevind. Sy het bevestig die ma en haar kinders se lyke is Maandag saam ontdek.

"Die vermoede is dat die slagoffers gas ingesam het wat opsetlik toegedien is," sê Nevhuwuli.

Intussen worstel haar geliefdes met die trauma en baie "onbeantwoorde vrae".

'n Familielid wat verkies om anonimiteit te bly, sê dit wil voorkom asof die ma die treurspel "al 'n baie lang tyd" beplan het. Die familiebron bevestig Bil-

lie-Jean se man, Deon (37), is in Maart 2020 aan kanker oorlede.

Joubert was die eienaar van die drukkersonderneming Honey Hive Printing, wat sy drie jaar gelede kort ná Deon se dood op die been gebring het.

Sy het die Vrydag voor haar en die kinders se dood nog met kliënte op haar onderneming se Facebook-blad geskakel en foto's van 'n T-hemde geadverteer.

Die familielid sê hulle is "self nie 100% seker" presies wanneer hulle dood is nie, maar dit het vermoedelik tussen Saterdagoggend en Sondagoggend gebeur.

Niemand het vooraf enige onraad vermoed nie.

"Ons was almal baie na aan haar, ook aan haar kinders.

Daar is nog baie verwarring, woede... Daar is baie om te verwerk."

Hy vertel hulle glo nou sy het nooit haar man se dood verwerk nie, al het dit so voorgekom. "Ons vermoed dit is hoekom sy dit verwerk het. Daar is briewe wat sy aan sekere mense geskryf het."

Die familie moes vandag nog deur alles gaan, vertel hy.

Die plaaslike koerant Rekord Centurion het destyds berig Deon is in Januarie 2019 met fase 4 metastatische melanoom gediagnoseer nadat 'n gewas in sy brein ontdek is. Die kanker het ook na sy longe versprei.

Deon en Billie-Jean was 'n skoolleefde, wat al in 1998 begin uitgaan het, nadat hulle by die

Sutherland High School in Centurion op 'n Valentynsdans op mekaar verlief geraak het.

Volgens die familielid het die dood van Joubert se man haar aanvanklik swaar getref, maar hulle was onder die indruk dat sy dit verwerk het.

"Sy het glad nie die laaste tyd depressief voorgekom nie. Sy het Deon se dood baie sleg gevat, maar merkwaardig genoeg het sy alles daarna goed hanteer. Almal was onder die indruk dat sy baie beter begin vaar. Sy het begin staptogte doen. Sy het selfs weer iemand ontmoet. Die lewe het rooskleurig gelyk. Daar was geen aanduiding dat enigiets fout was nie..."

Die familie verstaan nie hoe-

kom sy dit doen het nie. Nicolene Muller, Bear (soos hulle Dylan geken het) en Robyn se voormalige dagsorgmoeder, vertel die boetie en sussie was albei lank in haar sorg.

Sy sê Bear was ten tyde van die treurspel in gr. 1 aan die Springvale Primary School en Robyn was in die Little Village Christian-kleuterskool.

"Hulle was fantastiese kinders. Baie gelukkig. Ek het nooit enige probleme opgemerk nie. Hulle was altyd baie goed versorg."

Muller het Joubert 'n geskenk vir haar kind se verjaardag gebring het - 'n sweetpakkie met oulike drukwerk op.

"Sy was 'n fantastiese ma. Ons het die dag nog gelag en gesels," vertel Muller.

Die vermoede bestaan dat Joubert eerste die kinders doodgemaak het en toe "hulle weg is", haarself ook om die lewe gebring het.

Daar is glo kannettjies gas op die toneel gekry. "Sy was 'n baie opgeruimde mens. Sy was altyd die life of the party. Sy was ook baie erg oor haar kinders. Daar was geen teken daarvan dat sy daaraan gedink het om so iets te doen nie."

'n Familiewoordvoerder het namens Joubert se familie gister vir Netwerk24 gevra om asseblief die familie se privaatheid te respekteer.

"Niemand van ons het nog al die feite nie," het hy gesê.

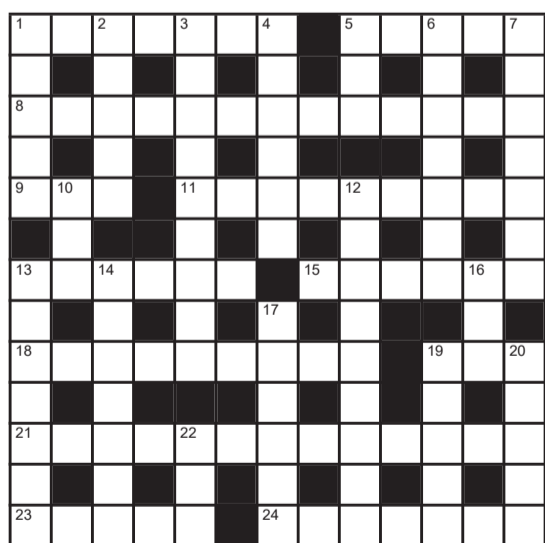

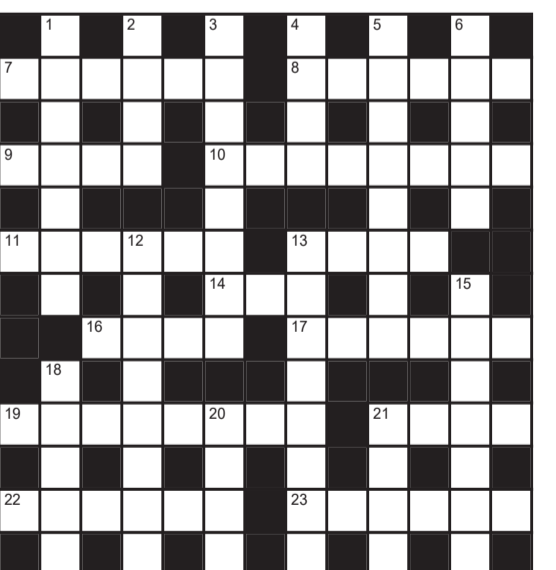
