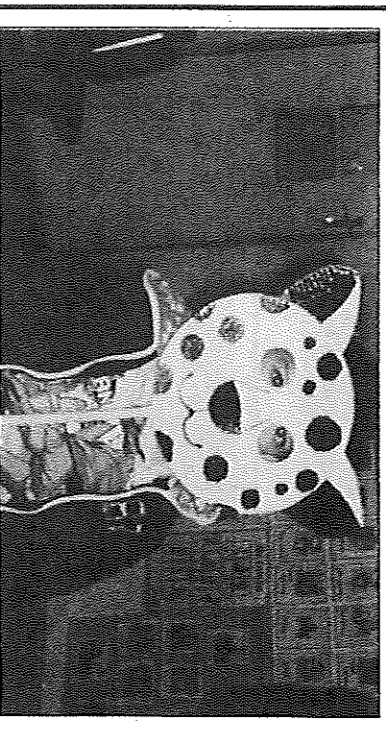

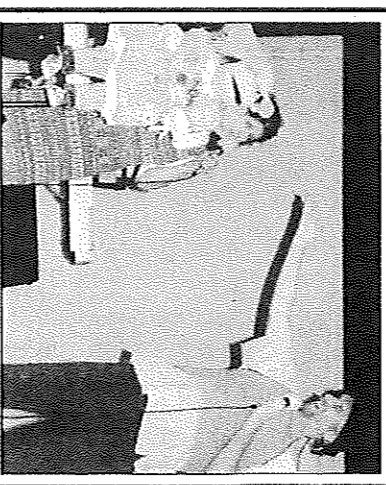

MOONOO! - Entries are awaited for the exciting Face of Grace competition that will be held on 3 November at Elandskraal Primary School in Moonoo!

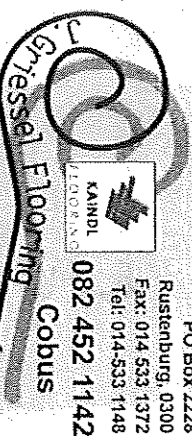
