SITE INSPECTION REPORT FOR PROPOSED TOWNSHIP ESTABLISHMENT ON PORTION 385 OF THE FARM WATERKLOOF 305JQ, RUSTENBURG

DATE: 16/11/2012

1.BACKGROUND INFORMATION REGARDING THE ACTIVITY

A township establishment is proposed on portion 385 of farm Waterkloof 305JQ Rustenburg in the North West Province. As part of the EIA Process, a flora and fauna specialist study is required to indicate what the potential impacts of the proposed development will be on the current biodiversity if the project proceeds. From the identified impacts, mitigation can be suggested to reduce the significance of the negative impacts. This is also relevant to the visual/aesthetic impacts as vegetation will be removed and the project area is located on a sloped topography. Department of Agriculture, Forestry and Fisheries registered as interested and affected stakeholder with the main aim to make sure the development comply with the National Forest Act, 84 of 1998 as amended administered by the department of agriculture, forestry and fisheries.

2. THE LEGISLATIVE MANDATE

- The National Forest Act of 1998 (as amended) provides the strongest and most comprehensive legislative mandate for the protection of trees and all natural forests in South Africa
- Natural forest and woodlands form an important part of the environment and need to be conserved and developed according to the principles of sustainable management
- The National Forest Act also recognize that the constitutional rights-stipulate that everyone has the right to the environment protected for the benefit of present and future generations

3. THE PURPOSE OF THE NATIONAL FOREST ACT

- Sustainable management of forests and woodlands for the benefit of all
- Create conditions necessary to restructure forestry in state forests
- Provides special measures for the protection of certain forest and trees
- Promote sustainable use of forests for environmental, economic, educational, cultural, health and spiritual purposes.
- Promote community forestry
- Promotes greater participation in all aspects of forestry and the forest products industry by disadvantaged by unfair discrimination.

4. LOCATION OF THE ACTIVITY

The proposed township establishment will be on portion 385 the farm Waterkloof 305JQ, Rustenburg North West province. The proposed portion of land is situated approximately 6,5km south from Rustenburg Central Business District on the Dinie Road between the R24 just before the Waterfall Mall driving into Rustenburg from Magalies/ Johannesburg The farm portion is bordered by agricultural homestead, natural areas and commercial businesses

5. STAKEHOLDERS INVOLVED IN SITE VISIT

Mr Nevhufumba Lufuno representing Agriculture, Forestry and Fisheries and Ms Paulette from Hydro science Independent Environmental Assessment Practitioner.

6. PURPOSE OF THE SITE VISIT

The purpose of the site visit was to check the vegetation that would be affected by development and if within the development site is there any trees protected in terms of the National Forest Act, 84 of 1998

7. INFORMATION GATHERED

There are various types of indigenous like Acacia caffra, acacia karoo , eragrosticis and exotic species in form of jacaranda mimosifolia, melia azedarach and eucalyptus species. On the entrance to the proposed site there are structures like old hotel, camping tents, residential houses, shops and gardens. Within the site proposed for development there are structures like old hotel, camping tents, residential houses, shops and gardens. The area start next to the road and extend towards the foot of the hill however according to Paulette the area next to the foot of the hill will not be developed meaning the vegetation would not be removed. Within the proposed site as you move towards the foot of the hill next to one of the structure/ house there is one big Marula tree and is protected according to the National Forest Act, 84 of 1998.

8. CONCLUSION

I would to conclude by mentioning that if the identified marula tree will be disturbed an application form should be sent to the office of the Department Of Agriculture and Forestry and Fisheries in order for a permit to be issued as required by the National Forest Act 84 of 1998 as amended. I would also suggest that trees are important for their services to the people so during development those trees that are valuable may be left whereas other option would be replanting trees for various purposes.

Good day Lufuno

We would like to thank you for conducting the site visits with us, for your prompt response and valuable input.

Please find attached the property boundary for the Marula Residential Development (NWP/EIA/52/2012). From this image you will find that the Marulas found on the road entering the proposed site are outside the project area and will not be affected by this development. Also the Marula found in the garden area of the wedding venue will remain unaffected. We will confirm this once we receive a layout plan from the developers and will then send this to you.

The Braun-Blanquet sampling method was used during vegetation surveys for all three projects, whereby vegetation is stratified by means of aerial/satellite imagery with physiognomic characteristics as a first approximation. Representative areas within these stratifications are then surveyed by means of line-point transects for grasses, sedges and forbs, as well as belt transects for shrubs and trees. With this method once I identify the communities on a satellite image, I try to focus my transects in areas that have more dense vegetation and are less likely to be disturbed. These areas are usually where I find our valuable protected species but in this case Marulas were found in the more disturbed areas of all three project areas which was not covered by my transects. This unfortunately is a limitation of transect surveys.

I have recommended to Paulette that in future I will include a map in my reports indicating my transects, this way we can perhaps identify other areas of concern and cover all bases. We will require permits for both the Waterkloof 65 and 501 (NWP/EIA/23/2012) and Waterkloof 385 Cynthiana (NWP/EIA/72/2012) projects.

Also it will be a privilege if you join me on one of my surveys. Paulette specifically mentioned the Kroondal N4 project. I will make arrangements in this regard with you in the new year as soon as I return from my maternity leave.

I am responding to everybody in one email as many of you have the same concerns. I trust you find this in order. Thank you for your input.

Registration: I have registered everybody (Jabes, BP, Shell, Engen) as interested and affected parties on this project. This means your objections, concerns and contributions have been incorporated into the reports which will be submitted as part of this project for consideration by the North West Department of Economic Development, Environment, Conservation and Tourism (NW DEDECT) in terms of the decision they have to make. Your actual communication will also be included as appendices to these reports. You will further be informed of progress and new information on the project.

The following concerns/comments and reasons for objection have been noted:

Existing filling stations in area fulfilling the demand: There are already 5 existing operational filling stations over a distance of 15 km on the R24 between Olifantsnek and the R24/R27 intersection that can service travellers between Rustenburg and Johannesburg/Krugersdorp. The new proposed filling station will be in proximity to these 5 existing operational filling stations.

Financial impact: Another filling station on this route will have a detrimental financial impact on the existing operational filling stations.

Other objections: Fuel Retailers Association (FRA) and Kallie Erasmus have been requested to become involve and object on behalf of existing operational filling stations.

Capacity: Existing filling stations have not reached full capacity and can therefore supply a larger demand if the need arises.

Mining and Business in Rustenburg: Strikes in the mining sector result in mines closing shafts - 5 Platinum shafts are closing down. The chrome market is deteriorating. This affects existing businesses in Rustenburg negatively.

Previous refusals for filling stations.

Hotel: Already have 2 relatively new hotels (City Lodge & Stay Easy) on R24.

Restaurant/food: Rudan has bakery and Wimpy

Traffic volumes: Increase of vehicles on Highway from Marikana Plaza is irrelevant because motorists will not enter Rustenburg.

Kindly advise if you are satisfied with the issues captured.

Thank you for your input and comments. We do realise that access to municipal services (water, sanitation and waste removal) in this area has been a challenge in the past.
