PROPOSED DEVELOPMENT OF A 25M HIGH TELECOMMUNICATION MAST ON ERF 542, MAIN ROAD, KLEINSEE, NORTHERN CAPE

Notice is hereby given of the intention to submit an application, and the public participation process, in terms of the National Environmental Management Act, 1998 (Act No. 107 of 1998), as amended ("NEMA"), Environmental Impact Assessment Regulations 2014. The proposed 25m high telecommunications mast on Erf 542, Main Road, Kleinsee, Northern Cape, includes activities listed in terms of the NEMA EIA Regulations 2014.

EnviroAfrica cc has been appointed by the Eagle Towers SA (Pty) Ltd, to undertake the NEMA Application for Environmental Authorisation process.

Project Description & Location:

A telecommunications mast, including associated infrastructure, is proposed on Erf 542, Main Road, Kleinsee, Northern Cape. The base station will have a development footprint of approximately (8m x 8m) 64m² and will include a 25m high lattice mast and three service provider equipment containers. The site will be enclosed by fencing for security reasons. The site is located off Main Road, Kleinsee Central. The proposed site coordinates: 29°40' 43.95"S, 17°4'10.81"E.


