The proposed 25m high telecommunications mast on Erf 2820, 41 Brisson Street, Matjieskloof, Springbok, Northern Cape, includes activities listed in terms of the NEMA EIA Regulations 2014.

EnviroAfrica cc has been appointed by the Eagle Towers SA (Pty) Ltd, to undertake the NEMA Application for Environmental Authorisation process.

Project Description & Location:

A telecommunications mast, including associated infrastructure, is proposed on Erf 2820, 41 Brisson Street, Matjieskloof, Springbok, Northern Cape. The base station will have a developmental footprint of approximately (8m x 7m) 56m² and will include a 25m high monopole mast and three service provider equipment containers. The site will be enclosed by fencing for security reasons. The proposed site co-ordinates: **29°40' 16.10"S, 17°51'59.28"E**.
