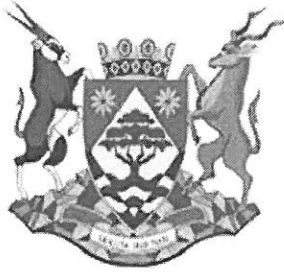

NEW KATHU CEMETERY: REQUEST FOR PROJECT TIMEFRAME EXTENSION

Project Background

The Gamagara Local Municipality (GLM) proposes to develop additional space for graves in the town of Kathu. The cemetery is nearing capacity and thus additional space is necessary due to the rapid expansion of the town of Kathu which is partly due to the resettlement of the Dingleton residents.

Due to the existing Kathu Cemetery being located in the protected Kathu Forest, extending the existing cemetery on the farm Uitkoms 463 is not possible. The best viable alternative is to establish a new cemetery on the remaining extent of the farm Lyleveld 545, approximately 13 km south of central Kathu, within the GLM and John Taolo Gaetsewe District Municipality. The new Kathu Cemetery will be approximately 5 hectares (ha) in extent on land owned by the Sishen Iron Ore Company (Pty) Ltd. The land for the new cemetery will be transferred to the GLM through a land swap agreement as part of the Dingleton Resettlement project.

An application for environmental authorisation was submitted to the Department of Environment and Nature Conservation (DENC) on the 18th November 2016, for the New Kathu Cemetery. The DENC acknowledgement of receipt of the application was received on the 14th December 2016 (dated 21st November 2016).

Following submission of the application, the public participation process (PPP) and the specialist studies for the project commenced. During PPP, Eskom indicated that they were planning to apply for the construction of a new powerline which would intersect with the New Kathu Cemetery.

Following a meeting between Eskom, GLM, SIOC and Synergistics, the position of the New Kathu Cemetery was moved to accommodate the alignment of the proposed Eskom Powerline. The revised location of the New Kathu Cemetery is still located on the remaining extent of the farm Lyleveld 545. It should be noted that the revised location is near the area that was visited by DENC and the Department of Agriculture Forestry and Fisheries during the pre-application consultation.

Motivation for project timeframe extension

With the required changes to the location of the New Kathu Cemetery, there is a project timeframe delay as a result of needing to find a new suitable location and specialists needing to re-do their site work and update their reports.

An extension for the project timeframe is being requested as allowed for in Regulation 3(7) of the 2014 Environmental Impact Assessment Regulations (GNR982) due to the unforeseen circumstances. An additional 45 calendar days (excluding public holidays) is being requested for the submission of the Final Basic Assessment Report to DENC, with the new submission date being 02 May 2017. This additional time is required for the finalisation of the location of the revised site, for specialists to re-do their site work and for the Basic Assessment Report to be completed with the revised location and updated specialist studies.

Due to the changes in the location of the New Kathu Cemetery, the GLM would like to update their application to include the revised co-ordinates of the site and the revised locality map. An updated application has been included with this submission. There are no new listed activities being applied for, the only change is the location of the New Kathu Cemetery. A map which shows the original location has been included in Appendix 1 and the finalised revised location of the new Kathu Cemetery has been included in Appendix 2.

A meeting was held with DENC on the 11th January 2017 to discuss this timeframe extension and the proposed changes. A summary of the meeting has been attached in Appendix 3.

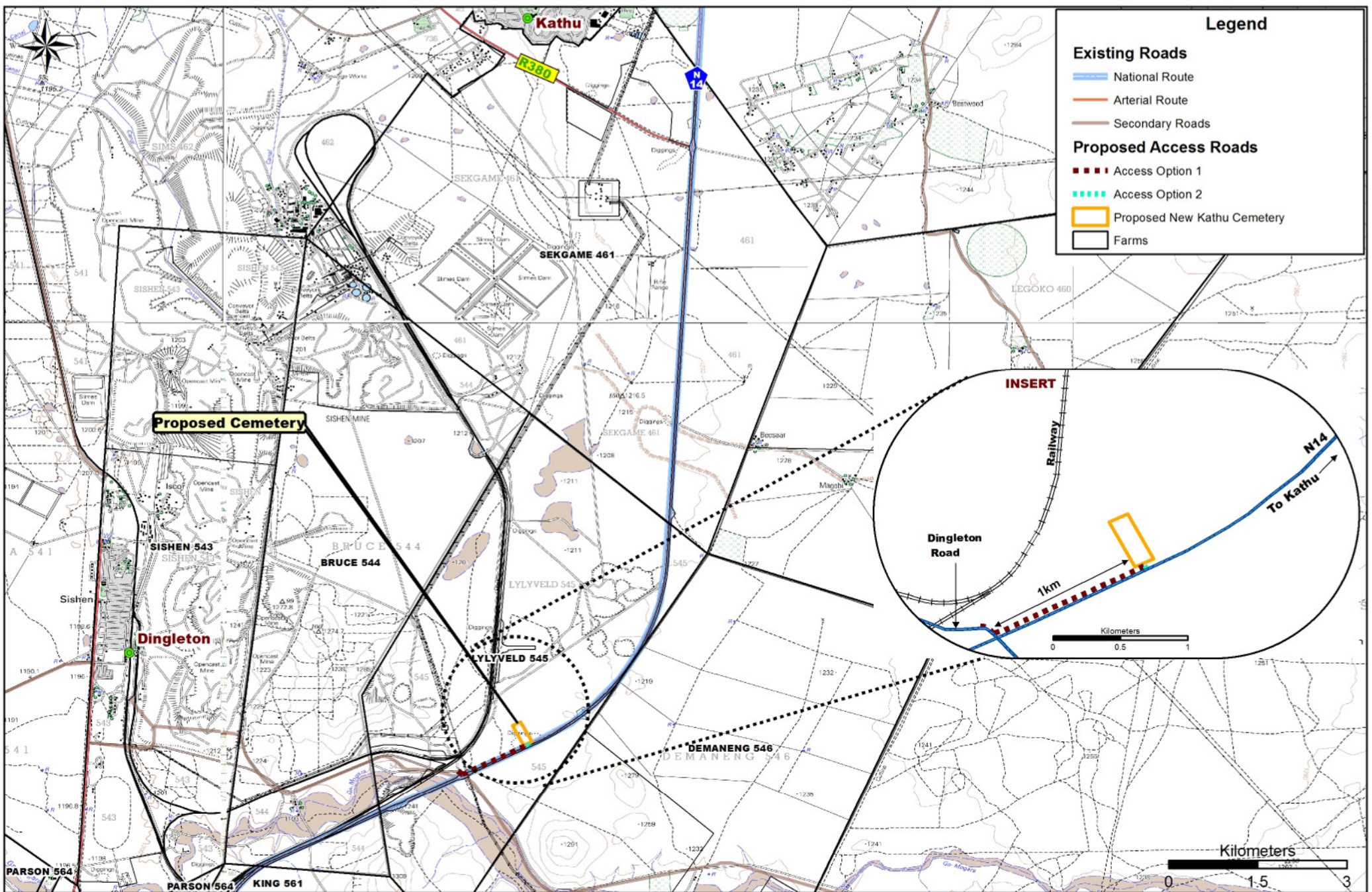

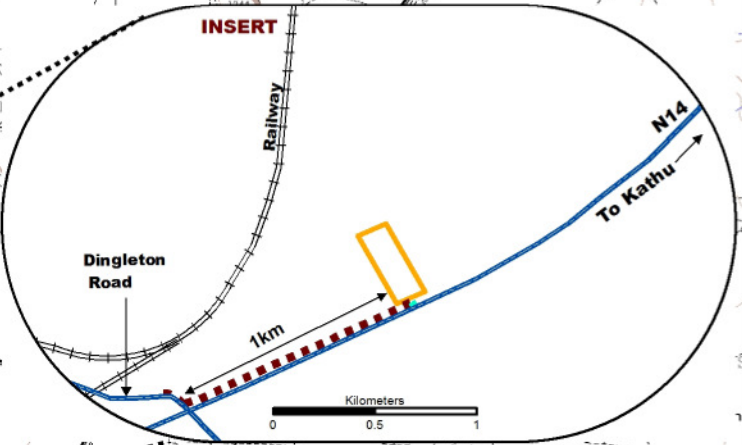

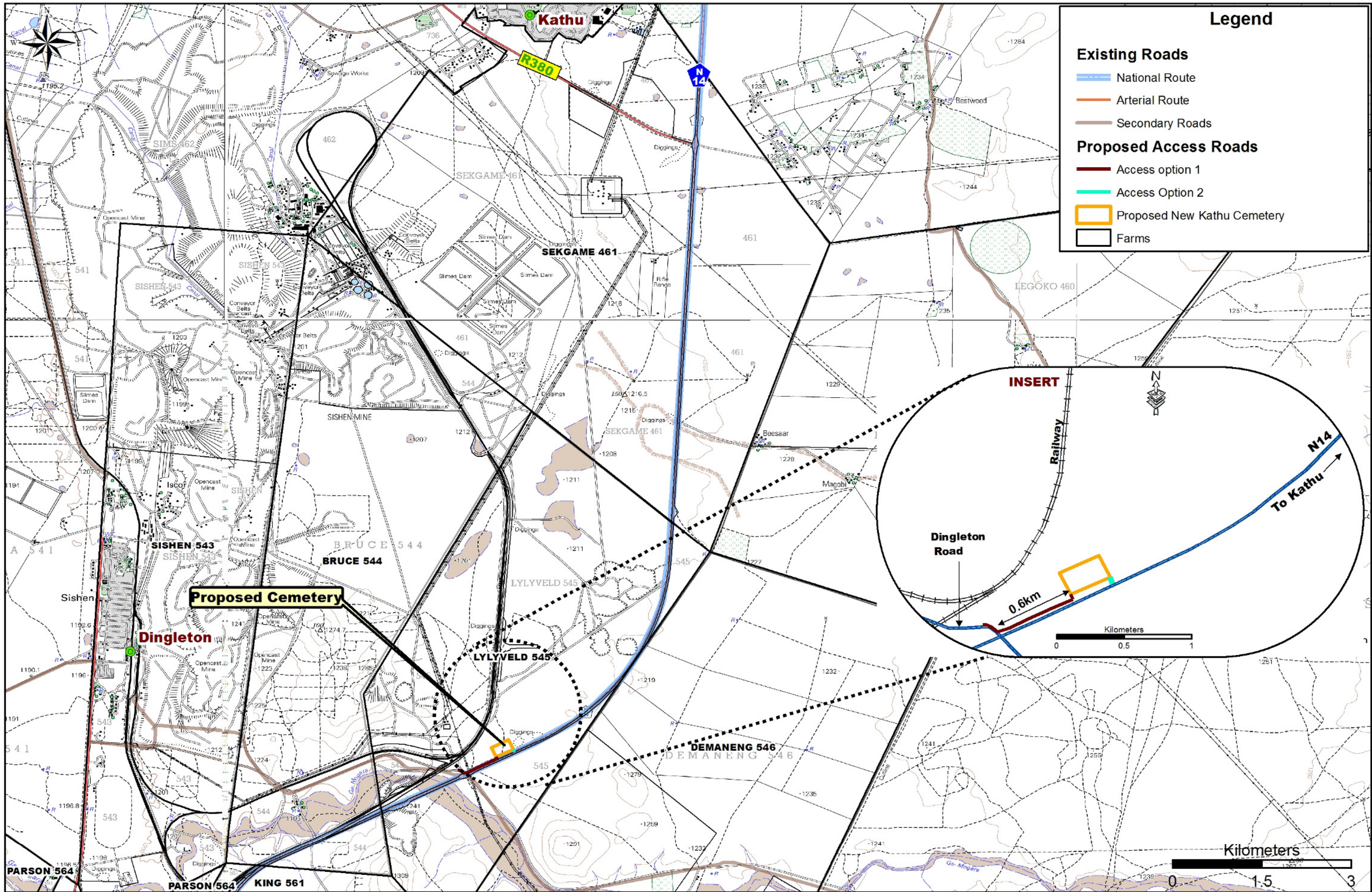


Locality Map for the Proposed New Kathu Cemetery

1. INTRODUCTION AND PURPOSE OF THE MEETING

The meeting was attended by Thulani Mthombeni and Naomi Mokonopi of the Department of Environment and Nature Conservation (DENC) and Chiara Kotze as a representative of Synergistics Environmental Services (Pty) Ltd.

The purpose of the meeting was to:

- Discuss the required changes to the location of the New Kathu Cemetery
- Discuss the proposed project extension being requested
- Discuss changes to the Basic Assessment Template
- Discuss the methods included in the public participation process being conducted

2. PRESENTATION

An information meeting pack was distributed providing details on the project changes and the new selected site (Appendix 1).

3. DISCUSSION

During the meeting the following comments were raised:

Changes to the location and project extension

- DENC indicated that they do not foresee the extension request being a problem as an extension can be requested as provided for in the Environmental Impact Assessment (EIA), 2014 Regulations.

- A formal letter needs to be submitted for the request to extend the project timeframe. The letter needs to include:
 - a motivation for the extension;
 - a copy of the meeting summary of this meeting;
 - mention that the applicant wants to update and amend the details of the project site in the application; and
 - the new proposed submission date for the final Basic Assessment Report (BAR).
- A new application form will need to be submitted to DENC which details:
 - the changes to the project and why a change is required;
 - the new co-ordinates;
 - a new project locality map; and
 - the allocated DENC project reference number.
- The updated application can be submitted simultaneously with the request for extension to optimise on time.
- One hard copy of the letter and application needs to be submitted to the Kimberley DENC office.

DENC template and BAR

- Synergistics noted that the regulation numbers included in the DENC BAR template need to be updated to the 2014 EIA regulation numbers. DENC indicated that Synergistics can cross off and correct the regulation numbers in the template.
- Synergistics enquired if the format of the impact assessment summary table in the DENC BAR template has to be used or if an alternative format which considers the same information can be used instead. DENC indicated that while they are mainly concerned with the content of the impact assessment, it cannot be indicated at this stage if the summary table structure can be changed. Since this is an official template, it will require consent from other personnel within DENC. If Synergistics does want to deviate, they should send a request and this could then be considered by DENC.
- DENC indicated that the different sites around Kathu that were considered for the location of the new Kathu Cemetery should be mentioned in the BAR to explain why the final location was chosen. Synergistics indicated that this would be included as an appendix to the BAR. The impact assessment in the BAR will be for the chosen location for the New Kathu Cemetery and the two access road alternatives.
- DENC indicated that two hard copies of the final BAR need to be submitted to the Kimberley office.

Public Participation Process

- Synergistics queried if DENC considered the PPP methods that were conducted to be adequate. These included:
 - Conducting a social scan;
 - Advertising in two newspapers and the government gazette;
 - Setting up site notices at the project site and around Kathu, Dingleton, Olifantshoek, Dibeng and Sesheng;

- Sending SMSes to the people on the municipal bill database – only people who requested to be registered were included on the project IAP database;
 - Conducting a deed search of directly adjacent landowners;
 - Sending notification letters to directly adjacent landowners, the landowner of the project site and applicable regulatory and local authorities;
 - Sending a letter to all registered IAPs informing them of the changed location of the New Kathu Cemetery (this will be done near the end of January 2017);
 - Advertising the availability of the draft BAR for review and comment in two local newspapers (this will be done when the BAR is completed and available for review); and
 - Notifying all registered IAPs of the availability of the Draft BAR for review and comment (this will be done when the BAR is completed and available for review).
- DENC indicated that the minimum requirements need to be met in terms of the EIA regulations; additional methods for PPP can be done as well and need to be detailed in the BAR. DENC indicated that the PPP detailed seemed adequate for the project.

4. CLOSE

Chiara Kotze thanked all attendees for their time and contributions. The meeting was then closed.

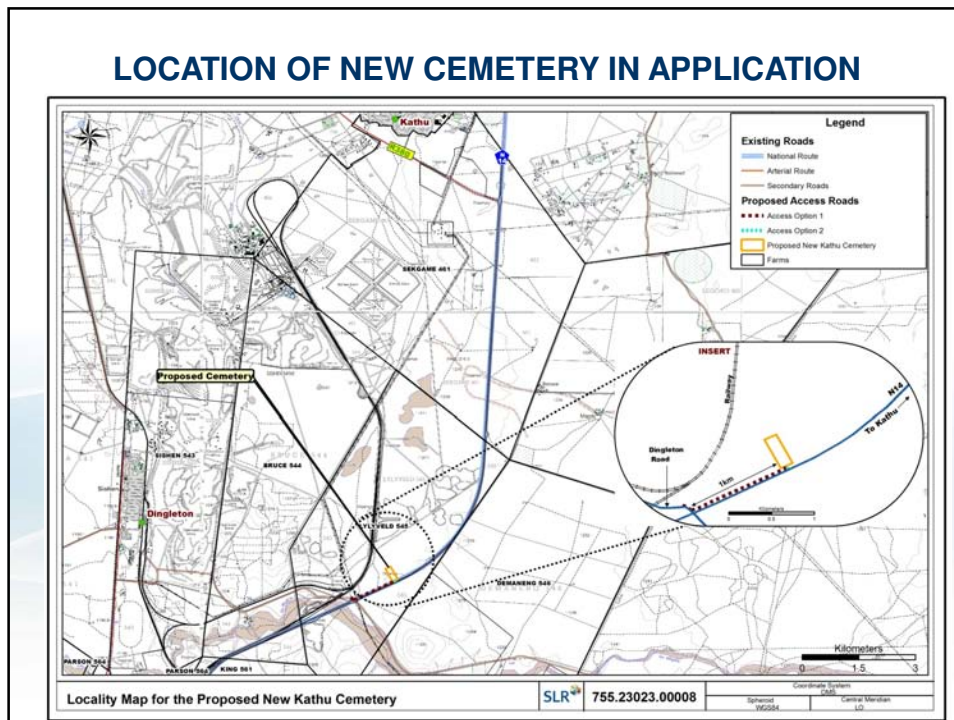

- The revised location is closer to the area that was visited by DENC during the pre-application site meeting and is on the same property as included in the application
- The revised location will likely require a water use licence/general authorisation as it will be within the 500m regulated zone of the Gamagara River and pans
- The revised location is however outside of the 1:100 year floodline and outside of the 32m NEMA regulated zone

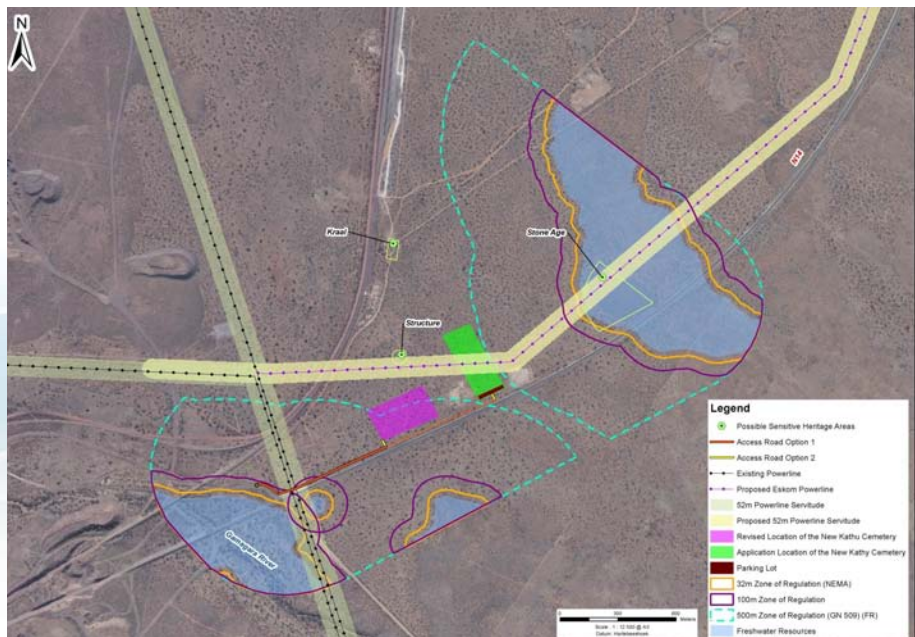

1. SUBJECT

The Department of Agriculture, Forestry and Fisheries (DAFF) received a request from SLR Consulting (Chiara D' Egidio Kotze, Tel 011 – 467 0945 or 073 277 7228) to do a site inspection at the new site earmarked for development as a cemetery in the vicinity of Kathu. The site inspection took place on 28 September 2016. Subsidised vehicle with registration CJN 979 NC was used.

3. BACKGROUND

Ms. Chiara D'Egidio Koze of SLR Consulting requested a site meeting / inspection to determine the suitability of the new site earmarked for development as a cemetery. SLR Consulting conducted the previous EIA to expand the existing Kathu cemetery with 5 ha. The project was not authorized due to its location inside the demarcated Kathu Forest.

Gamagara Municipality urgently needs an appropriate site for a cemetery due to the current one being at full capacity. SLR Consulting requested inputs from DAFF (Forestry) regarding potential impacts on protected trees and thus suitability of the site from DAFF's point of view.

4. OBSERVATIONS & DISCUSSIONS

The site is located approximately 9 km from Kathu, in the direction of Olifantshoek. The land belongs to Kumba Iron Ore (KIO) and they are willing to provide a 5 ha portion of the farm Lylyveld for a cemetery. No site closer to town could be found that is suitable – that is deep enough to facilitate burial. Closer to town, calcareous outcroppings make it impossible to go beyond 2 m depths.

The site shown to DAFF and DENC is outside Kathu Forest. It is located approximately 3 km away from the Sishen Mine. The mine is visible from the site. A portion of the site is disturbed, but the disturbed area will not be included in the cemetery. The officials of KIO stated that this farm portion will not be mined. It was tested and not deemed suitable for mining. The proposed cemetery site forms part of the so-called game camp of Sishen Iron Ore Mine (SIOC) and is currently being used for farming.

There are scattered *Acacia (Vachellia) erioloba* and *Acacia (Vachellia) haematoxylon* trees present on site, some of them quite large, but most are small or medium-sized. The site is deemed suitable from DAFF's point of view, because it will not impact on the Kathu Forest.

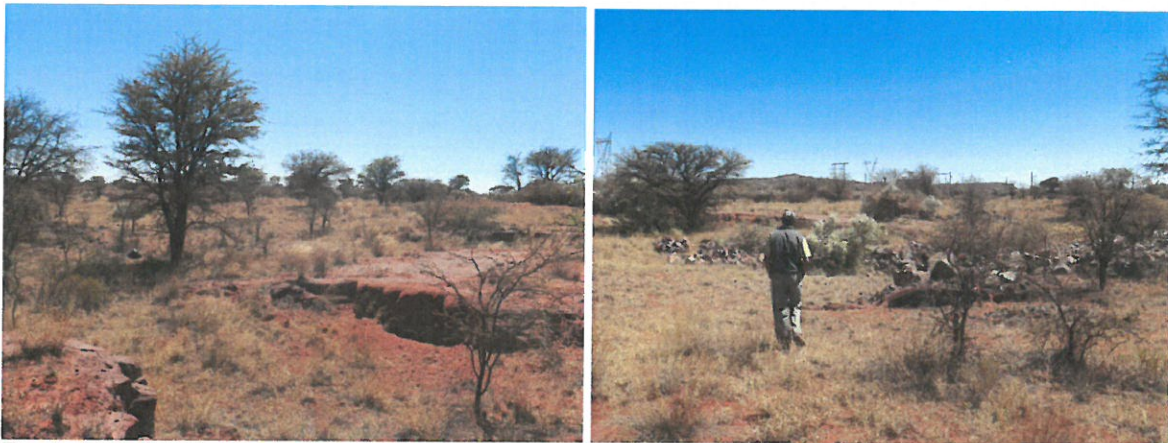


Fig. 1: The disturbed area (left and right) will be excluded.

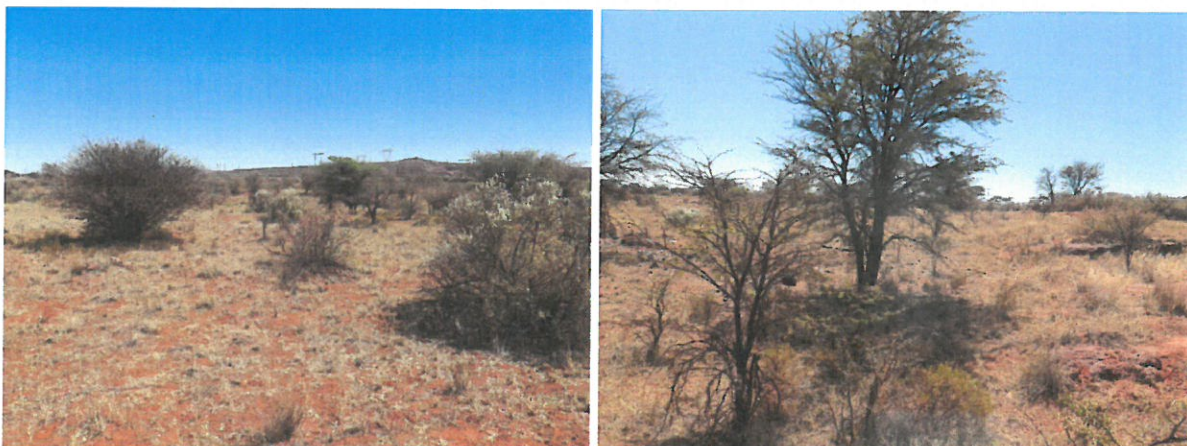


Fig. 2: The site earmarked for the cemetery has deep sand making it easy for burial, but the mine is visible in the background (left); there are scattered Camel thorn trees present on site (right).

The officials from Gamagara Municipality raised their concern regarding vibrations that can be felt on site when the mine use explosives, but others present pointed out that the vibrations can also be felt in town. Ms. Apools said the vibrations may damage tombstones. They also expressed

their concern regarding the distance to town (about 9 km), but closer to town no suitable site could be found due to underlying geology and calcareous outcroppings.

The SIOC will fence off the 5 ha parcel, if the land is found suitable by the Municipality. Access will be through the existing gate.

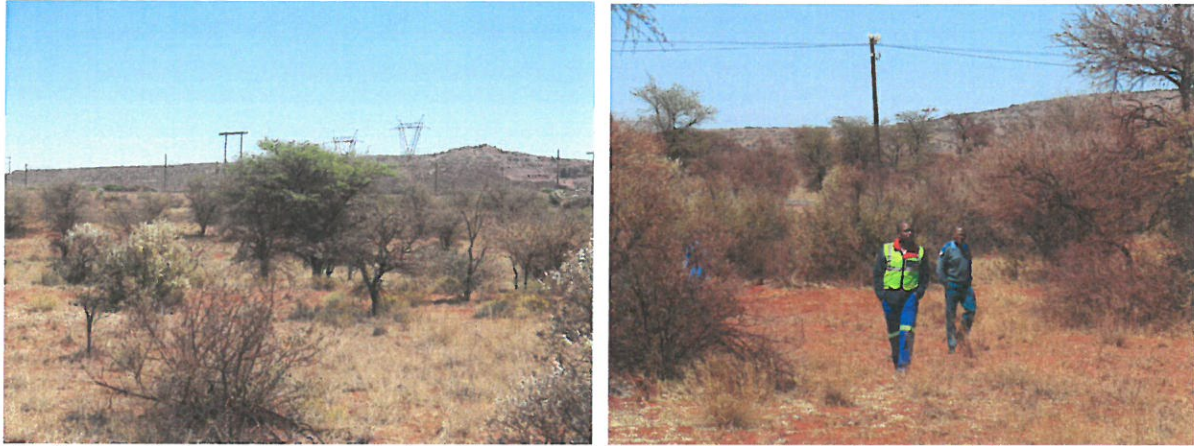



Fig. 3: The site is about 3 km away from the mine, which is visible in the background (left); and adjacent to the N14 (right).

5. OUTCOMES

The site is deemed suitable for a cemetery from DAFF's point of view. If individual protected trees must be removed, a license can be applied for and granted.

1. SUBJECT

The Department of Agriculture, Forestry and Fisheries (DAFF) received a request from SLR Consulting (Chiara D' Egidio Kotze, Tel 011 – 467 0945 or 073 277 7228) to do a site inspection at the new site earmarked for development as a cemetery in the vicinity of Kathu. The site inspection took place on 28 September 2016. Subsidised vehicle with registration CJN 979 NC was used.

3. BACKGROUND

Ms. Chiara D'Egidio Koze of SLR Consulting requested a site meeting / inspection to determine the suitability of the new site earmarked for development as a cemetery. SLR Consulting conducted the previous EIA to expand the existing Kathu cemetery with 5 ha. The project was not authorized due to its location inside the demarcated Kathu Forest.

Gamagara Municipality urgently needs an appropriate site for a cemetery due to the current one being at full capacity. SLR Consulting requested inputs from DAFF (Forestry) regarding potential impacts on protected trees and thus suitability of the site from DAFF's point of view.

4. OBSERVATIONS & DISCUSSIONS

The site is located approximately 9 km from Kathu, in the direction of Olifantshoek. The land belongs to Kumba Iron Ore (KIO) and they are willing to provide a 5 ha portion of the farm Lylyveld for a cemetery. No site closer to town could be found that is suitable – that is deep enough to facilitate burial. Closer to town, calcareous outcroppings make it impossible to go beyond 2 m depths.

The site shown to DAFF and DENC is outside Kathu Forest. It is located approximately 3 km away from the Sishen Mine. The mine is visible from the site. A portion of the site is disturbed, but the disturbed area will not be included in the cemetery. The officials of KIO stated that this farm portion will not be mined. It was tested and not deemed suitable for mining. The proposed cemetery site forms part of the so-called game camp of Sishen Iron Ore Mine (SIOC) and is currently being used for farming.

There are scattered *Acacia (Vachellia) erioloba* and *Acacia (Vachellia) haematoxylon* trees present on site, some of them quite large, but most are small or medium-sized. The site is deemed suitable from DAFF's point of view, because it will not impact on the Kathu Forest.

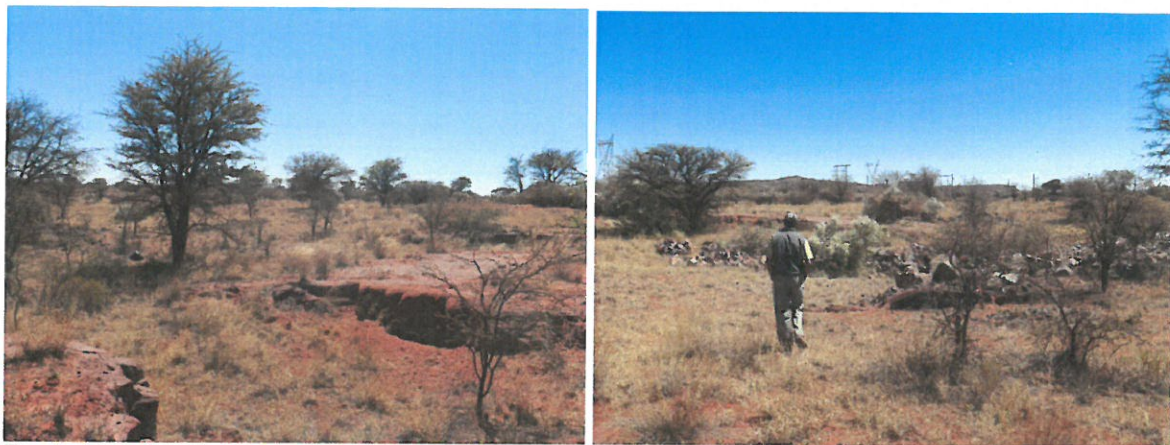


Fig. 1: The disturbed area (left and right) will be excluded.

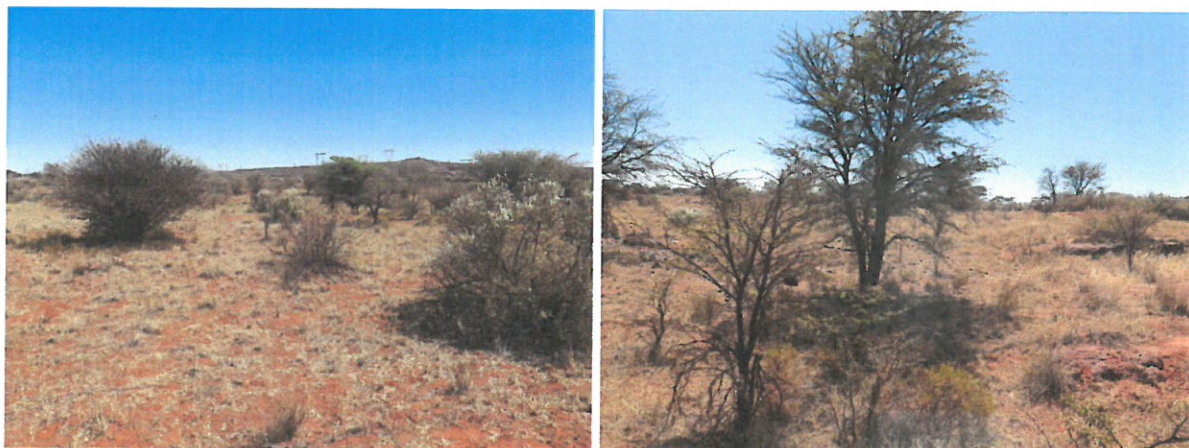


Fig. 2: The site earmarked for the cemetery has deep sand making it easy for burial, but the mine is visible in the background (left); there are scattered Camel thorn trees present on site (right).

The officials from Gamagara Municipality raised their concern regarding vibrations that can be felt on site when the mine use explosives, but others present pointed out that the vibrations can also be felt in town. Ms. Apools said the vibrations may damage tombstones. They also expressed

their concern regarding the distance to town (about 9 km), but closer to town no suitable site could be found due to underlying geology and calcareous outcroppings.

The SIOC will fence off the 5 ha parcel, if the land is found suitable by the Municipality. Access will be through the existing gate.

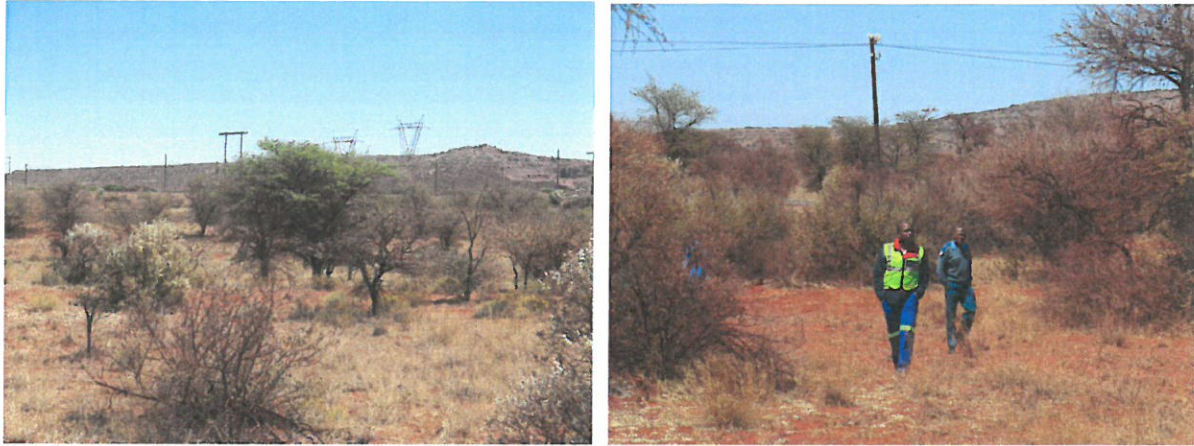



Fig. 3: The site is about 3 km away from the mine, which is visible in the background (left); and adjacent to the N14 (right).

5. OUTCOMES

The site is deemed suitable for a cemetery from DAFF's point of view. If individual protected trees must be removed, a license can be applied for and granted.

RE: COMMENTS ON NOTICE OF A BASIC ASSESSMENT PROCESS FOR NEW KATHU CEMETERY ON THE REMAINING EXTENT OF THE FARM LYLVELD 545, KATHU (DENC REF: Not Supplied)

1. DEPARTMENTAL MANDATE

The Directorate: Forestry Management (Other Regions) in the Department of Agriculture, Forestry and Fisheries (DAFF) is responsible for implementation of the **National Forests Act, Act 84 of 1998 (NFA)** and the **National Veld and Forest Fires Act, Act 101 of 1998** as amended. The developer must take note of the following sections of the NFA:

1.1 Section 12(1): "The Minister may declare-

- (a) a particular tree,
- (b) a particular group of trees,
- (c) a particular woodland; or
- (d) trees belonging to a particular species, to be a protected tree, group of trees, woodland or species.

1.2 Section 15(1): "No person may-

- (a) **Cut, disturb, damage or destroy any protected tree; or**
- (b) Possess, collect, remove, transport, export, purchase, sell, donate or in any other manner acquire or dispose of any protected tree, or any forest product derived from a protected tree, **except-**
 - (i) **under a license granted by the Minister; or**
 - (ii) **in terms of an exemption from the provision of this subsection published by the Minister in the Gazette on the advice of the Council."**

- 1.3 "Any person who contravenes the prohibition on-
- (i) The cutting, disturbance, damage or destruction of temporarily protected trees or groups of trees referred to in section 14(2) or protected trees referred to in section 15(1)(a); or
 - (ii) The possession, collection, removal, transport, export, purchase or sale of temporarily protected trees or groups of trees referred to in section 14(2) or protected trees referred to in section 15(1)(b), or any forest product derived from a temporarily protected tree, group of trees or protected tree, is guilty of a first category offence.
- 1.4 Section 58 (1): "Any person who is guilty of a first category offence referred to in sections 62 and 63 may be sentenced to a fine or imprisonment for a period of up to three years, or to both a fine and such imprisonment."
- 1.5 The list of protected tree species under section 12(1) (d) of the National Forests Act, 1998 (Act No. 84 of 1998) was published in GN1161 of 20 November 2015.

2. INITIAL COMMENTS ON BASIC ASSESSMENT PROCESS

- 2.1 The Department visited the proposed cemetery site on the Remaining Extent of the farm Lylyveld 545, Kathu in September 2016. The inspection confirmed the presence of protected trees on site, but also that the site is partially disturbed and located away from the Protected Woodland i.e. Kathu Forest. In light of this the Department does not have any objection against the proposed site *per se*.
- 2.2 A positive Environmental Authorisation does not exempt the developer (Gamagara Local Municipality) from complying with the NFA and the Northern Cape Nature Conservation Act, Act 9 of 2009 (NCNCA). If protected trees must be felled or pruned for establishment of the new cemetery, the developer must obtain a valid NFA License prior to disturbance of such affected trees.
- 2.3 Efforts must be made to minimise impacts on slow growing protected trees, especially larger trees. Infrastructure should be placed where it would have the least impacts on protected trees. In the parking area, large individual trees must be retained as far as possible. It can provide shade for cars.

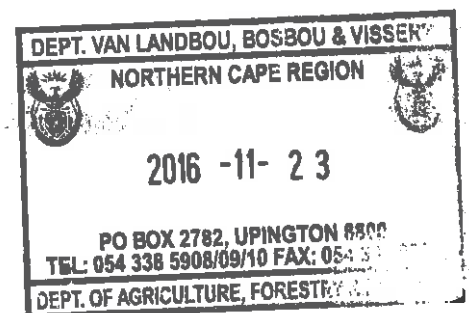

www.asapa.org.za) to provide a Phase 1 Archaeological Impact Assessment Report. The Phase 1 Impact Assessment Report will identify the archaeological sites and assess their significance. It should also make recommendations (as indicated in section 38) about the process to be followed. For example, there may need to be a mitigation phase (Phase 2) where the specialist will collect or excavate material and date the site. At the end of the process the heritage authority may give permission for destruction of the sites. If the property is very small or disturbed and there is no significant site the specialist may choose to send a letter to the heritage authority to indicate that there is no necessity for any further assessment. It must be noted that the proposed development is located approximately 14 km from the Kathu Archaeological Site which is currently pending declaration as a National Heritage Site.
