- The ground elevation of the site above mean sea level (MSL) to an accuracy of 1 metre.
- The vertical dimensions of such multiple story structure and geographical positions planned.
- The total all-inclusive height of the proposed structure above ground level (AGL).
- A conditional approval would be provided, and as soon as an “as build” is provided with final plans, would the final approval be issued.

It should also be considered that temporary construction equipment that may be used in such a project, is also subject to prior approval and possible conditions.
