De Beers Marine (Pty) Ltd, the appointed operator for De Beers Consolidated Mines (Pty) Ltd.'s ("DBCM") South African offshore prospecting rights, wishes to inform you that in regard to the Samara Mining Proprietary Limited ("Samara Mining") Prospecting Right application over Sea Areas 4c and 5c, DBCM and De Beers Marine (Pty) Ltd ("DBM") are interested and affected parties ("I&APs").

DBCM was the holder of prospecting rights over Sea Areas 4c and 5c on the date that Samara Mining lodged its application for a prospecting right over Sea Areas 4c and 5c, which date of lodgement is understood to be on 8 February 2021. Samara Mining's scoping report confirms that an application for an environmental authorisation was lodged on 8 February 2021. In terms of section 16(1) of the MPRDA, any person who wishes to apply for a prospecting right must simultaneously apply for an environmental authorisation. As such, if Samara Mining complied with section 16(1) of the MPRDA, then their prospecting right was lodged on 8 February 2021.

In terms of section 16(2)(b), an application for a prospecting right must not be accepted if another entity holds a prospecting right. The day after, namely on 9 February 2021, DBCM lodged its own new application for a prospecting right over Sea Areas 4c and 5c. DBCM was the first competent applicant for a prospecting right subsequent to the lapse of DBCM's erstwhile prospecting rights at midnight on 8 February 2021. DBCM has lodged an appeal against the rejection of its prospecting right application and the acceptance of a third-party application (being that of Samara Mining). It is noteworthy that at the time DBCM lodged its application, it was first in line in terms of Section 9(1)(b) of the Mineral and Petroleum Resources Development Act (MPRDA), 2002 (Act 28 of 2002), which provides that if a Regional Manager receives more than one application for a prospecting right on different days (and in respect of the same mineral and land), these applications must be dealt with in order of receipt. In any event, the application by Samara Mining was unlawfully lodged as DBCM's erstwhile prospecting rights over 4c and 5c still existed up until midnight on 8 February 2021.

In addition, DBCM is the holder of a prospecting right over Sea Area 6c which is adjacent to the 4c and 5c Prospecting Right Area and is a direct interested and affected party as the holder of a prospecting right on a neighbouring sea area for purposes of the environmental authorisation application of Samara Mining.

From our review of the draft Scoping Report, several additional key stakeholders have also not been included on the project I&AP database for the application by Samara Mining. Such parties include:

- a. Contact persons from the Northern Cape Department of Mineral Resources and Energy (DMRE) or the Petroleum Agency of South Africa (PASA);
- b. Neighbouring mining/prospecting right holders (BPT127 [3c], DBCM [6c] and Alexkor [inshore]);
- c. Small-scale fishery co-operatives operating off the West Coast, as well as other key commercial fishing sector representatives;
- d. Commercial fishing companies (Oceana, I&J and Sea Harvest) are listed; and
- e. Oil and gas operators which have an interest in overlapping licence blocks.


