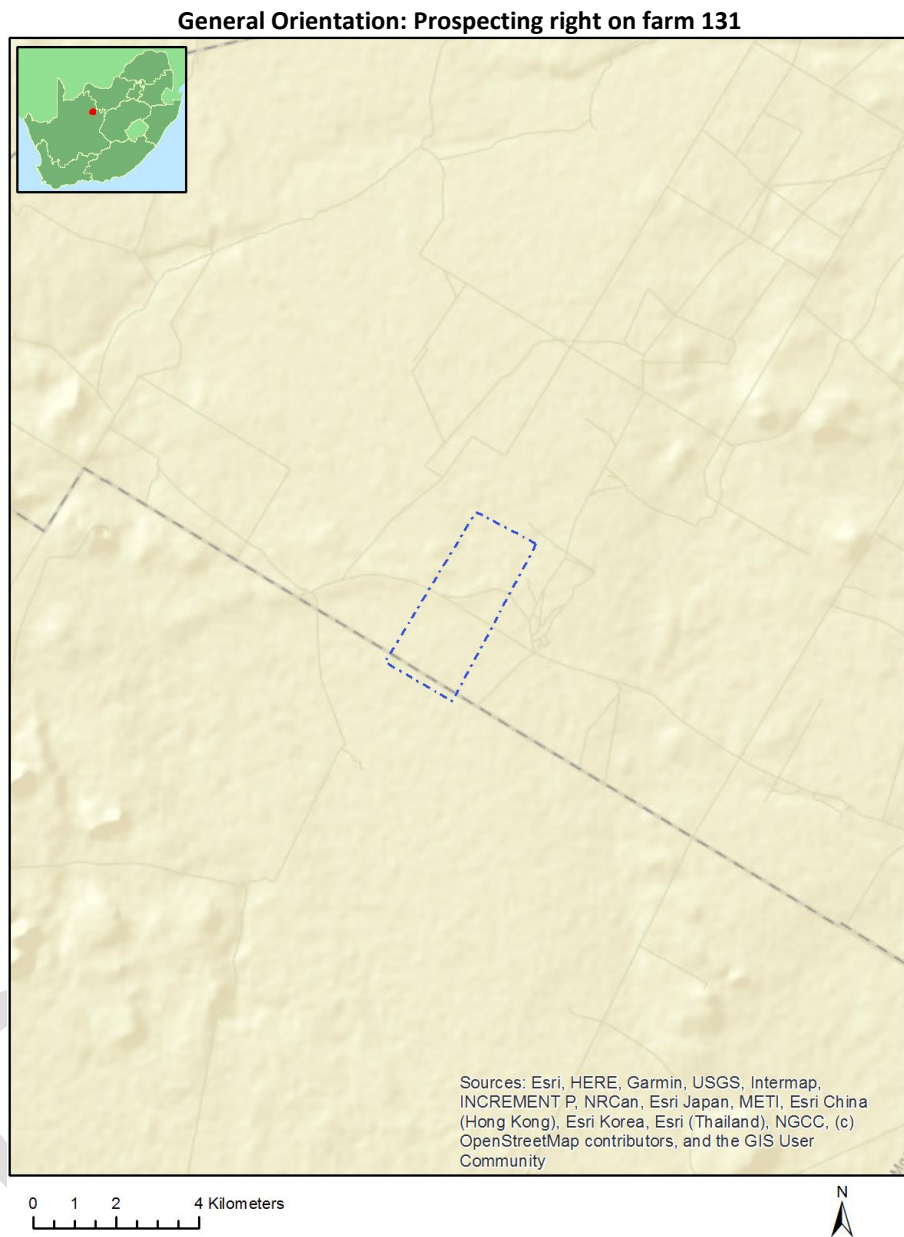

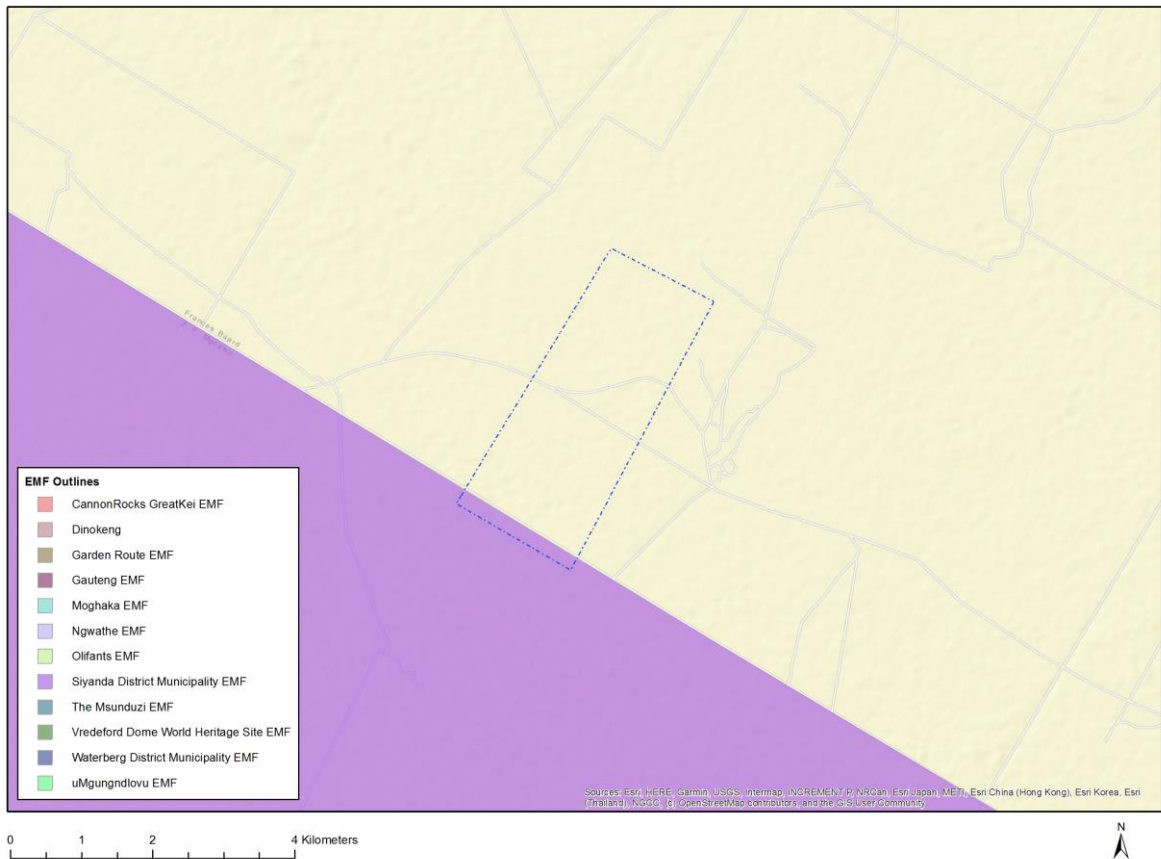

MAP OF RELATIVE ANIMAL SPECIES THEME SENSITIVITY



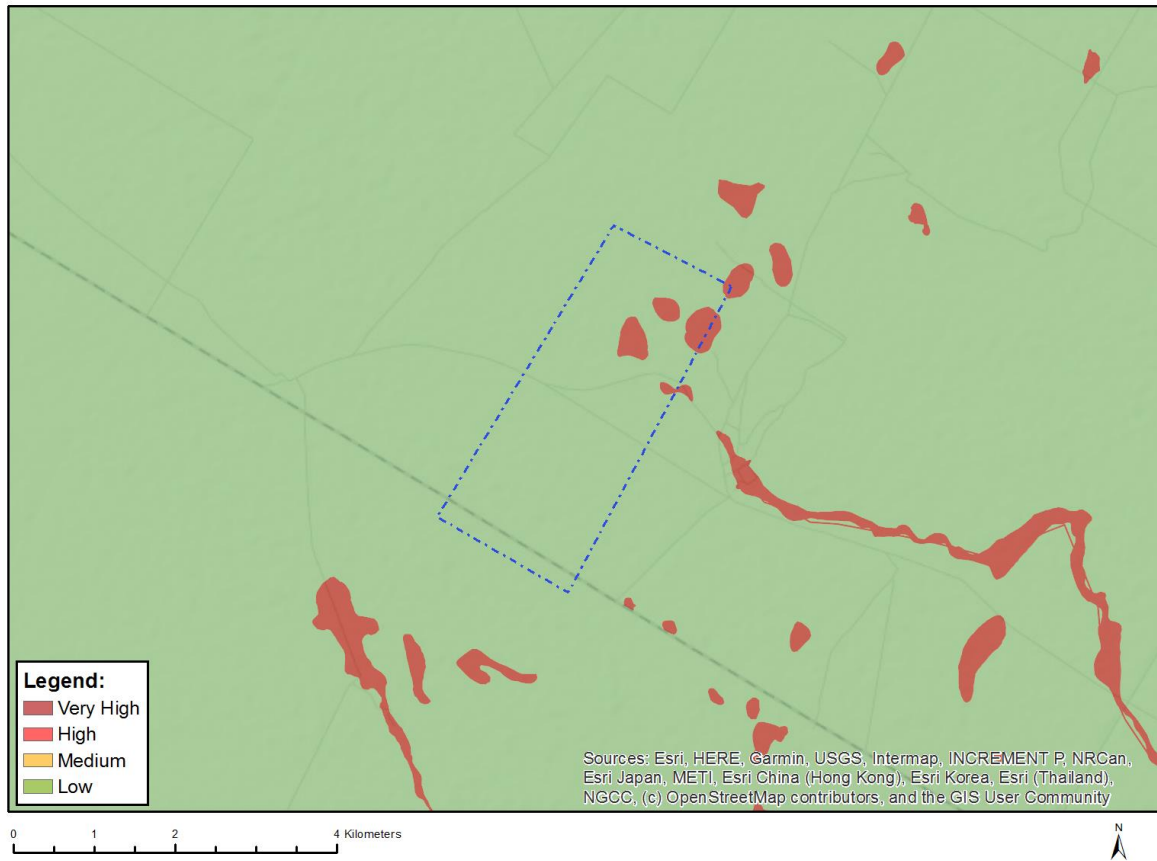

MAP OF RELATIVE DEFENCE THEME SENSITIVITY

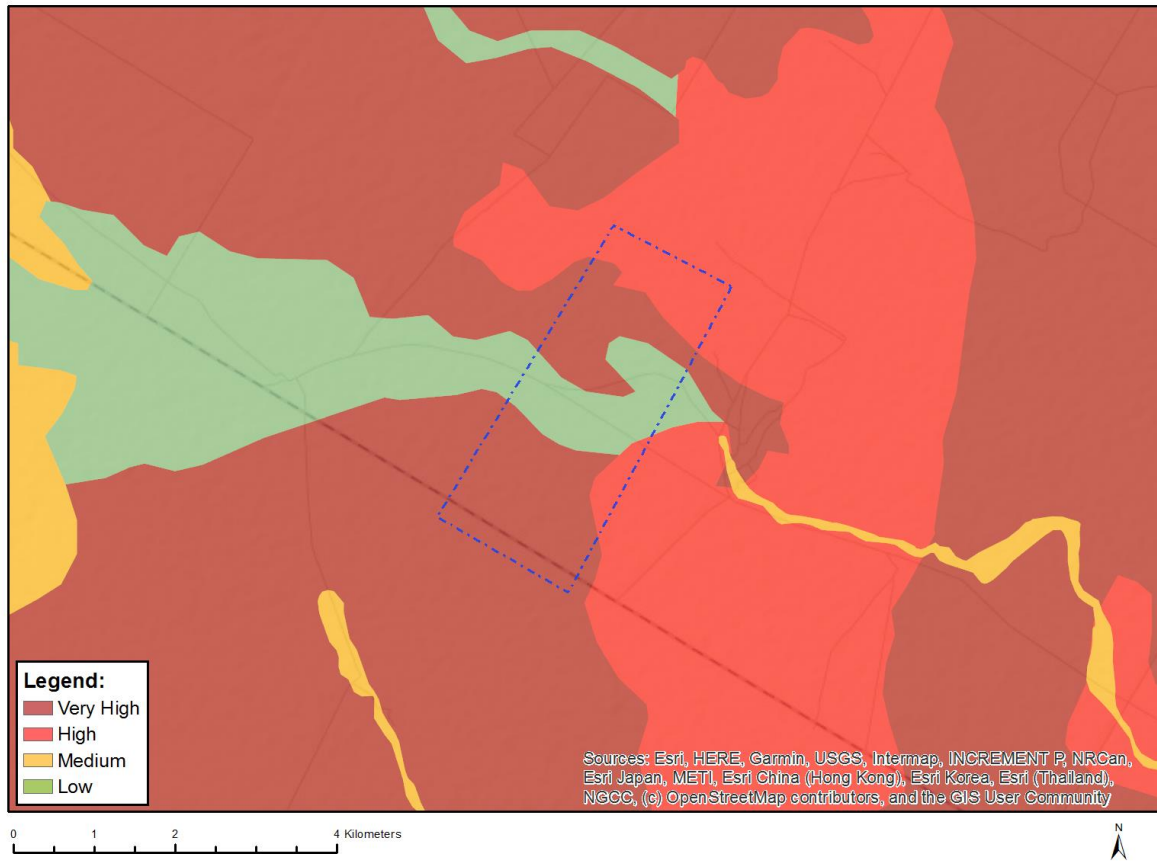

MAP OF RELATIVE PALEONTOLOGY THEME SENSITIVITY

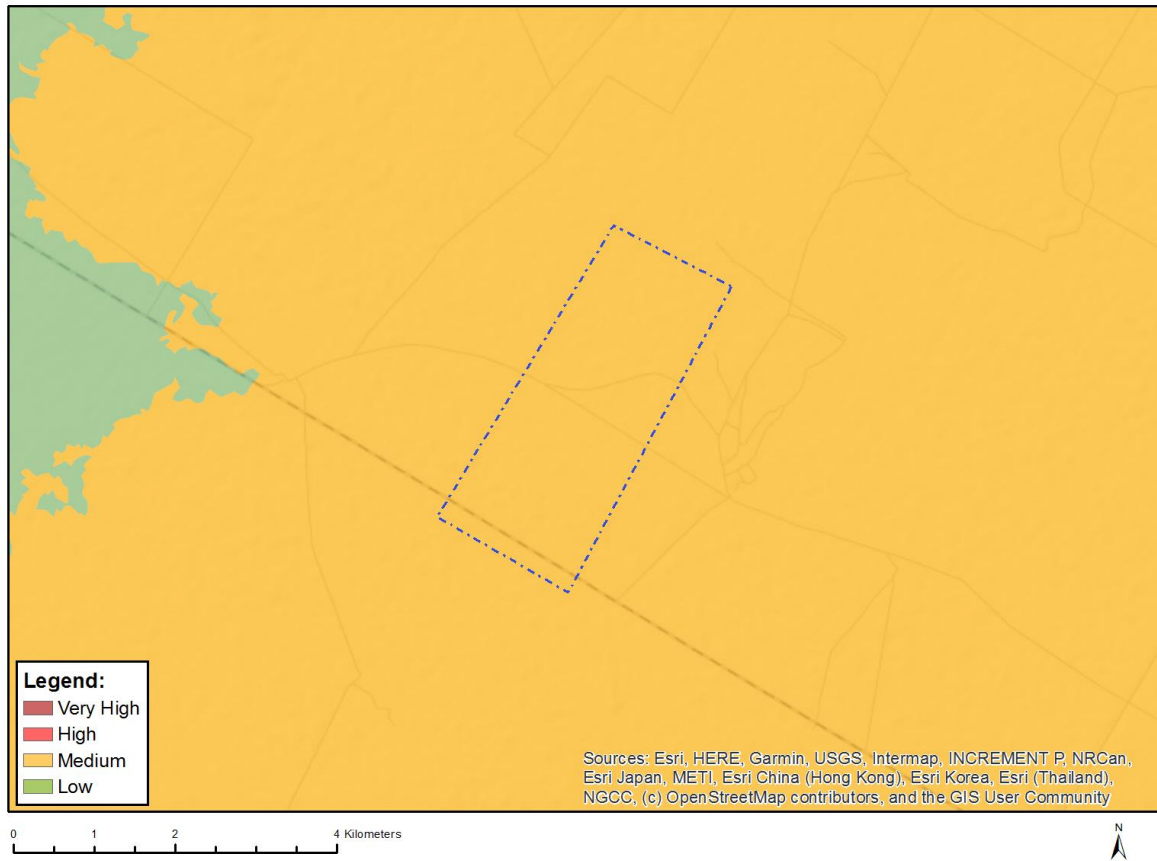

MAP OF RELATIVE PLANT SPECIES THEME SENSITIVITY



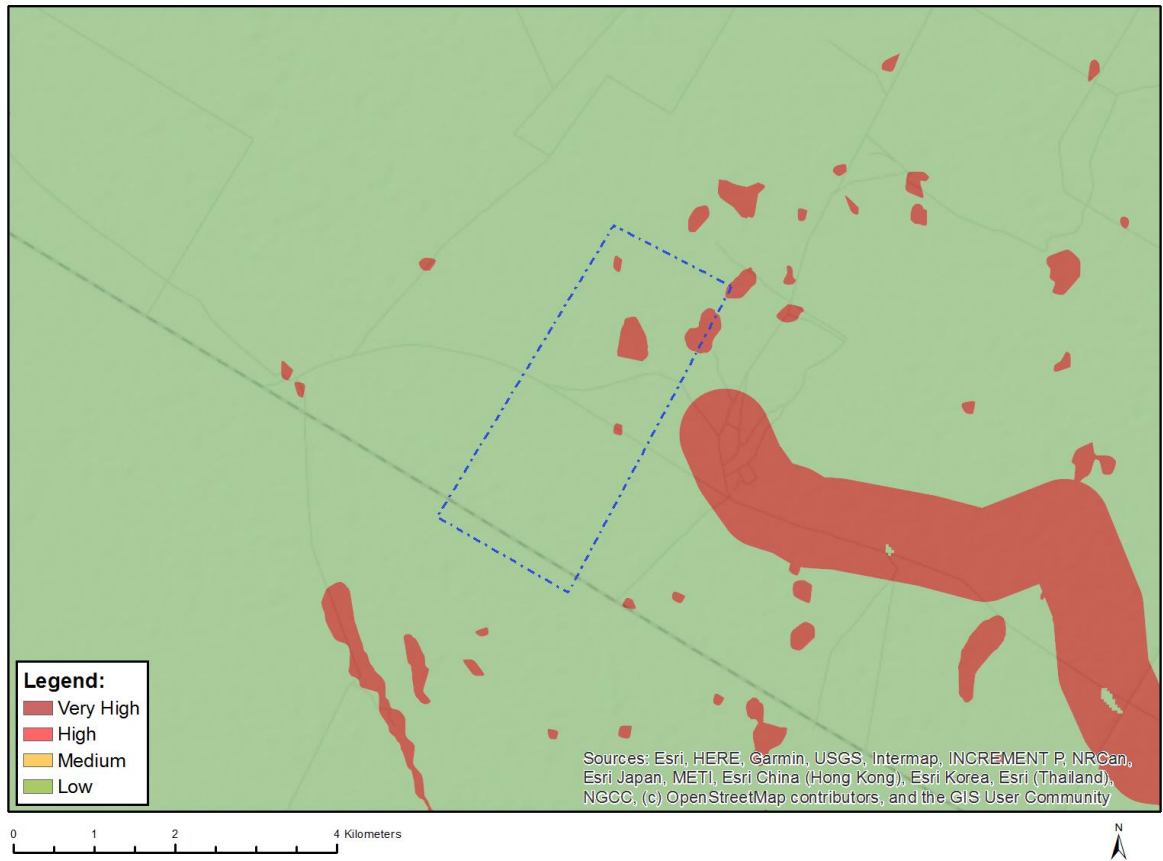
