Hostel residents 'living in fear'

'THERE'S A LOW-KEY POLITICAL WAR HERE'

RESIDENTS of Durban's volatile Kwa-Mashu hostel say they live in constant fear of being killed in what is believed to be a low-key political war.

Even more worrying, say residents who do not want to be identified, is that police have failed to make arrests in some of the more than 20 killings during this year alone.

The hostel, unlike the eight other hostels in Durban, is a squalid, overcrowded facility whose conditions are made worse by shacks built between the hostel blocks.

"You sleep today and in the morning, you wake up with a shack next to your room," said a resident.

"You don't know who is staying there or where they come from. Some of us are concerned because we have children," she said.

Residents say they cannot live elsewhere as they cannot afford rent.

Following the killing of

four ANC members at the hostel on November 7, the ANC's KwaZulu-Natal deputy chairman Willies Mchunu has blamed opposition parties.

Sphamandla Mpungose, Sizwe Shandu, Lucky Sibiya and Sibongiseni Biyela were shot dead at the hostel in a suspected political hit. They were said to have defected from the Inkatha Freedom Party (IFP).

for community safety, visited the hostel to assure residents that arrests into the murders would follow.

The hostel rooms are inhabited by one up to eight people. The tenants say they pay between R46 and R600 per month.

Last Thursday the ANC eThekwini region held a joint memorial service for the dead members ahead of their burial.

Although Mchunu did not

name individual parties, he said the ANC has always been targeted. But IFP provincial chairman Blessed Gwala hit back.

"The ANC has dismally failed as the government to put the real hostel issue to rest. It has failed to change

the hostels into family units and reduce crime.
Why would we kill people for defeat

for defecting from us? We also have many members who defected from the ANC and other parties," said Gwala.

Ubunye bamaHostela – an association formed by hostel residents – blames both the governing party and the opposition for the killings.

"We formed this association so that people could be united on the basis of their common needs and not be divided according to their political affiliations," he said.

GN R545 Activity 15: Physical alteration of undeveloped, vacant or derelict land or residential, retail, commercial, recreational, industrial or institutional use where the total area to be transformed is 20 hectares or more; and

GN R546 Activity 4c i (ee): The construction of a road wider than 4 metres with a reserve less than 13.5metres in North West in critical biodiversity areas (Terrestrial Type 1 and 2 and Aquatic Type 1) as identified in systematic biodiversity plans adopted by the competent authority or in bioregional plans

An application to carry out an Environmental Impact Assessment Process has been lodged with the Department of Environmental Affairs and was assigned **DEA Reference No:** 14/12/16/3/3/2/611.

Protesters demand councillor's resignation

CHAOS reigned in KwaNdengezi township, west of Durban, yesterday as hundreds of protesting residents barricaded roads with burning tyres and other debris.

Police had their hands full trying to open access roads leading to the township. At least one man was arrested and was expected to appear in the Pinetown Magistrate's Court on charges of public

Protesters were demanding that the government provide them with low-cost houses and called for the resignation of the local councillor Mduduzi Ngcobo.

They accused him of nepotism, corruption, intimidation and of being hugely responsible for the death of community activists, who are critical of his leadership style

Yesterday's protests came just days after the funeral of Mobeni Khwela, a community activist who was shot dead two weeks ago

KwaZulu-Natal police spokesman Thulani Zwane said the situation was under control

KwaNdengezi has been on a knife-edge for the past seven weeks.

It all began in early October when Thuli Ndlovu, an Abahlali baseMjondolo branch chairperson, was murdered at her home in KwaNdengezi.

She was critical of Ngcobo's leadership in the township and Ndlovu's supporters blamed the councillor for her death.

Three weeks ago angry community members burnt down three municipal vehicles and ransacked Ngcobo's constituency office. Last week Ngcobo said he and his family members had been threatened.

Sizwe Dlamini at yesterday's protest said: "We will never stop until this councillor is gone. We even told the ANC leaders during the funeral [of Khwela] on Saturday that we don't want him [Ngcobo]. We are tired of him because he is allocating jobs to his pals and RDP houses are sold by his close associates."

Ngcobo was not available for comment yesterday afternoon.
