2. THE CLAIMANTS HAVE BEEN WORKSHOPPED ON THE RESTITUTION OF LAND RIGHTS ACT NO.22 OF 1994 AS AMENDED

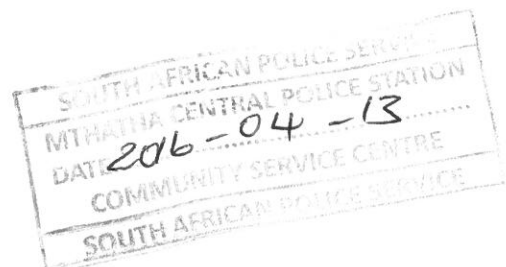
