<u>Proposed Fish Farm</u>: Madlankala Primary Co-Operative – Requets for details regarding the Water Extraction Pit

I refer to an email request from Mduduzi Mncwanga (Madlankala) to assist you in this matter and our subsequent telecom yesterday. The motivation for the Extraction Pit is as follows:

The Project will require a source of water to provide for its initial charge/fill (611,000 litres over the period of 12 month establishment as production is scaled up) and then on-going top up requirements (estimated to be 37,500 litres per month – less in winter more in summer).

Once the initial charge of water is in the system it will continuously recirculate through the Farm with zero environmental discharge. The only water loss that will occur will be evaporation, with a higher loss during hot windy summer months, and limited some mechanical loss (splashing and when fish are harvested) and Filtration System loss. The water loss will need to be replaced.

In considering how best to extract water from Lake Qubu we considered 2 Options:

#### 1. DIRECT EXTRACTION

This would entail running a surface/moveable pipe between the Farm and Lake. Because there is a significant amount of vegetation around the Lake it is difficult to access open water of a 1m depth. In addition the Lake Water Level will change over time and it would prove difficult and awkward to keep moving the extraction end of the pipe. Initial Charge will be drawn in this manner.

### 2. INDIRECT EXTRACTION / EXTRACTION PIT/WELL

This entails digging a Pit/Well into the Ground above the High Water Level to below the Water Table allowing water to seep into it and extract water from there. Top Up will be drawn in this way. The Pit would be fenced off to prevent unauthorised entry and mitigate the risk of Human/Animal Safety.

The 2<sup>nd</sup> Option is preferred.




# APPENDIX I. ENGINEERING PLANS, CROSS SECTION PLANS




