1. Decision

The Department has decided to amend the Environmental Authorisation (Gaut 002/09-10/N0586) and amended Environmental Authorisation (Gaut 006/15-16/E0172) issued on 02 June 2011 and 25 May 2016 respectively.

2. Amendments to the Environmental Authorisation

2.1.2 The township Extension numbers have been changed from:

- a) Cosmo City Extension 20 to Cosmo City Extensions 36, 37, 38, 39 and 41;
- b) Cosmo City Extension 22 to Cosmo City Extensions 33, 34 and 35:
- c) Cosmo City Extension 23 to Cosmo City Extensions 40, 42 and 44;
- d) Cosmo City Extension 25 to Cosmo City Extension 25:
- e) Cosmo City Extension 27 to Cosmo City Extensions 43, 45 and 46; and
- f) Cosmo City Extension 28 to Cosmo City Extensions 48 and 49.
- 2.1.3 Portion 21 of the Farm Nietgedacht 535-JQ has been removed from the property description for it has been expropriated by Eskom for the purpose of a regional electrical substation.
- 2.1.4 The Layout Plan (Cosmo20_25Lay D17/2018.11.20) included as Annexure 10 of the amendment application is approved/supported by the Department.



3. General Conditions

- 3.1 All conditions stipulated in the Environmental Authorisation (Gaut 002/09-10/N0586) and amended Environmental Authorisation (Gaut 006/15-16/E0172) issued on 02 June 2011 and 25 May 2016 respectively, that have not been amended by this amendment must be strictly adhered to.
- 3.2 A copy of this Addendum together with a copy of the initial Environmental Authorisation and all related Amended Environmental Authorisations must be kept at the property where the activities will be undertaken. The authorisations must be produced to any authorised official of the Department who requests to see them and must be made available for inspection by any employee or agent of the holder of the authorisation who works or undertakes work at the property. If it is not possible to keep a copy of this authorisation on site, then it must be kept at the offices of the site manager.
- 3.3 Where any of the applicant's contact details change, including the name of the responsible holder of the authorisation, the physical or postal address and/ or telephonic details, the applicant must follow an amendment process as prescribed in Chapter 5 of the NEMA Environmental Impact Assessment Regulations, 2014, by submitting an amendment application to the Department for consideration and decision making as soon as the new details become known to the applicant.
- 3.4 The holder of the authorisation must notify the Department, in writing within 7 days if a condition of this Addendum is not adhered to. Any notification in terms of this condition must be accompanied by reasons for the non-compliance.
- 3.5 Non-compliance with a condition of this Addendum may result in criminal prosecution or other actions provided for in NEMA and the Regulations.
- 3.6 The surface storm water management plan must be based on Sustainable Urban Drainage Systems (SUDS) Principles and consider source, local and regional controls.

ANNEXURE 1: REASON FOR DECISION

1. Background

The Department issued Environmental Authorisation (Gaut 002/09-10/N0586) and amended Environmental Authorisation (Gaut 006/15-16/E0172) on 02 June 2011 and 25 May 2016 respectively, for the proposed mixed use and mixed income residential development on Portions 2 and 21 (now Portion 21 to be excluded) of the Farm Nietgedacht 535-JQ to be known as Cosmo City Extensions 20-25 (to be amended to X 33-49); City of Johannesburg Metropolitan Municipality.

The applicant appointed LEAP to undertake the amendment application process.

2. Information Considered in Making the Decision

In reaching its decision, the Department took, inter alia, the following into consideration:

- 2.1 The information contained in the amendment application received by this Department on 14 February 2019.
- 2.2 The objectives and requirements of relevant legislation, policies and guidelines, including Section 2 of the National Environmental Management Act, 1998 (Act No. 107 of 1998) (as amended).
- 2.3 The Initial EA (Gaut 002/09-10/N0586) and amended EA (Gaut 006/15-16/E0172) issued on 02 June 2011 and 25 May 2016 respectively.

3. Key Factors Considered in Making the Decision

All information presented to the Department was taken into account in the Department's consideration of the application. A summary of the issues which, in the Department's view, were of the most significance is set out below:

- 3.1 The amendment does not deviate substantially from the initial and Amended Environmental Authorisations: and
- 3.2 The scope of the application and rights of Interested and Affected parties.

4. Findings

After consideration of the information and factors listed above, the Department made the following findings:

- 4.1 All other conditions set out in the Environmental Authorisation (Gaut 002/09-10/N0586) and amended Environmental Authorisation (Gaut 006/15-16/E0172) issued on 02 June 2011 and 25 May 2016 respectively, that have not been amended by this amendment still stand and are to be adhered to.
- 4.2 The proposed amendments are of administrative in nature without any change in scope of the activity and have no significant impact on the rights of Interested and Affected Parties (I&APs) and the environment.

In view of the above, this Department is of the opinion that the amendment would not result in a negative environmental impact that would conflict with the general objectives and principles of integrated environmental management laid down in Chapter 5 of the NEMA. The environmental authorisation is accordingly amended.
