LAND USE NOT LISTED: PROPOSED PROVISION OF INTERNAL WATER AND SEWAGE NETWORK FOR HAMMANSKRAAL EXTENSION 10, CITY OF TSHWANE METROPOLITAN MUNICIPALITY

The enquiry received by the Department on 31 May 2017 has reference.

The proposal entails establishment of internal water and sewage network and toilet top structures on the afore-mentioned site. The proposed site falls within an urban built-up area and is not affected by any watercourses. Part of the proposed site has been developed for informal housing purposes.

Based on the above and the information submitted, the proposed activity is not listed in terms of Listing Notice 1, 2 and 3 of Environmental Impact Assessment Regulations, 2014 (as amended), published under the National Environmental Management Act (NEMA), 1998 (Act No. 107 of 1998, as amended) and therefore does not legally require Environmental Authorisation from the Department.

Although authorisation, in terms of NEMA, is not required for this activity, all relevant legislation and requirements of other government departments (i.e. National, Provincial and Local) must still be complied with.
