Regarding AEL submission, it will not serve any purpose to submit an application if the WML has not been issued. Section 36(5) triggered AEL applications can only be processed after EA; WML or Valid Mining Rights/Order has been acquired. Any AEL application without such would be sent back, just like what we did with one of your application. My understanding is that proposed Queenstown Incinerator has not been issued with WML. Therefore, it would be sent back too.
