#### 1. INTRODUCTION

The Public Participation is a process done in line with the National Environmental Management Act No. 107 of 1998 (as amended) and the Environmental assessment regulations 2010. In addition to the above mentioned legislation, the process is further outlined in the public participation guideline (10 October 2012). In a nutshell the Public Participation process is a legal framework that ensures public and stakeholder participation during the stages of acquiring authorisation for a development, thus in this case. The comments and issues raised by I&APs and stakeholders form part of the decision making process. The Public Participation Process is outlined in Chapter 6 of Environmental Impact Assessment regulations 2010(as amended).

#### 2. BACKGROUND

The proposed development is the establishment of a landfill site to service the following three areas, Harrismith, Kestel and Phuthaditjhaba.

It is proposed that the new landfill site will have the following facilities:

- Recycling facility (and a Buy-Back center).
- Compost facility
- Inert waste disposal facility

The type of waste to be landfilled is general waste; no hazardous waste will be expected to the landfill site. The proposed waste disposal site is classified as a General (G) Waste Landfill site. As per the design report conducted by All Green Consultants, the size of the landfill site is classified as large (L). Furthermore there is a potential that the waste disposal site will generate leachate, which classifies the site as a B plus (B+) waste disposal facility, in turn this entails that a leachate management system will be required for the landfill site.

The physical footprint of the proposed landfill site is estimated to be approximately 20 hectares. Subdivisions and rezoning processed will be done by the applicant. The design report calculates the life span for the landfill site facility to be approximately 20 years.

On 19<sup>th</sup> September 2014, Tholoana Consulting submitted an application of intent to conduct a Scoping/EIA process pursuant Waste Management License for the proposed disposal site. An acknowledgement and acceptance of the application from the Department of Economic Development, Tourism and Environmental Affairs Free State province (DETEA) was received on the 2<sup>nd</sup> October 2014. The final Scoping Report was submitted to DETEA Free State Province on the 06<sup>th</sup> May 2015. In response the acceptance of the Scoping report was received from DETEA Free State province on the 05<sup>th</sup> June 2015.

#### 3. THE PUBLIC PARTICIPATION PROCESS FOR THE PROPOSED MALUTI-A-PHOFUNG LANDFLL SITE

The following Public Participation Process was followed during the Scoping phase of the proposed Maluti-A-Phofung Landfill site:

#### 3.1 PHASE 1: SCOPING PHASE – I&AP INVITATION

The first Public Participation process was aimed at identifying Interested or Affected parties. Invitations were done via

- A newspaper advert in the Eastern Free State Issues (13<sup>th</sup> November 2014). This newspaper reaches the following areas: Bethlehem, QwaQwa, Harrismith, Ficksburg, Fouriesburg, Senekal, Kestel & Paul Roux. Attached Appendix 1.
- Notification Posters were placed on site and along the proposed access route (13<sup>th</sup> November 2014), and notification Posters were placed at Public facilities (Libraries Phuthaditjhaba, Kestel, Harrismith and Clinics). Appendix 2.
- The Background information Document was further sent to Department of Water and Sanitation, Local Authority and the Free State Heritage Agency. Appendix 3

#### 3.2 PHASE 2: SCOPING PHASE – AVAILABILITY OF DRAFT SCOPING REPORT.

The second Public Participation Process of the scoping phase for the availability of the Draft Scoping Report was done in the following manner

- The availability of the Draft Scoping Report was advertised on the Eastern Free State Issue (29<sup>th</sup> January 2015), which reaches: Bethlehem, QwaQwa, Harrismith, Ficksburg, Fouriesburg, Senekal, Kestel & Paul Roux. Appendix 1.
- Notifications (Poster), with hard copies of the report were delivered at Phuthaditjhaba, Kestel, Intabazwe Public Library, Sasol Makwane Garage Library and Harrismith Library. Appendix 2.
- Hard copies were delivered to the Free State Heritage Agency, Local Authority, Councillors and DWA. Appendix 3.
- Knock and drops of notifications (pamphlets) were done to households in close proximity of the proposed location. Appendix 4
- Two meetings were held with the Department of Water and Sanitation officials, the dates respectively (on 2<sup>nd</sup> December 2014 and 16<sup>th</sup> February 2015). Further to that a presentation was done the Wilge Forum held at Reitz on the 19<sup>th</sup> May 2015. Appendix 3

The comments received from I&APs and the Free State Heritage Agency are contained in the issues and response report that forms part of this assessment. Based on submissions done to DETEA Free State province, the Scoping Report was approved on 5<sup>th</sup> June 2015.

#### 3.3 PHASE 3: EIA PHASE – AVAILABILITY OF DRAFT EIR AND DRAFT EMPr.

The third Public Participation Process for the availability of the Draft Environmental Impact Assessment Report and Draft Environmental Management Programme was carried out as follows:

- Newspaper advert in the Eastern Free State Issue was done on the 2<sup>nd</sup> July 2015. The newspaper reaches the following areas: Bethlehem, QwaQwa, Harrismith, Ficksburg, Fouriesburg, Senekal, Kestel & Paul Roux. Appendix 1.
- Notifications (Poster), with hard copies of the report were delivered at Phuthaditjhaba, Kestel, Intabazwe Public Library, and Harrismith Library. Appendix 2
- Hard copies were delivered to the Free State Heritage Agency, Local Authority and Councillors. Appendix 3.
- > I&AP notifications were done via email and post on the 1 July 2015. Appendix 4.

#### 3.4 MALUTI-A-PHOFUNG DISPOSAL SITE ISSUES AND RESPONSE REPORT

The Issues and Response report consolidates all comments received from the I&APs, Stakeholders and the Local Authority. Furthermore all responses given to the issues raised are captured on the responses column of the report. The summary of comments received during the Scoping phase Public Participation Process is as follows:

- Ms Rethabile Moloi requested for more detailed information pertaining to the proposed recycling facility as she had an interest in the project.
- The following comments were received from the Local authority (Maluti-A-Phofung Env and Waste Management Manager).
  - The access road to the landfill site is gravel (There is a need for the municipality to upgrade the road. The road would be budgeted for in the next financial year and will be included in the IDP of the municipality).

- The budget is not enough for the implementation of the project. (This project will be implemented in phases; the municipality has already developed a business plan for addition MIG funding to accommodate other phases)
- The land is not zoned for this purpose (a request was made to appoint service provider to assist on the application for the subdivision and rezoning of the land. It is recommended that the implementation of developing a landfill site be carried forward while waiting for approval on the rezoning).
- The provision of water and electricity were also identified as a challenge ( The municipality would make provision for the identified infrastructure)
- This was followed by a comment from Cllr. Betsie Mofokeng, which was in line with the proposed access roads to the site. The access roads are currently unpaved, thus as the result of increased use to the disposal site, these roads will generate dust which impacts on the houses along the access roads. The request was that an option of paving the roads should be looked at; however this was not raised in a manner to objecting the proposed landfill site.
- The other comment received from Mr Tefo Simon, was in line with interest in terms of business opportunities from the proposed landfill site establishment.
- Amendments were requested by the Free State Heritage Agency on the Heritage Impact Assessment, with a an indication that a Paleontological Impact Assessment needs to be carried out for the proposed landfill site as it is a standard requirement within the Free State Province.

The following comments were received during the EIA phase (availability of Draft EIR and Draft EMPr), the following comments were received:

- Cllr Betsie Mofokeng requested the design layout of the proposed road, as per the Deign report page 2-12
- Ms Keagalaletsa Gobolawamang requested a soft copy of the Draft EIA and Draft EMPr.
- Mr Tefo Simon Mantje sent a letter requesting for funding their co-operative.


