Your revised application J12585/TP/DWA01 dated 27 January 2015 submitted on your behalf by AECOM (Pty) Ltd consultants has reference.

The revised application has been duly assessed and the Department confirms that the water use still falls within the ambit of the General Authorisation as per Government Notice 665 dated 6 September 2013, as published in Government Gazette No. 36820.

Please be advised that the revised authorization supersedes and replaces the previous confirmation letter for General Authorization issued to you on 28 January 2014.

7. Groundwater Monitoring

- 7.1. The applicant shall develop a groundwater monitoring programme to measure the probable impacts of seepage through the oxidation and/or evaporation ponds into the underlain groundwater resource and submit this programme to the Department and the BG CMA within the 3 months of the date of this letter.
- 7.2. The holder of this authorisation shall take special note of the GEOSS Report No.2013/09-03 paragraph 1.10 recommendations for implementation as to protect the groundwater resource under its monitoring protocol.
- 7.3. The holder of this authorisation must furthermore ensure that all 3 primary ponds, existing and planned are lined as indicated and committed in the AECOM report dated 27 January 2015, Ref: J12585/ TP/DWA 01, insofar as to protect the groundwater from any potential contamination.
- 8. A copy of the General Authorisations is attached for your attention and must be adhere to.
- 9. The conditions of this authorisation shall be brought to the attention of all persons (employees, sub-consultants, contractors etc.) associated with the undertaking of this activity and the authorised party shall take such measures that are necessary to bind such persons to these conditions.
- Should the circumstances regarding your water use change, you are kindly requested
 to approach this office for assistance in ascertaining the requirements to authorize such
 changed water use.
- 11. The Department or BG CMA will approach you should the General Authorisations be altered to such an extent that it may impact on the authorization of your water use at future revisions of the General Authorisations, or should compulsory licensing be introduced.

Please take note that if you do not comply with the conditions of the General Authorisation your water use may be regarded as unlawful and hence you may be required to apply for a water use licence in terms of section 41 of the National Water Act, Act 36 of 1998.
