# ENVIRONMENTAL MANAGEMENT PLAN FOR PROPOSED BATHYMETRY SURVEY AND SEABED SEDIMENT SAMPLING IN BLOCK 11B/12B OFF THE SOUTH COAST OF SOUTH AFRICA: NOTICE OF EMP AND PUBLIC PARTICIPATION PROCESS

This letter and attached Background Information Document (BID) provides information on proposed oil and gas exploration activities in Block 11B/12B off the South Coast of South Africa.

Total E and P South Africa B.V. (herewith referred to as "TEPSA") is the operator and holder of an existing Exploration Right for undertaking seismic surveys and exploration well drilling in Block 11B/12B off the South Coast of South Africa. Block 11B/12B is located approximately 130 km offshore between Mossel Bay and St Francis Bay in water depths of between 500 m and 2 000 m.

TEPSA is proposing to undertake additional exploration activities including bathymetry surveys and seabed sediment sampling activities over selected areas of the licence blocks at various times over the Exploration Right validity period. In terms of the MPRDA, TEPSA is required to apply for an amendment to their approved Environmental Management Programme (EMPr) in order to undertake the proposed sampling activities.

A Background Information Document (BID) providing preliminary project detail has been compiled and is available for a 21-day review and comment period from **5 November 2014 to 26 November 2014**. A copy of the BID is enclosed for your information.

If you or your organisation wish to register as an Interested and/or Affected Party and/or wish to raise any issues or concerns regarding the proposed project, please make use of the attached Response Form and forward it to Mandy Kula of CCA at the contact details below. 

# PROPOSED BATHYMETRY SURVEY AND SEABED SEDIMENT SAMPLING IN BLOCK 11B/12B OFF THE SOUTH COAST OF SOUTH AFRICA

# BACKGROUND INFORMATION DOCUMENT NOVEMBER 2014

### 1. PROJECT BACKGROUND




Figure 1: Locality of Block 11B/12B off the South Coast of South Africa.

TOTAL Exploration & Production South Africa B.V. (hereafter referred to as "TEPSA") is the operator and holder of an existing Exploration Right for undertaking seismic surveys and exploration well drilling in Block 11B/12B. This block is approximately 18 734 km² in extent and is located off the South Coast of South Africa roughly between Mossel Bay and St Francis Bay, approximately 130 km offshore in water depths of between 500 m and 2 000 m (see Figure 1). TEPSA took over as operator of Block 11B/12B from CNR International (South Africa) Limited (hereafter referred to as "CNR"), which has retained a 50% working interest in the block.

Prior to TEPSA's involvement, CNR obtained the Exploration Right for Block 11B/12B in terms of the Mineral and Petroleum Resources Development Act, 2002 (No. 28 of 2002) (MPRDA). As part of the process of applying for the Exploration Right, an Environmental Management Programme (EMPr) was compiled and approved for the undertaking of seismic surveys and exploration drilling within the licence area. Exploration drilling also received Environmental Authorisation under the National Environmental Management Act, 1998 (No. 107 of 1998) (NEMA), as amended. Under the aforementioned Exploration Right and Environmental Authorisation, both seismic surveying and exploration well drilling have been undertaken within the licence area to date.

TEPSA is now proposing to undertake additional exploration activities, including a bathymetry survey and seabed sediment sampling over selected areas of the licence block at various times over the Exploration Right validity period. TEPSA is thus required to apply for an amendment of the approved EMPr in order to undertake these proposed activities.

#### 2. PURPOSE OF THIS DOCUMENT

This Background Information Document (BID) serves to:

 inform interested and affected parties (I&APs) about the legislative process that TEPSA is required to comply with;

BID

- provide a description of the proposed bathymetry survey and seabed sediment sampling activities;
- describe the study process;
- present the specialist consultants' scope of work; and
- describe how I&APs can participate in the process.

### 3. WHO ARE THE CONSULTANTS?

CCA Environmental (Pty) Ltd (CCA) has been appointed by TEPSA to undertake the necessary amendment application process in terms of the MPRDA.

### 4. WHAT AUTHORISATION IS REQUIRED?

The proposed additional exploration activities in Block 11B/12B requires authorisation in terms of the MPRDA. To proceed with these activities requires an amendment application in terms of Sections 29(6) and 102 of the MPRDA. An EMPr Addendum covering the proposed bathymetry survey and seabed sediment sampling must be compiled and submitted to PASA for consideration and approved by the Minister of Mineral Resources (or the delegated authority).

Since the proposed activities would not result in the removal of more than 5 m³ of material from the seabed, the proposed additional exploration activities do not trigger any activity listed under NEMA. Thus no Environmental Authorisation is required for these activities.

## 5. PROJECT OVERVIEW

The proposed exploration activities would include a bathymetry survey and seabed sediment sampling. These activities provide for the rapid collection of data and provide critical information regarding the exploration potential of the licence area and would guide future exploration efforts. These exploration activities are described in more detail below.

The proposed exploration activities are likely to occur during the entire exploration permit period.

#### 5.1 BATHYMETRY SURVEY

#### 5.1.1 Introduction




Figure 2: Illustration of a vessel using multi-beam depth/echo sounders (http://www.gns.cri.nz/).

There are a number of different sonar surveying tools for investigating the structure of the ocean bed sediment layers (including depth sounders, side scan sonar, bottom profilers and multi-beam bathymetry). Multi-beam bathymetry surveying is the most likely technique that would be used (see Figure 2). However, the other techniques may also need to be considered in view of the tough operating conditions across the block.

## 5.1.2 Methodology

The survey vessel would be equipped with a multi-beam echo sounder to obtain swath bathymetry and a sub-bottom profiler to image the seabed and the near surface geology. The multi-beam system provides depth sounding information on either side of the vessel's track across a swath width of approximately two times the water depth. Although this type of survey typically does not require the vessel to tow any cables, it is "restricted in its ability to manoeuvre" due to the operational nature of this work.

Typical multi-beam echo sounder emits a fan of acoustic beams from a transducer at frequencies ranging from 10 kHz to 200 kHz and typically produces sound levels in the order of 207 db re  $1\mu$ Pa at 1m (approximately 1 000 times less than a seismic survey). A typical sub-bottom profiler emits an acoustic pulse from a transducer at frequencies ranging from 3 kHz to 40 kHz and typically produces sound levels in the order of 206 db re  $1\mu$ Pa at 1m.

### 5.1.3 Location, extent and duration

The multi-beam bathymetry survey would be undertaken in small specific areas across the block. It is anticipated that each data acquisition operation would take in the order of three to four weeks to complete.

## 5.2 SEABED SEDIMENT SAMPLING

#### 5.2.1 Introduction

The seabed sediment sampling programme would involve the collection of sediment samples for laboratory geochemical analyses in order to determine if there is any naturally occurring hydrocarbon seepage at the seabed. Piston and box coring (or grab samples) techniques would be used to collect seabed sediment samples. These are described below.

#### 5.2.1 Piston coring




Figure 3: Schematic of a drop piston core operation at the seabed (from TDI Brooks).

Piston core (or drop core) is one of the more common seafloor sampling methods. A piston coring device with ultra-short baseline (USBL) navigation would be used to accurately target and collect the seafloor samples (see Figure 3). The programme would likely utilise a piston corer (approximately 1 000 kg) capable of retrieving sediment samples that are up to a maximum of 6 m in length and 0.032 m in diameter.

The piston corer is lowered over the side of the survey vessel on a line and allowed to free fall from about 3 m above the seafloor to allow better penetration (see Figure 3-A). As the trigger weight hits the bottom (Figure 3-B), it releases the weight on the trigger arm and the corer is released to "free-fall" the 3 m distance to the bottom (Figure 3-B & C), forcing the core barrel to travel down over the piston into the sediment (Figure 3-D). The movement of the core barrel over the piston creates suction below the piston and expels the water out the top of the corer. When forward momentum of the core has stopped, a slow pull-out of the winch commences. This suction triggers the separation of the top and bottom sections of the piston (Figure 3-E). The corer and sample are then slowly pulled from the seafloor and retrieved.

The recovered cores are visually examined at the surface for indications of hydrocarbons (gas hydrate, gas parting or oil staining) and sub-samples retained for further geochemical analysis in an onshore laboratory.

### 5.2.2 Box coring / grab samples

The box corer (see Figure 4) is deployed from a survey vessel by lowering it vertically to the seabed. At the seabed the instrument is triggered by a trip as the main coring stem passes through its frame. The stem has a weight of up to 800 kg to aid penetration. While pulling the corer out of the sediment a spade swings underneath the sample to prevent loss. When hauled back on board, the spade is under the box. The recovered sample is completely enclosed after sampling, reducing the loss of finer materials during recovery. Stainless steel doors, kept open during the deployment to reduce any "bow-wave effect" during sampling, are triggered on sampling and remain tightly closed, sealing the sampled water from that of the water column. On recovery, the sample can be processed directly through the large access doors or via the removal of the box completely, together with its cutting blade. A spare box and spade can then be added, ready for an immediate redeployment.




Figure 5: Grab sampler (Source: http://www.jochemnet.de/fiu/OCB3043\_35.html).

Grab sampling (see Figure 5) is the simple process of bringing up surface sediments from the seafloor. This method, however, cannot be used to characterise different sedimentary layers since it is unable to penetrate the ground to depth and a mixture of sediments is produced. Once the grab sampler is launched, the jaws open and it descends to the seafloor. A spring closes the jaws and they trap sediments or loose substrate. The grab sampler is then brought up to the surface where its contents are studied in detail.

### 5.2.3 Location, extent and duration

The seabed sediment sampling would be undertaken in small specific areas across the block. Each individual piston and box core would have a maximum volume of 0.02 m³ and 0.012 m³, respectively. It should be noted that the total cumulative volume of material that would be removed from the seabed would be less than 5 m³.

It is anticipated that the seafloor sampling would take in the order of three to five weeks to complete per sampling campaign.

#### 5.3 EXCLUSION ZONES

Under the Convention on the International Regulations for Preventing Collisions at Sea (COLREGS, 1972, Part B, Rule 18), survey vessels that are engaged in surveying are defined as "vessel restricted in its ability to manoeuvre" which requires that power-driven and sailing vessels give way to a vessel restricted in its ability to manoeuvre. Vessels engaged in fishing shall, so far as possible, keep out of the way of survey operations. Furthermore, under the Marine Traffic Act, 1981 (No. 2 of 1981), a vessel used for the purpose of exploiting the seabed falls under the definition of an "offshore installation" and as such it is protected by a 500 m safety zone. It is an offence for an unauthorised vessel to enter the safety zone.

The 500 m safety zone and proposed safe operational limits would be communicated to key stakeholders well in advance of the proposed exploration programme. Notices to Mariners will also be communicated through the proper channels.

### 6. KEY ISSUES TO BE INVESTIGATED

The key focus areas that have been identified, and that will be addressed in the EMPr Addendum for the proposed exploration activities, include:

- Noise effects on marine fauna from the bathymetry survey and seabed sediment sampling;
- Disturbance and loss of benthic macrofauna habitat due to the removal of sediment samples;

- Effects on the fishing industry due to temporary displacement of fishing activities and effects on fish behaviour due to noise;
- Interference with marine traffic; and
- Waste discharge to sea and atmosphere.

#### 7. THE STUDY PROCESS




Figure 6: Study process for EMPr Addendum.

The EMPr Addendum study process is shown in Figure 6.

### 7.1 INITIAL PUBLIC PARTICIPATION

The objective of the initial public participation process is to ensure that I&APs are notified of the proposed project, given a reasonable opportunity to register on the project database and to provide initial comments. Steps undertaken during this phase include:

- I&AP identification using TEPSA's existing database for licence area, as well as other databases of previous studies undertaken in the area;
- Advertising in regional newspapers, including Cape Times (Western Cape), Herald (Eastern Cape),
   Die Burger (Western Cape) and Die Burger (Eastern Cape); and
- Distribution of the BID for a 21-day comment and I&AP registration period.

Any comments on the BID will be included and responded to in the draft EMPr Addendum (see Section 7.3).

#### 7.2 SPECIALIST STUDIES

During this phase specialists will be appointed to address key issues relevant to the proposed project that require further investigation. Specialists will gather data that is relevant to identifying and assessing environmental impacts that may occur as a result of the project. These impacts would be assessed according to pre-defined rating scales. Specialists would also recommend appropriate mitigation or control measures to minimise potential impacts or enhance potential benefits. The specialist studies identified thus far are listed below.

#### Marine Faunal Assessment (Pisces Environmental Services: Dr Andrea Pulfrich)

- Describe the local marine fauna in and around the licence area;
- Determine the primary risks to the marine environment associated with the proposed bathymetry survey and seabed sediment sampling;
- Identify, describe and assess the significance of potential impacts of the proposed bathymetry survey and seabed sediment sampling activities on the local marine fauna (including the benthic and pelagic environments); and
- Identify practicable mitigation measures to reduce any negative impacts on marine fauna.

#### Fisheries Assessment (CapFish SA: Dave Japp & Sarah Wilkinson)

- Describe the fishing activities expected in and around the licence area;
- Undertake a spatial and temporal assessment of expected fishing effort and catch per sector in the proposed survey / sampling area;
- Determine the primary risks to the different fishing sectors associated with the proposed bathymetry survey and seabed sediment sampling;
- Assess the impact of the proposed safety zones around the sampling support vessel on the fishing
  activities in terms of estimated catch and effort and due to the loss of fishing grounds, as well as the
  effect on fish behaviour; and
- Identify practicable mitigation measures to reduce any negative impacts on the fishing industry.

#### 7.3 INTEGRATION AND ASSESSMENT

The specialist information and other relevant information will be integrated into a draft EMPr Addendum. Many of the issues associated with bathymetry survey and seabed sediment sampling are generic in nature and will be assessed based on previous exploration programmes off the coast of South Africa and the Generic EMPr prepared for oil and gas in South Africa.

The EMPr Addendum will be published for a 30-day I&AP review and comment period. After closure of the comment period, the report will be updated, including a Comments and Responses Report, and then submitted to PASA for consideration and approved by the Minister of Mineral Resources (or the delegated authority).

# Numsa pleads for time to defend its case

THE National Union of Metalworkers of South Africa (Numsa) will suffer irreversible damage if Cosatu's central executive committee (CEC) kicks it out of the federation on Friday, and its right to appeal the decision will be all but meaningless

This is Numsa's argument in court papers filed as part of its urgent interdict to stop Friday's special CEC from taking any action against it.

The union, which is Cosatu's largest affiliate, believes that the meeting will not be fair because Cosatu and the majority of its affiliates have already made up their minds to expel it, despite the fact that it has not been given a chance to make a case to the CEC why it should not be sanctioned.

Numsa says in the documents it had been given only seven working days to prepare since the matter was put on the CEC agenda.

In the 59-page application, the union says Cosatu has a vendetta against it. The union lists numerous occasions it believes the federation has failed to abide by its constitution and follow due process to settle its political dispute with the union.

Numsa says the grudge stems from its successful court action against Cosatu, which forced it to lift the suspension of Cosatu general secretary Zwelinzima Vavi.

The papers further allege that Cosatu has been attempting to excise Numsa since February, when a special CEC took the preliminary view that Numsa should be suspended or expelled.


"To the extent that the string of meetings commencing in February 2014 silence (Numsa) as a vocal trade union and/or to settle political scores, it is likely that this decision, once it has been acted upon, will not be capable of reversal.

"Should this court fail to intervene, it is unlikely that this prejudice may ever be cured and indeed (Numsa) will be unable to seek substantive relief in proceedings in due course," the document reads.

Numsa is facing suspension or expulsion for a host of reasons, including accusations of "poaching" members of sister affiliates.

Although it can appeal if it is expelled – to a Cosatu congress, this would be only next year. If suspended, it would still have to pay affiliation fees to Cosatu, despite being barred from participating in the federation's structures.

Numsa has asked the court to restrain the CEC from taking any action against it, pending Cosatu's compliance with its constitution, or that it be given adequate time to prepare its defence.

# 'Game-changing' minimum wage to be mandatory

SOUTH AFRICA should have a set of cast-iron agreements about a mandatory national minimum wage by July.

This was agreed at yesterday's Labour Relations Indaba, hosted by the National Economic Development and Labour Council (Nedlac).

implementing the policy. The investigating group's work is meant to be concluded by July.

This will mark the first time that South Africa has

the government agreed in implemented a nationally regulated minimum wage, though the Department of Labour currently determines minimum wage scales in the mostvulnerable sectors.

Deputy President Cyril Ramaphosa, who chaired the indaba, said agreement in principle on the implementation of a national minimum wage was premised on recognition among all constituencies that wages were the most important source of income to most citizens. Its implementation would

be aimed at ensuring workers a sustainable lifestyle, but taking into account competitiveness and the sustainability of businesses as well.

The absence of a minimum wage undermined the possibilities of social cohesion, Ramaphosa said, adding that a history of low wages was the higgest contributor to inequality. South Africa is widely acknowledged as the most unequal society in the world.

Ramaphosa said the national minimum wage would be aimed at providing social protection to the most vulnerable workers.

Sandile Businessman Zungu said that the modalities should include recommenda-

tions relating to whether there would be any exclusions to the minimum wage, which might apply to small and medium enterprises. General secretary Zwelinz-

ima Vavi said Cosatu would be asking whether the minimum wage would replace collective bargaining. But he said the agreement represented a "game-changer in labour relations" in the country.

# Ministry committed to prohibiting 'brutal' evictions

THE Human Settlements Department wants a moratorium on "brutal" evictions countrywide in the wake of the Lwandle removals. This follows a report of a

inquiry that Human Settlements Minister Lindiwe Sisulu had ordered after the Lwandle evictions.

The inquiry found the

eviction had been illegal because it had been carried out using an interdict preventing occupation of the land and not an eviction order. It recommended, among other remedies, a legislative review of the Prevention of Illegal Eviction from and Unlawful Occupation of Land Act.

Sisulu's legal adviser, Menzi Simelane, told a briefing of the National Assembly portfolio committee on human settlements yesterday it seemed a "misapplication" of the court order had been deliberate and part of a co-ordinated effort to remove people from the SA National Roads Agency-owned (Sanral) land.

Neither Sanral nor the

organisations that testified at the inquiry had provided evidence that there was urgency in removing the people from

the land.

He said although the department had monitored evictions elsewhere, what had happened in Lwandle "was different" because a "court interdict had been illegally converted into an eviction order".

"We will proceed to argue and seek the rest of the country to support actions by the department to have a moratorium on evictions.

"An eviction is a brutal process because it is something that can be done forcefully, but only if a court authorises it under circumstances that a court itself considered appropriate," Simelane said.

He assured the department would engage with all the government entities involved in the eviction to ensure it was avoided in the future.

DA MP Makashule Gana

said a moratorium on evictions would have to be carefully considered because it could open up the country to more land invasions.

National Freedom Party MP Maliyakhe Shelembe said he would have expected the inquiry report would recommend whoever misapplied the court order should apologise to the affected families.



You could write the banter from anywhere: "They lost by how much?" "Two-nil, bru! And we thought they were a decent side . . . ' The Australians started this conversation them-

selves at the weekend when Ben Cutting said: "... for us to try to bring the focus back on home soil and start with a win would get the ball rolling for [the test squad] when they get back next week.

"Dit werk nog, maar dit is nie in 'n betroubare toestand nie. Daar is ook 'n kategorie waar baie infrastruktuur nie funksioneer nie en ander netwerke gebruik moet word.'

Instandhoudingswerk wat uitgestel word, is volgens Barnard deel van die probleem. "Sommige infrastruktuur is in so 'n toestand dat dit baie krag-

oorsaak. Maandagaand was die helfte van Johannesburg sonder krag en almal dink outomaties dit is weens beurtkrag. Dit was nie beurtkrag

Hy het verduidelik **Dr. Wolsey** dat wanneer beurt-Barnard krag toegepas word, die verspreidingsinfrastruk-
