Project Proposal: Ash Mining has lodged a Mining Permit and Environmental Authorisation application to the Department of Mineral Resources and Energy (DMRE) to mine for Chrome Ore, PGM, Nickel, Gold Ore, Silver Ore, Iron Ore, Manganese Ore, and Vanadium in terms of Section 27(2) of the Mineral and Petroleum Resource Development Act, 28 of 2002 (MPRDA). WTP Environmental Consulting (Pty) Ltd was appointed as the Environmental Assessment Practitioners (EAP) to conduct the Environmental Impact Assessment (EIA) process.

Location: The applicant intends to mine on certain portion of Farm Brakkuil 154 JP, situated within the magisterial district of Rustenburg, North West Province.

Application for Environmental Authorization: Ash Mining Pty Ltd is required to obtain Environmental Authorization (EA) in support of its mining permit and has accordingly submitted an application an Environmental Authorization to the DMRE accepted on the 2nd November 2022. The proposed activities will require environmental authorization in terms of the Environmental Impact Assessment (EIA) Regulations (GN No. R324, R325, R326, R327 as amended on 07 April 2017) of the National Environmental Management Act (NEMA) (No. 107 of 1998) as amended. **The proposed Mining Permit activities triggers Activity 21, 22 and 27 of Listing Notice 1 (GN R 327)** and based on the triggered activities, the application will be subject to a Basic Assessment Process.

Opportunity to participate: Chapter 6 of NEMA requires that a full and transparent Public Participation Process (PPP) must be conducted for any listed activities. An initial Background Information Document provides a summary of the proposed project and EIA process and is available on request from the appointed EAP (Contact Details below)- please contact us in order to receive the document.

Interested and Affected Parties (IAPs) are invited to register and/or provide written comments. All comments should be submitted together with their name, contact details (preferred method of communication e.g email) and an indication of any direct business, financial, personal or other interest that they may have in the application to the contact person indicated below. Once registered IAPs will be informed of further opportunities to comment on the Basic Assessment Reports.

Public Participation: The purpose of the public participation process is to inform Interested and Affected Parties (&IAPs) regarding the proposed mining permit activities as well as the environmental process. I&APs will also be provided with the opportunity to comment on and contribute to the identification of environmental impacts of the proposed mining activities (27 Feb to 27 Mar 2023). Registered IAPs will be granted an opportunity to review and comment on the Draft Basic Assessment Report (BAR). Copies of the report will be made available on request to registered I&APs for a review period to be stated on the report.
