Eggbert is proposing the construction of 4 environmentally controlled chicken breeder houses with the capacity to hold up to 48 000 breeders per house on Glenleitch 871 HT formally known as Bedrog 607 HT situated in the Zululand District within Abaqulusi Local Municipality. The need for a Basic Assessment is triggered by Listing 1; activity 5(ii) in GN R983 dated 04 December 2014 namely the development and related operation of facilities or infrastructure for the concentration of (ii) more than 5 000 poultry per facility situated outside an urban area, excluding chicks younger than 20 days. (iv) more than 25 000 chicks younger than 20 days per facility situated outside an urban area. The entire facility will able to house up to 192 000 breeder birds.

The project will entail the following:

Earthworks and clearing of vegetation (plantation and planted pasture) on the site for 4 breeder houses.

Construction of 4 environmentally controlled chicken breeder houses (111m x 15m) Construction of an egg house (24m x 24m) with a generator room (4m x 4m)

The site will be fenced off with a 2.4m high electric fence.


