
PURPOSE OF THIS DOCUMENT

Thelsa Trading & Projects (Pty) Ltd has been appointed by Ukubhukuda Trading & Project 165 CC to conduct an Environmental Impact Assessment Process in accordance with the NEMA Regulations 21 to 24 compiled in terms of **Chapter 3** of the National Environmental Management Act, 1998 (Act 107 of 1998) as amended 2014, for this project which will be registered with the KwaZulu-Natal Economic Development, Tourism and Environmental Affairs. The purpose of this Background Information Document (BID) is to inform interested and/or affected parties (I&AP's) of the Environmental Impact Assessment Process (EIA) that will be conducted for the proposed clearance of indigenous vegetation on Farm A of Wonderdam of Extremity 10023, Dundee, eNdumeni Local Municipality. In addition to supplying information about the proposed Project, this BID will also provide I&AP's with the opportunity to:

> Provide initial comments on the proposed project.

ENVIRONMENTAL AUTHORISATION PROCESS

Environmental Impact Assessment?

An Environmental Impact Assessment (EIA) is a process of collecting, organizing, analyzing, interpreting and communicating information that is relevant for the consideration of a particular application. EIAs are undertaken where the impacts are likely to have significant impacts on the receiving environment. EIA's are used by planning authorities/developers to obtain an independent and objective view of the potential environmental (biophysical and social) impacts that could arise during the construction and operation of the proposed development. The information assimilated needs to provide the Competent Authority with a sound basis for their decision-making. Environmental management and mitigation measures are also identified through the EIA process.

National Environmental Management Act (NEMA)

In terms of the Environmental Regulations promulgated under the National Environmental Management Act, the EIA will be conducted for the proposed development in terms of the new EIA Regulations **Section 21 to 24** for the following activity:

27	The clearance of an area of 12 hectares or more of indigenous vegetation, excluding where such clearance of indigenous vegetation is required for— (i) the undertaking of a linear activity; or (ii) maintenance purposes undertaken in accordance with a maintenance management plan. Competent Authority

The Competent Authority, as described according to the new EIA Regulations, for this proposed project is the KwaZulu-Natal Department of Economic Development Tourism and Environmental Affairs (KZNEDTEA) which will ultimately be responsible for providing

a decision on whether the proposed Activity will be granted Environmental Authorization in terms of NEMA.

PHASE 1

- A draft Basic Assessment Report will be made available for a period of 30 day for review and comment
- A public meeting will be held (where required)

PHASE 3

Decision Making

Registered stakeholders and I&AP's will be informed in writing of the Authority's decision regarding the project.

- There is an appeal period during which I&APs have the opportunity to appeal against the Environmental Authorisation (EA).
- This appeal period commences, within 14 days of the date of the decision on the EA.
- You will receive personal notification, once registered, by e-mail of all documents available for comment, and due dates for comment at every stage.

Your responsibilities as an I&AP:

In terms of the EIA Regulations, your attention is drawn to your responsibilities as and I&AP:

- In order to participate in this BA process, register yourself on the project database.
- Inform any other parties (neighbours, friends, and colleagues) who may be interested and/or affected by the proposed project about the EIA process and encourage them to become involved.
