## The Development

The applicant, uThukela District Municipality proposes to upgrade and extend a water reticulation for the settlements of Bhekuzulu - Epangweni to supply water to reservoirs A1 and A2 supply zones.

The project consists of the laying of approximately 26.2 kilometres of <360mm PVC pipe (diameters will range from 355 - 50mm, peak flow through the system will be below 100l/s) to provide water reticulation to the Bhekezulu – Epangweni communities.

This project compliments the previous one for uThekela District Municipality where the Department (EDTEA) has been asked to approve the construction of a bulk water supply to the area including the associated reservoirs (a basic assessment process undertaken by Terratest).

A plan of the pipeline network overlain on an aerial image is provided in Appendix B.

It is noted that a pipeline crosses the Tugela river to link to the settlement to the west. This will be achieved by strapping the pipeline to the existing road bridge.
