INTRODUCTION

The purpose of the Background Information Document (BID) is to provide information to Interested and Affected Parties (I&APs) regarding the proposed Fuel Station and Convenience Store in Ottawa. Wallace and Green (Pty) Ltd. has been appointed by Indels Cartage CC to provide Independent Environmental Consulting Services for the proposed development.

LOCATION OF PROPOSED DEVELOPMENT

The proposed development will be undertaken on Portion 14 of Erf 110 Ottawa, which is located at 59 Old Main Road, within Ward 102 of the eThekwini Municipality. The project area is located approximately 3km south of the town of Verulam and approximately 1.5km north of Phoenix. The project area is situated within a residential area and is surrounded by residential dwellings and small commercial businesses.




Figure 1: Locality Map illustrating the location of the Proposed Fuel Station

PROJECT DETAIL

Indels Cartage CC intends on establishing a Fuel Station and Convenience Store on Portion 14 of Erf 110 Ottawa which is approximately 4764m² in extent. The site has been rezoned to Limited Commercial which permits the development of a fuel station. The proposed development includes construction of the following:

- Five underground storage tanks (USTs) each with a capacity of 23 000 litres. Three USTs will be utilised for petrol and two will be utilised for diesel. The total capacity of the USTs will be 115 000 litres.
- Three pump islands;
- A canopy;
- Parking areas; and
- A convenience store.

ENVIRONMENTAL AUTHORISATION

The proposed project triggers the following listed activities, thus requiring an Environmental Authorisation from KZN EDTEA (to be confirmed) in terms of the National Environmental Management Act (NEMA).

The Basic assessment process being followed comprises of the following:

- > Submission of an Application for Authorisation to EDTEA;
- Public Participation Process;
 - Notification and distribution of the Background Information Document (this document)
 to identified stakeholders and I&AP's to announce the project and inviting stakeholders
 to register as an I&AP and participate in the public participation process;
 - o An advertisement in the local newspaper;
 - Placement of a site notification at the site notifying I&AP's of the proposed activity and inviting them to register; and;
 - o Relevant I&AP's consultation to address issues and concerns raised;
- > Compilation of a Draft Basic Assessment Report for I&APs to review and comment.
- Submission of a Final Basic Assessment Report and details of I&AP consultation to the EDTEA, for a decision:
- ➤ Communication to I&APs regarding the decision made by EDTEA on the application for Environmental Authorisation.

SPECIALIST EVALUATION

To inform the Basic Assessment Report, specialist studies have to be undertaken. The Ecological Assessment, Geotechnical Assessment and Desktop Heritage Assessment have been undertaken and the key findings have been summarised below. The full specialist reports will be made available for public comment as part of the Draft Basic Assessment Report.

Ecological Assessment:

An Ecological Statement was undertaken by the Biodiversity Company in May 2022. The project area was found to be critically modified from its historical state, and the current habitat may be classified as completely transformed as it does not support any functional plant populations. The project area is therefore not representative of either Critical Biodiversity Area or Ecological Support Area, and as such it has been correctly classified by the provincial conservation plan. The extensive and long-term impacts from dumping, land clearing, and alien plant and weed invasion have degraded the project area to the point that new



development activities will not result in the destruction of any valuable natural resources. As such the project may be favourably considered from a terrestrial biodiversity perspective.

Geotechnical Assessment:

A Geotechnical Investigation was undertaken by Peter Allen and Associates in June 2022. As per the report, it will be possible to excavate the siltstone to depth of 4m approximately below ground level using a payloader or backacter, and there should thus not be any untoward problems associated with the installation of the tanks. It is unlikely that the "true" water table will be reached. There may, however, be some seepage from the sides of the excavation, particularly if the work is carried out in the wet season, and some dewatering may be necessary to facilitate the installation of the tanks. From a Geotechnical point of view, the proposed development is supported, and the location of the product tanks is considered to be satisfactory.

Heritage Impact Assessment:

A Desktop Heritage Assessment was undertaken by Umlando: Archaeological Surveys and Heritage Management in April 2022. As per the Heritage Assessment, the site has no heritage value and should be exempt from further heritage mitigation.
