


Figure 1: indicating the EIA (BA) process to be followed during the application process for the proposed rectifi-cation of unlawful commencement of everland chicken farming .

Purpose of this document

The purpose of this Background Information Document ("BID") is to provide you as a potential interested and/or affected party (I&AP) with an overview of the proposed project.

Need and desirability of the project

The applicant established chicken farming activities by establishing up to 9 chicken broiler houses. The domestic demand for chicken in South Africa was not being met. The location and climatic conditions of the farm is more suited to broiler chicken houses than the current land situation.

Chicken Broiler Development: The Applicant feels that proposed chicken farming activity would be a wise financial decision and that would be reducing risk in the event of a downturn in to leave vacant land or open land. At present the number of farms that are contributing significantly to income generating activities, and the income generating potential of this farm as a contributor to the South African Agricultural sector is not being maximised.
