#### INTRODUCTION TO THE PROPOSED PROJECT

Mr Donald & Mrs Ascentia Mothapo proposes to start a broiler chicken facility with the carrying capacity of 120 000 birds per cycle. Their proposed development is situated in Pretoria North on Farm 79 Erica Street, Bon Accord Agricultural Holdings, Pretoria, Gauteng (Co-ordinates: 25°37'09.7"S 28°13'06.2"E). The proposed broiler facility consists of 3 chicken houses that have a carrying capacity of 40 000 birds per house that will be built on 0.6 hectares within the 2.1 hectare agricultural holdings (Figure 1).

### SUMMARY OF THE BASIC ASSESSMENT PROCESS

In terms of the NEMA EIA Regulations published in GNR 324, 325 and 327 on the 7 April 2017, Government Gazette Number 40772, a BA process is required as the project triggers the following listed activities (detailed in Table 1 below). These listed activities require Environmental Authorisation under the competent authority, the Gauteng Department of Agriculture and Rural Development (GDARD).

#### **IMPACT ASSESSMENT**

The proposed development was screened through the National Department of Environment, Forestry and Fisheries (DEFF) online environmental sensitivity screening tool. According to the screening tool, a number of specialist studies need to be undertaken, with the most important being the following:
