In terms of Section 16(4) (b) of the Mineral and Petroleum Resources Development Act, (Act No 28 of 2002) and It is a requirement of Sections 40 and 41 of Regulation 982 of the NEMA as amended (I&APs that wish to comment on the proposed project may register with the EIA consultants and submit concerns and objections within **30 days** from the date of this notice or submit such comment to the Department of mineral resources.

The application for a prospecting right triggers the following activity listed in GNR 327:

- Activity 20;
- Activity 27 and
- Section 16 of MPRDA

The said prospecting application has no blasting, bulk sampling and IWULA will be conducted on the property stated above.

Therefore, a BA process must be followed in order to obtain an EA from the DMRE for the proposed prospecting activities. The requirements and time frames stipulated in GNR 327 of NEMA will be adhered to during the BA process.

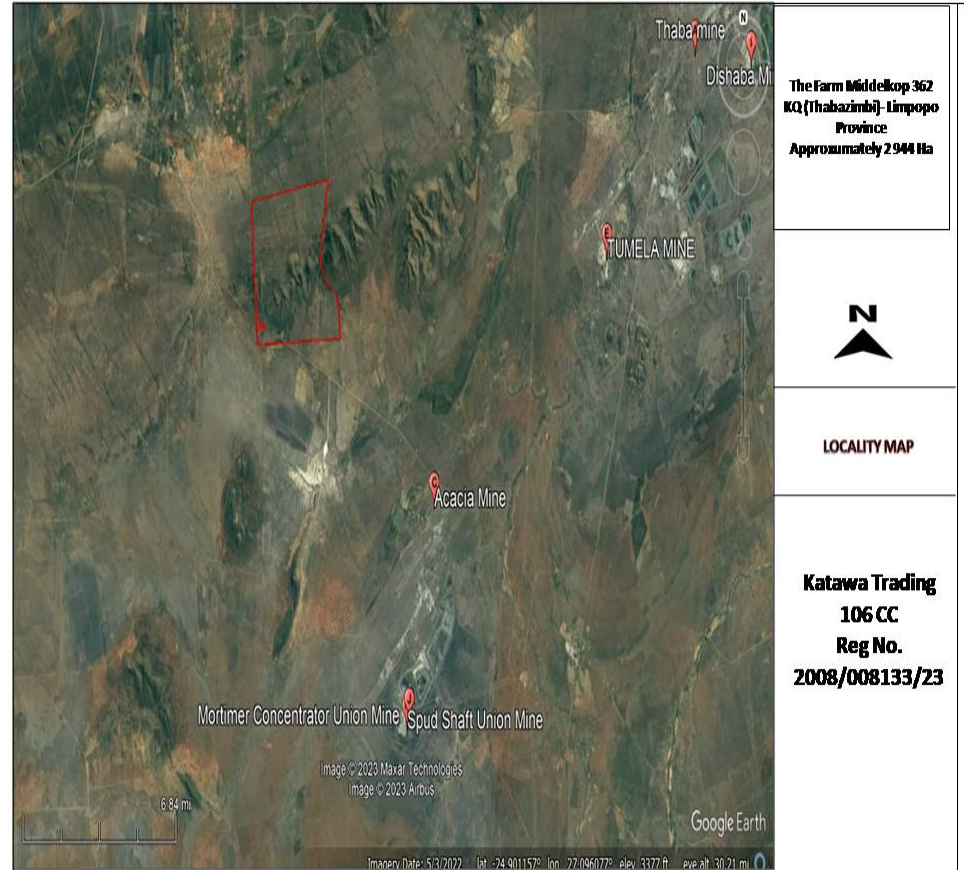
Purpose of this BID

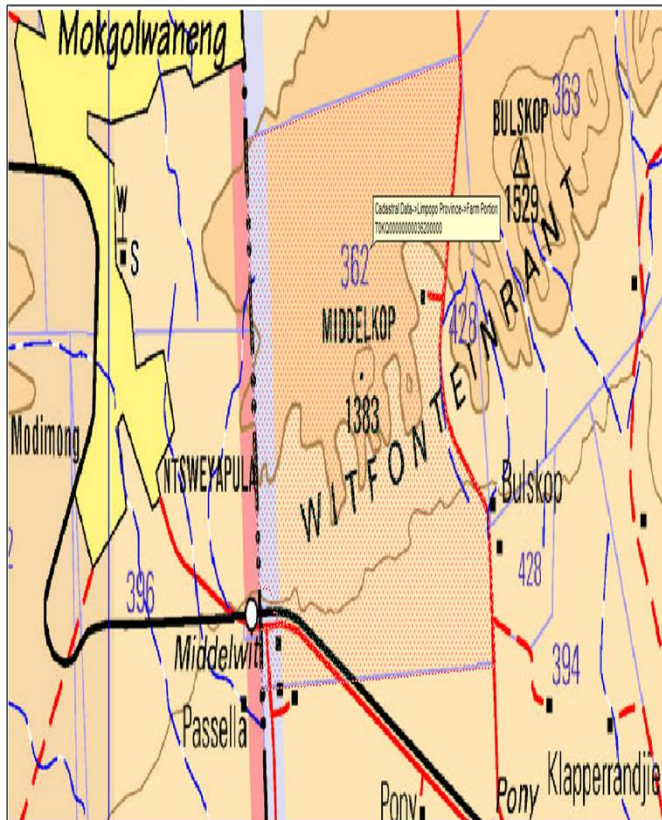

- Inform any other person / organization that they feel should be informed about the project

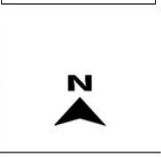
