

1.INTRODUCTION

Singo Consulting (Pty) Ltd has been appointed by Foloyi Construction & Projects CC to undertake an Environmental Impact Study (EIA) in accordance with Environmental Impact Regulations, 2014 published according to Chapter 5 of the National Environmental Management Act 1998, Act No. 107, of 1998 as amended. Foloyi Construction & Projects CC intends to reclaim/rehabilitate friable coal material abounded and/or buried by previous mining company on the 58.1968 Hectares constituting the Remaining Extent of the farms Klipspruit 138 HT, Portion 7 of the farm Annysspruit 141 HT and Portion 1 of the farm Annysspruit 139 HT under Wakkerstroom and Piet Retief Magisterial Districts, Mpumalanga Province.

Notice is hereby given pursuant to the National Environmental Management Act (Act no. 107 of 1998) (as amended) of an Integrated Scoping and Environmental Impact Assessment process to be followed for a Waste Management Licence application to the Department of Forestry, Fisheries and Environment as the licensing authority for all listed hazardous waste activities as per National Environmental Management: Waste Act (Act no. 59 of 2008), and Integrated Water Use Licence application to the Department of Water and Sanitation as per the National Water Act (Act No. 36 of 1998), for the aforementioned development.

2. PROJECT LOCALITY

The area of interest is located in close proximity of the eMatafuleni Community and at about 25.55 km West of eMkhondo (Piet Retief). The site can be located by the following coordinates: -27.071457° S 30.554128° E. The R543 cuts through the site which links the Piet Retief and Dirkiesdorp Town.

3. Project Description

Remediation, reclamation or rehabilitation in this regard, is the process of repairing any negative effects of mining activities on the environment. This can be simply returning the site to a safe and stable condition, restoring premining conditions as closely as possible to support the future sustainability of the site, or improving the landscape with new features. Foloyi Construction & Projects CC has as of 08 August 2022 attained an Environmental Authorisation from the Mpumalanga Department of Agriculture, Rural Development, Land & Environmental Affairs (DARDLEA) with Ref: 1/3/1/16/1G-252 for the processing plant currently operational on certain portion of the site. Coal waste will be recycled and processed as far as practical thereby distributing to the intended market. All other generated waste will be handled appropriately through permitted waste service providers.

4. REGULATORY FRAMEWORK

National Environmental Management: Waste Act, No. 59 of 2008

With the enactment of the National Environmental Management: Waste Act 59 of 2008 ("NEMWA"), all wasterelated activities that were previously listed under the National Environmental Management Act, 1998 (Act 107 of 1998) (NEMA) are now listed within the scope of the NEMWA. The project is listed GN 921, 2013 (amended by GNR 1094, 2017)- List of waste management activities that have, or are likely to have, detrimental effect on the environment; as follows: Category B: (1, 2, 9 & 11). An application for an environmental authorisation and waste license following the Scoping and EIA process as outlined in the EIA Regulations, 2014, will be undertaken by the appointed EAP.

The National Water Act, No. 36 of 1998

The Water Use License Application (WULA) under the provisions of the National Water Act No.36 of 1998 (NWA,1998) as required for the proposed Coal Dump Rehabilitation/ Reclamation Facility will be applied to the Department of Water and Sanitation for the triggering section 21 water uses.

To quantify the impact of the development on the water bodies, the following studies have been identified:

- O Wetland Delineation and Impact Assessment
- Surface water
- An ecological study and;
- A geohydrological study.


