Purpose of this Background Information Letter

This document gives you as an Interested and Affected Party (I&AP) background information about the proposed retail truck stop by Shishini Trading (Pty) Ltd.

Public participation has the intent to obtain valuable input from you as an I&AP to consider all potential impacts that may result from the retail truck stop.

This document explains the Basic Assessment (BA) and Water Use Licence Applications (WULA) processes that will be followed. It also gives information on how you as an I&AP can obtain information, identify matters of concern or interest to you and hence contribute to the project.

The proposed development includes scheduled activities under the 2014 EIA Regulations of the National Environmental Management Act, 1998 (Act 107 of 1998) as amended (NEMA) resulting in the need for Environmental Authorisation (EA) from the Gauteng Department of Agriculture and Rural Development (GDARD). Proposed activities listed in terms of National Water Act, 1998 (Act 37 of 1998) (NWA) will require a Water Use License (WUL) to be administered by the Department of Water and Sanitation (DWS).

Activities applied for under NEMA include GN R No. 327 (Listing Notice No. 1, Activities 14 and 27) requiring Environmental Authorisation by way of a BA process. Activities applied for under the NWA includes activities listed in Section 21 (a) and (b) for the abstraction and storage of water. These activities may be amended after consultation with the Competent Authorities and you as an I&AP kept informed accordingly.

The purpose of the BA process is to ensure that the environmental impacts that may be associated with the proposed project are identified, and that appropriate mitigation as appropriate are introduced. I&APs will be given an opportunity to provide comments, raise issues of concern and/or suggestions for enhanced benefits and/or alternatives and to ensure that the GDARD has sufficient information for decision making.
