Vakhusi Business Enterprise (cc) intends to obtain an Environmental Authorisation before commencements with the proposed development of Mhahlandela Lodge.


Great Warthog Geo-Environmental has been contracted to undertake the Environmental Impact Assessment process required to fulfil requirements of Environmental Authorisation in terms of the National Environmental Management Act (NEMA) (Act no 107 of 1998).

EIA Triggered Listed Activities:

Activity	Description
GNR 327 Listing Notice 1; Activity No.27	The proposed development will involve the clearance of vegetation of more than 1 hectare, the area is currently covered by indigenous vegetation.
GNR 324 Listing Notice 3; Activity No.5	The proposed development will entail accommodation facities for more than 15 beds and the site is located with CBA in terms of Limpopo Biodiversity Sector Plan.

BASIC ASSESSMENT PROCESS

In terms of the National Environmental Management Act, 1998 (No. 107 of 1998) [NEMA] and associated EIA Regulations, an Environmental Authorisation must be obtained from the relevant decision-making authority (LEDET), prior to the commencement of any development that may trigger a potential listed activity in terms of the Listing Notices, 2014 (as amended). A Basic Assessment is a process of collecting information and analysing results in terms of the proposed activity against the regulated Listing Notices. Basic Assessments Reports [BARs] are undertaken for project activities that are included under Listing Notices 1 (GNR 327) and Listing Notice 3 (GNR 324). Usually these activities are considered to impose less significant environmental impacts. A BAR will be conducted for the proposed development in terms of the 2014 EIA regulations (as amended). The Basic Assessment Process will follow procedures as described in Regulations 19 to 20 of NEMA EIA Regulations

All comments should be submitted together with their name, contact details (preferred method of communication e.g. e-mail) and an indication of any direct business, financial, personal or other interest that they may have in the application to the contact person indicated below. Registered IAPs will be informed of further opportunities to comment on the Basic Assessment Reports.

PUBLIC PARTICIPATION PROCESS

The purpose of the public participation process is to inform Interested and Affected Parties (IAPs) regarding the proposed development as well as the EIA process. IAPs will also be provided with the opportunity to comment on and contribute to the identification of environmental impacts of the proposed development. Registered IAPs will be granted an opportunity to review and comment on the Draft Basic Assessment Report. Copies of the report will be made available on request for a review period.
