


Aangeheg die nodige inligting soos versoek met stawende dokumente. Die Museum was in die lewe geroep met die uitsluitlike doel om voertuie en toerusting wat betrekking het op die motorbedryf te bewaar vir die nageslag.

Wat uniek is aan St. Croix Motor Museum is die feit dat ek dit opereer sonder finansiële bystand van geen aard vir 25 jaar lank. Soortgelyke instansies soos die Heidelberg Transport Museum (Gauteng), die Midmar Transport Museum (Natal) en die Inggs Versameling (Grahamstad) moes almal hul deure sluit as gevolg van verkeerde besluite.

Soos u bewus is, was Port Elizabeth in die verlede bekend as die "Detroit" van Suid Afrika, omdat die twee grootste Motorvervaardigers, Ford en General Motors hier gevestig was. Ter inligting, die eerste 1926 Chevrolet wat hier in Port Elizabeth gebou was staan tesame met die een miljoenste V6 Fordenjin, ook in my Museum. Verder was daar die RSA Presidensiële voertuig 'n 1964 Cadillac Limousine tesame met Meneer Ian Smith van die eertydse Rhodesië se ampmotor, 'n 1965 Rambler "440 Classic" hier gehuisves.

Besoek in tale beloop gemiddeld tussen 70-80 persone oor naweke. Skoolbesprekings word gereeld gedoen, meestal deur skole uit die vorige Ciskei en Transkei, tot en met 80 skoliere per slag. Ek het 'n huurkontrak aanvanklik gesluit met die Departement Openbare Werke ± 25 jaar gelede. Gedurende hierdie termyn het ek dit 2 keer hernu. Die laaste termyn het aanvang geneem in Maart 2003 tot en met Maart 2013. Met ondertekening hiervan in 2003 het ek dit duidelik gestel en versoek om die termyn wel te verleng na 2013 (Sien korrespondensie angeheg)

Gedurende Maart 2012, 12 maande voor verstryking van die huidige kontrak het ek weereens my begeerte om voort te gaan met die huur van die perseel uitgespreek. Na ± 4 maande het ek nog geen reaksie van D.O.W gehad nie maar het toe reeds by verskeie persone buite die Department gehoor dat ek "uitgegooi" gaan word uit die Museum. Hierna het ek aangedring op 'n antwoord wat ek toe weldra ontvang het.

Ter inligting, ek deel die betrokke perseel wat bekend staan as ERF150 Westview, met SA inkomstediens (Doeane) 'n Maatskappy wat sekerheids instillasies doen vir die Regering asook die SAP.

± 2 jaar gelede het die SAP dit goed gedink om die perseel te laat afkamp en het die hoofgang versper met 'n staalhek. Die aksie het toegang tot die Museum heeltemaal belemmer. By versoek om die plek nie toe te maak soos 'n tronk nie het die bevelvoerder ene Kolonel Botha my aangesê om 'n ander ingang vir MY te maak vanaf die agterkant van die Museum. Hy het al verskeie kere konfrontasie probeer skep wat ek eenvoudig net vermy het.

By geleentheid het hy my ook verbied om op sekere dae die Museum oop te maak. Huidig berg die SAP 'n magdom skrap voertuie op die perseel wat gereeld stukkend gedruk word en saamgepers word vir herverkoop aan RECLAM, die staalskroot handelaar. Soos u kan aflei van D.O.W se skrywe het hulle n' "Klient" wat die Museum perseel benodig – duidelik die SAP wat hier in die middel van 'n woonbuurt 'n skrootwerf tussen 2 skole kom plaas het!!!!

Ek sluit hierby 'n sketsplan van die algehele perseel in vir u kennisse.

Voorlaaste wil ek net noem dat die Museum al in die verlede vir opleidingsdoeleindes met Miganiese Ingeneurs Studente aangewend was om hul praktiese jaar te finaliseer voor Gradeplegtigheid. Vir hierdie doel het ek 'n praktiserende Siviele Ingineur, byname Mn. Keith Blignault aangestel om alle werkstukke af te teken na voltooiing van die praktiese jaar..

Tenlaaste wil ek net ook vir u mededeel dat ek met ongeveer 4 duisend kg onderdele plus bykans 3000 naslaanboeke ook huisves in die Museum. Ek twyfel sterk of hierdie mense by D.O.W 'n benul het wat hulle aan Suid Afrika, Port Elizabeth en sy mense gaan doen, want nog nie een van hulle het nog ooit besoek afgelê by die Museum om die omvang daarvan te verstaan



Dear Madam,

Our telephonic conversation of today refers.

Having occupied your premises known as "The aircraft hanger – Westview" for the past 24 years a well laid out Motor Museum was established to the benefit of the general public of our country.

The building in question was allocated to me on the condition that ALL maintenance will be for my own account. Since inception I have replaced the entire roof at a cost of ± R58 000.00 as well as the south facing façade of the building at a further cost of R18 500.00. The external front façade was also repainted during December 2011. All safety equipment and installations are kept on National Standards as the Museum is Registered with the South African Museum Association (SAMA).

90% of my visitors are from the rural areas in the erstwhile Transkei of which I have full record. Busloads of kids are being transported to this venue where I personally entertain them on a tour and in formation talk on the history of the Automotive Industry for ± 2 hours.

Port Elizabeth was known as the "Detroit of South Africa" having had 2 major car manufactures, Chevrolet and Ford since the early 1920's. Both these company's are still operational in South Africa, but only G.M. (General Motors) the Chevrolet manufacturer, remained in Port Elizabeth. I have one of the first Chevrolet cars that were fully built in 1926 on display in the Museum.


Having my lease expiring in March 2013, I respectfully request an extension for a further 10 years as this Museum features across the world and is a great component of our City Tourism.
