# Introduction

Beeshoek Iron Ore Mine (hereafter referred to as Beeshoek) will be submitting an application to consolidate the existing Environmental Management Programmes and Plans (EMPs) in terms of Regulation 982

A meeting was held at the Department of Mineral and Resources (DMR) offices on 22 September 2016 to discuss the opportunity to combine the EMPs. Subsequent to this, the applicant submitted a motivation document on 23 September 2016 to the DMR officially requesting this process. Response was received from the DMR on 14 November 2016 concurring the process and specifically requesting that the applicant must make sure that all the previous Record of Decisions and Conditions form part of the consolidation.

The applicant is now required to prepare a Section 102 application and an Environmental Management Plan (EMP) to the DMR for consideration.

### **Project Location**

The project is located within the Magisterial District of Hay under the jurisdiction of the Tsantsabane Local Municipality, located within the ZF Mgcawu District Municipality (formally Siyanda District Municipality) of the Northern Cape Province. The mine is located approximately 10km west of the town of Postmasburg. The farms over which the mining right is held are: Beeshoek 448RD, Ptn 0, 1 and Olynfontein 47 RD, Ptn 4. All owned by the applicant.

### **Project Description**

The mine is operating with all required environmental authorisations in terms of the:

# **Project Description (continue)**

The mine would like to utilise this opportunity to:

- Combine all conditions in the approved EMPs and Record of Decisions (Environmental Authorisations) into one holistic EMP;
- Tompile an EMP which presents a detailed action plan for all type of activities (approved) on site, i.e. Mine Residue Stockpiles, Slimes Dam, Infrastructure, Opencast Pts, and Roads.
- Clearly define all approved activities and indicate these clearly by presenting coordinates and locality maps;
- Include the Regulations 6 & 11 Reports of GN R.1147. The newly promulgated regulations (November 2015) pertaining to the Financial Provision for Prospecting, Exploration, Mining and Production Operations in terms of the NEMA prescribes the determination and making of Financial Provision for existing rights/permit holders (Regulation 11 of GNR.1147). Importantly, the provisions in Section 24P of NEMA has been given effect through these newly promulgated regulations.
- Incorporate all commitments and requirements as presented in the approved Water Uses Licence and also the Integrated Water and Waste Management Plan; and
- Include the monitoring schedule as required in the Water Use Licence.

# **Required Authorisations**

### National Environmental Management Act, 1998

Regulation 54 (2) of the National Environmental Management Act, 1998 (Act No. 107 of 1998) (as amended) provides that "An application submitted after the commencement of these Regulations for an amendment of an Environmental Management Programme, issued in terms of the Mineral and Petroleum Resources Development Act, 2002 (Act No. 28 of 2002) (MPRDA), must be dealt with in terms of Part 1 or Part 2 of Chapter 5 of these Regulations".

Chapter 5 presents two avenues for amendment:

Part 1, Regulation 29: "An environmental authorisation may be amended by following the process prescribed in this Part if the amendment;

- a) Will not change the scope of a valid environmental authorisation nor increase the level or nature of the impact, which impact was initially assessed and considered when the application was made for an environmental authorisation; or
- b) Relates to the change of ownership or transfer of rights and obligations".

Part 2, Regulation 31 is applicable for the amendments where a change in scope occurs.

The mine has a number of Environmental Authorisations in place and would like to consolidate the associated Environmental Management Plans in terms of Part 1 to allow for one document which would result in an effective management programme on site.

# Mineral and Petroleum Resources Development Act, 2002:

Section 102 of the MPRDA provides the opportunity for a holder of a mining right to amend its EMP, subject to a formal application.




Figure 1: Local Setting of Beeshoek Iron Ore Mine

# **Environmental Authorisation Process and Required Reporting**

# The following process will be followed:

- 1) Part 1: Motivation to the DMR:
  - a. Submitted during October 2016
  - b. Submission of Section 102 Application will be submitted with the EMP
- 2) Part 2: Approval by the DMR to proceed:
  - a. Approval in writing from the DMR will be required to proceed and was received in November 2016.
- 3) Part 3: Public Participation to inform the registered stakeholders of the project. This involves:
  - a. Site Notices;
  - b. One Advertisement;
  - c. Information letters to stakeholders; and
  - d. Opportunity the review the documents.
- 4) Part 4: Document Compilation
  - a. Detailed assessment of each of the EMPs and associated RODs;
  - b. Summary table of all approved activities will be compiled, indicating the applicable legislation and approval (see the example in Annexure 3);
  - c. Compilation of Consolidated EMP in terms of the NEMA Regulations:
    - i. Detailed description of the mining plan;
    - ii. Detailed description of activities approved;
    - iii. Detailed description of impacts previously identified;
    - iv. Detailed description of all management measures;
    - v. Detailed monitoring programme;
    - vi. Closure and Rehabilitation Plan (annual and final closure).
    - vii. Submission to the DMR for approval.

# **Public Participation Process or Stakeholder Consultation**

# **Purpose of Stakeholder Consultation**

The purpose of the stakeholder consultation process is to:

- Engage with stakeholders as part of a process to identify the potential social and environmental impacts which may result from the planned activities.
- Develop an understanding of the views, concerns and expectations of stakeholders.
- Engage with stakeholders to determine the closure objectives as input into the development of a rehabilitation plan.

### **Stakeholder Consultation Process**

The key objective of public participation during an Environmental Authorisation process is to assist stakeholders to identify issues of concern and suggestions for enhanced benefits, and to comment on the findings of the EIA. The Public Participation Process is an integral part of the EIA process, and continues throughout the EIA process, for this purpose the process is presented in a systematic approach:

- Step 1: Identify of Stakeholders and/or I&APs. Key stakeholders have been identified including:
  - Landowners and/or occupiers of affected land portions.
  - Landowners and/or occupiers located on land portions directly adjacent to the farms where activities will take place.
  - Government bodies / organs of state that have jurisdiction over the area where activities will take place.
  - Ward Councillors are consulted to ensure that host communities in proximity to the site are afforded the opportunity to participate.
  - The Department of Rural Development and Land Reform are contacted to confirm land claims and if applicable, land claimants will be registered as stakeholders.
  - Associations and non-governmental organisations that might have an interest in the area.
- Step 2: Notification of Stakeholder and or I&APs of the proposed project, via adverts, notices, BIDs to request these parties to register (please see the section on "Be an Integral Part of the Environmental Assessment Process").
- Step 3: All stakeholders are afforded the opportunity to share their views, raise concerns and clarify their expectations as it relates to the planned activities. Comments and concerns can be submitted in writing via email or fax to the details provided in this document. A written record of the stakeholder engagement process, the stakeholder comments and concerns will be compiled into a Report on Results of Consultation, and will be submitted to the DMR for consideration. All registered stakeholders will be provided with written feedback to address any questions and concerns.
- Step 4: I&APs are provided with the opportunity to review documents and comments on these. I&APs will be provided with 30 days to comment on the draft reports.
- Step 5: All registered stakeholders will be informed of the department's decision regarding whether an application was granted or not.

### Be an Integral Part of the Environmental Impact Assessment Process

Public involvement is an essential part of any environmental assessment process. All comments will be recorded and presented to the project team and regulatory authorities. You will receive feedback on how your comments have been taken into account and the outcome of the assessment. You will further receive updates on the status of the project.

### How to Register and get involved?

Parties wishing to register as Interested and Affected Parties ("I&APs"), who wish to participate by contributing comments, or require additional information, should please register or submit their correspondence in writing to reach EnviroGistics no later than **thirty (30) days** after the issue of this notice (**27 January 2017**). Please refer to the Registration Form attached. The draft EMP will be submitted to the DMR and registered Stakeholders during March 2016. All relevant comments received by **27 February 2017** will be incorporated into a final Report, which will be made available to all registered I&APs for review and comment.
