(PAINTED RED AND WHITE)

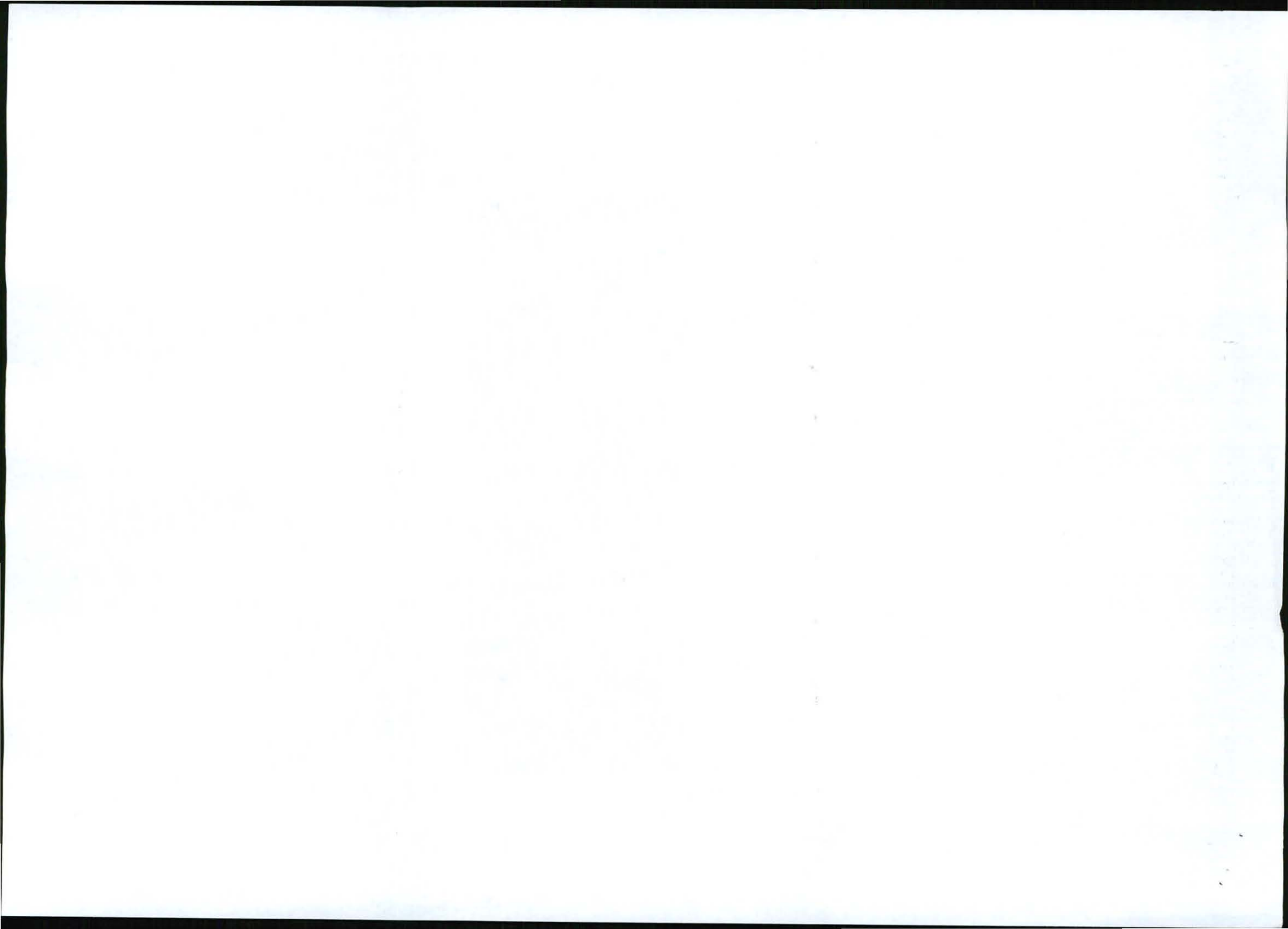

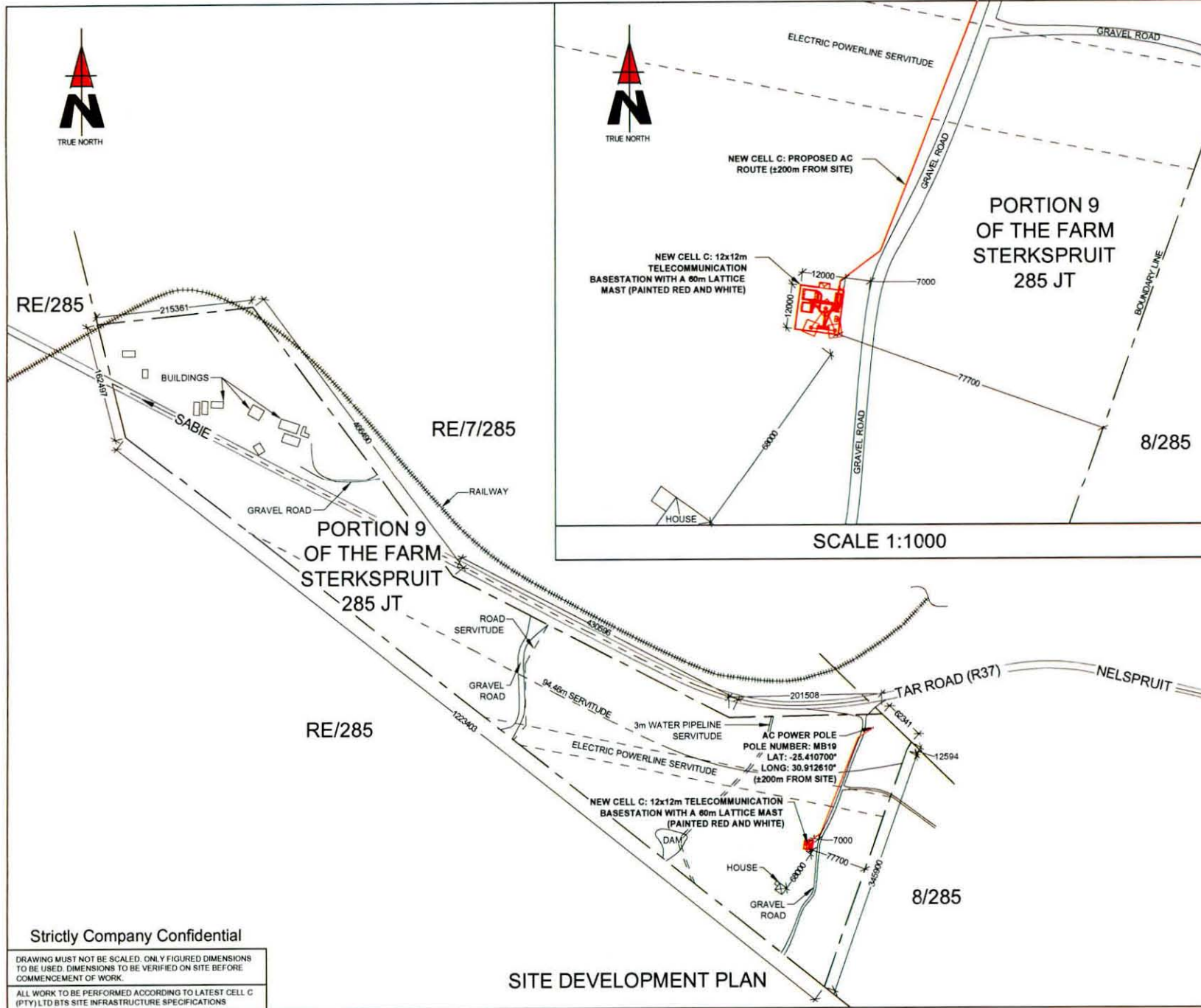
