## Letter

**In terms of Section of the National Heritage Resources Act (Act 25 of 1999)**

**Attention: Wesizwe Platinum Limited**

**Wesizwe Platinum Limited is the owner of Bakubung Platinum Mine. The Bakubung Platinum Mine received Environmental Authorisation in 2009. Wesizwe would now like to make several changes to the approved mine which require additional Environmental Authorisations, a Waste Management Licence and an additional Water Use Licence.**

Thank you for the background information document for the proposed development. In terms of the National Heritage Resources Act, no 25 of 1999, heritage resources, including archaeological or palaeontological sites over 100 years old, graves older than 60 years, structures older than 60 years are protected. They may not be disturbed without a permit from the relevant heritage resources authority. This means that prior to development it is incumbent on the developer to ensure that a Heritage Impact Assessment is done. This must include the archaeological component (Phase 1) and any other applicable heritage components. Appropriate (Phase 2) mitigation, which involves recording, sampling and dating sites that are to be destroyed, must be done as required.

A Palaeontological Assessment is not necessary for the proposed footprint area as it lies within an area of insignificant palaeontological sensitivity according to the PalaeoSensitivity Map on SAHRIS (<http://sahra.org.za/map/palaeo>).

The quickest process to follow for the archaeological component is to contract an accredited specialist (see the web site of the Association of Southern African Professional Archaeologists [www.asapa.org.za](http://www.asapa.org.za)) to provide a Phase 1 Archaeological Impact Assessment Report. This must be done before any large development takes place.

The Phase 1 Impact Assessment Report will identify the archaeological sites and assess their significance. It should also make recommendations (as indicated in section 38) about the process to be followed. For example, there may need to be a mitigation phase (Phase 2) where the specialist will collect or excavate material and date the site. At the end of the process the heritage authority may give permission for destruction of the sites.

If the property is very small or disturbed and there is no significant site the heritage specialist may choose to send a letter to the heritage authority to indicate that there is no necessity for any further assessment.

Any other heritage resources that may be impacted such as built structures over 60 years old, sites of cultural significance associated with oral histories, burial grounds and graves, graves of victims of conflict, and cultural
