

Notice of Environmental Authorisation Process

BASIC ASSESSMENTS (BA) FOR THE PROPOSED UPGRADE AND CONSTRUCTION OF COASTAL INFRASTRUCTURE WITHIN THE KING SABATA DALINDYEBO LOCAL MUNICIPALITY (KSDLM), EASTERN CAPE: COFFEE BAY AND HOLE IN THE WALL

In terms of the amended EIA Regulations (April 2017) published under the National Environmental Management Act, 1998 (Act No. 107 of 1998) (NEMA), as amended, notice is hereby given of the Department of Environment, Forestry and Fisheries' (DEFF) intention to upgrade and construct tourist facilities within the KSDLM, Eastern Cape: Coffee Bay and Hole in the Wall.

Environmental Authorisation

In terms of the amended EIA Regulations (April 2017) published under the National Environmental Management Act, 1998 (Act No. 107 of 1998), as amended, the proposed upgrade and construction of tourist facilities at Coffee Bay and Hole in the Wall trigger several listed activities that require environmental authorisation via the undertaking of a Basic Assessment (BA).

The Eastern Cape Department of Economic Development, Environmental Affairs and Tourism (DEDEAT) is the competent authority for the issuing of environmental authorisation for these proposed developments. DEFF will be consulted as a commenting authority.

Should a Water Use License be required, an application will be submitted to the Department of Human Settlements, Water and Sanitation (DHSWS) in terms of Chapter 4 of the National Water Act, 1998 (Act No 36 of 1998), particularly, Section 40(4). It is anticipated that this process will be completed by September 2021.
