Coal African Mining (Pty) Ltd has appointed EnviroStep (Pty) Ltd as an Independent Environmental Assessment Practitioners (EAP) for the proposed project to conduct an Environmental Impact Assessment Process in terms of the National Environmental Management Act (NEMA). - (B) The development and related operation of facilities or infrastructure, for the storage, or for the storage and handling, of a dangerous good, where such storage occurs in containers with a combined capacity of 80 cubic meters or more but not exceeding 500 cubic meters. (GNR 327 Activities 14; GNR 324, Activity 10);



The clearance of an area of 300 square metres or more of indigenous vegetation except where such clearance of indigenous vegetation is required for maintenance purposes undertaken in accordance with a maintenance management plan. (GNR 324, Activity 12).
